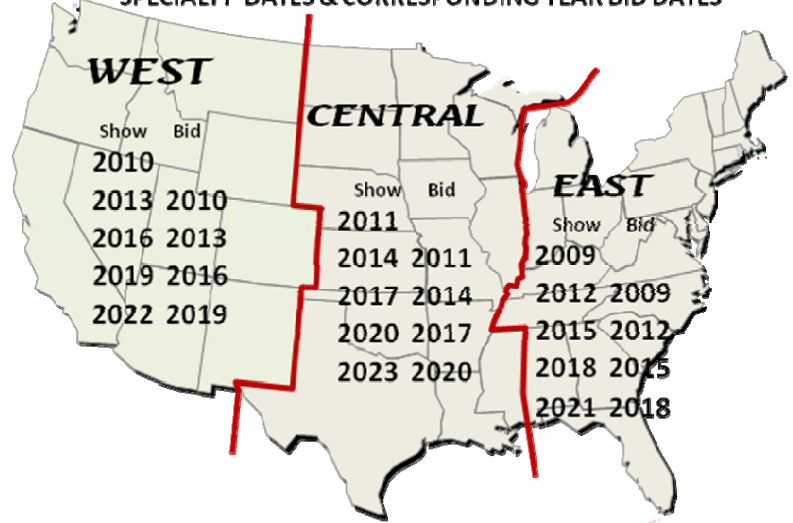

SUBMITTING EXPENSES TO THE BCOA TREASURER

Please note per BCOA Ballot 2004 – 48, published in January 2005 Bulletin Board:

“BCOA members incurring expenses covering BCOA budgeted items during the fiscal year shall submit invoices to the Treasurer on or before March 1st of the next year to be eligible for reimbursement. Expenditures incurred by members that are not covered by the Budget shall require Board approval. These bills shall be submitted to the Treasurer on or before February 1st of the next year. Committee Chairs shall be responsible for notifying committee members to submit receipts for expenses within this time frame.”

EFFECTIVE IMMEDIATELY

Wanda Pooley (IL) has resigned her positions as a member of the BCOA Board and as Chair of the National Specialty Oversight Committee effective April 3, 2009. NATIONAL SPECIALTY DEADLINES

As you know many national specialties are in the works at the same time. Past, present, and a couple of future all being juggled, some going up and some coming down. Here are just a few of the coming up membership deadline dates for some of the specialties for the current year of 2009.

Specialty Date:

2009: After specialty: 15 days, All bills submitted to Specialty Treasurer.

60 days final financial report from National treasurer to BCOA treasurer.

2010: Before specialty: Sept 15, Obedience, Lure Coursing, African stock Exhibition, Agility, and Junior Showmanship judges selected and approval requested.

Nov 15, judges under contract

2012: Before specialty: May 15, Deadline for host site proposals. *This is normally April 1, but has been extended this year.*

April 15, normal deadline for judges nominations. *This also has been extended due to development of a new procedure.*

June 15, Site/Judge tallier mails host proposal/judge ballots to members.

July 15, Close of host proposal/judge member voting

August 5, tie breaking ballots for host site/ judges mailed if needed.

August 20, Close of any necessary judges' runoff voting

July 1 through Nov 30	Annual meeting in conjunction with National specialty. Membership to be notified no later than 30 days prior to date
By July 8	Committee submits accept slate with 250 word resume to Secretary
By July 15	The list, including the full name and state of residence of each candidate published in Bulletin Board
By Aug 15	Additional nominations from the floor must be postmarked by
By Aug 21	Last day Secretary can received August 15 postmarked nominations
By Sept 1	Outside firm to inspect and count ballots
On or before Sept 15	Ballots mailed to membership
By October 15	Ballots must be post marked to be valid
By October 21	Ballots must be received by inspectors
By October 30	Elections certified
By November 20	Election results published in the Bulletin Board

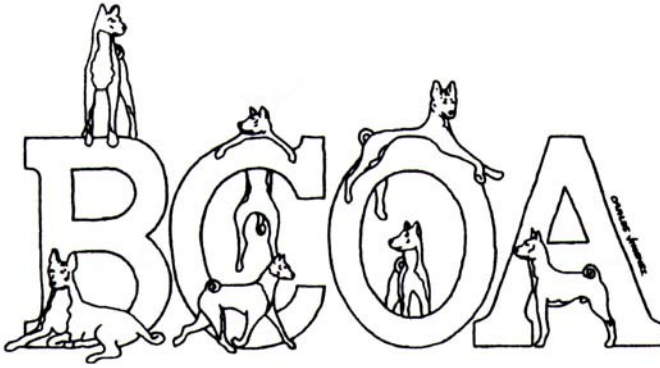
