## Online Entry

This is a two part procedure. You must complete & submit the LGRA Entry form then pay your entry fees.

### **Send the Entry Form to the Trial Secretary**

- 1- Complete the form online. The form has fill in fields. We suggest you select the option "Highlight Fields" in Acrobat (upper right corner of screen) to see the fill in areas.
- 2- When you have completed the entry form, select the SEND button.
- 3- EMAIL the form to **[jcook@gvprx.com](mailto:jcook@gvprx.com)**
- 4- SAVE the form to your files. That way if the form does NOT send properly, you CAN send the completed form as an attachment to **[jcook@gvprx.com](mailto:jcook@gvprx.com)**

- 2- Go to the PAYPAL ENTRYPAYMENTS Page
- 3- Complete the information required for entry payment
- 4- Pay for your entries using the PayPal Shopping Cart
