Eligible breeds & registry: Only purebred basenjis that are one year of age or older and have been registered with the American Kennel Club or an AKC-recognized foreign registry or that have been granted an indefinite listing privilege (PAL/ILP) may be entered.

Ribbons: green qualifying rosettes will be awarded to qualifying hounds for Junior Courser test.

JUNIOR COURSER: open to all hounds of an eligible breed. During a national specialty a hound running alone shall receive a certification from a judge after completing the first test and a second certification from a different judge upon completion of the second test stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

Substitutions for lame or in-season hounds allowed if substitute has same owner and Trial Secretary is notified at least 48 hours prior to roll call. Refund allowed for bitches in season prior to roll call if no substitution of hound.

RULES:

- Each entry will be examined at inspection for breed disqualifications.
- Spayed and neutered hounds, without breed disqualifications may be entered.
- Monorchid and cryptorchid hounds are ineligible to participate
- Battery powered, continuous loop lure machines will be used.

- The lure will consist of plastic bag strips.
- Backup equipment will be available.
- The members of the Basenji Club of America field committee reserve the right to alter the course plan as required by weather and/or field conditions on the day of the test/trial.
- A penalty of \$10.00 may be assessed for each loose hound not currently running a course during event hours.
- A fine of \$10.00 per occurrence may be assessed for failure to clean up after your dogs while on grounds.

Please note, the state of Colorado require all dogs have valid rabies vaccinations performed by licensed Veterinarians. You may be requested to show written proof of vaccination.

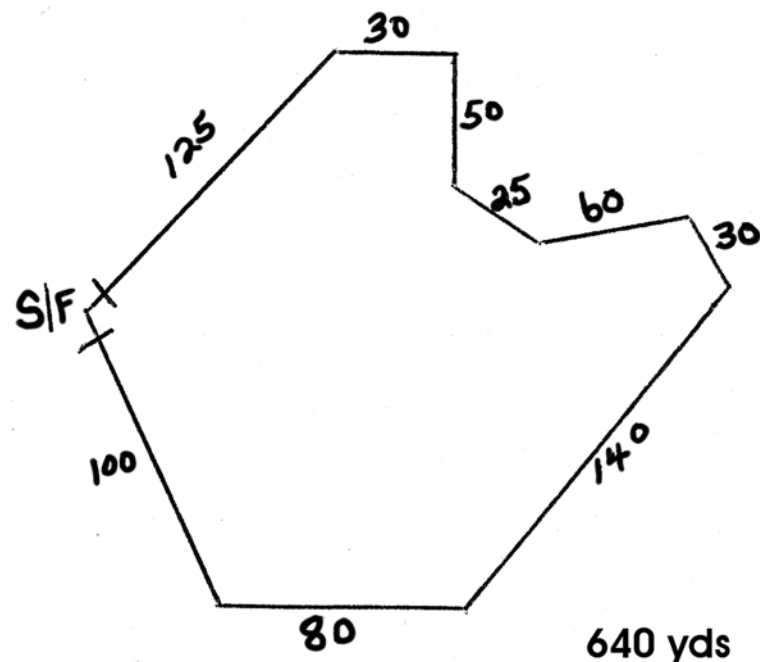
PRIZES FOR QUALIFYING BASENJIS: Green Rosette and Porcelain Pottery Bunny Pin.
