Surely I've been called naive (and worse) for these thoughts and impressions; and I've altered some of these. My main problem at this time is understanding club members and exhibitors. To me it would seem one joins a club to enjoy the members and the camaraderie of like interests. And a person exhibits his dog for the fun and ego of saying "Here's what I bred or own and let's see what a presumed expert thinks about him." Very few people are doing this to make money. I would imagine that you do very well to break even. If one can assume these are simplified truths - then WHY so much bitching and back-biting? Do exhibitors/breeders/handlers not want newcomers in their ranks so intensely that they exhibit their poor sportsmanship so obviously to all around the ring. So what's fun and challenging about having an exhibitor deliberately run his dog up on yours or deliberately throw/scatter bait in the ring, - etc.

On the subject of clubsmanship - there is something everyone can do, however small. And I feel that if a person has to gripe about a thing being left undone or not done to his satisfaction, he should at least have a solution available and be willing to assist in the implementing of the solution.

"Dear Ms. Bridges:

Personally, I have no problems with the Bulletin's covers the way they appeared in the January-February-Merch 1985 issue. I fail to understand why you feel the need that there must be a picture on both at any "cost"

However, I must say that I was terribly disappointed with your comments regarding the so-called cover

story of the Bulletin's last issue. The comments were not only tasteless but also inconsiderate.

In the six years that I have been showing Basenjis, I have advertised exactly twice. Once in July 1982 and once in March 1984 only because (1) There was extra money left over after the bills were paid and (2) I felt I had something worth advertising. My Basenjis at this time are a hobby. They are not an income-Any money that goes into the dogs goes in after the household bills are paid except producing business. of course the food bills and veterinary bills.

Contrary to what you seem to believe about other Basenji owners, my husband and I do not make a ton of money. My husband is the pastor of a small country church. I work for a one men CPA office. During the past tax season, I have averaged anywhere from 20 to 30 hours of overtime a week. I am on a salary. I do not get paid for my overtime.

While I realize that your comments were not a personal attack but of a general nature, there are many of us in this same situation. I am not one of those 450 that are being "subsidized" by anybody as your comments indicated. I have what I have because of careful planning and budgeting. I refuse to play the "political games" of the club by trying to outdo the next person in advertising dollars or otherwise. If I feel that I have something worth advertising, and I have the extra money, I will advertise.

I think it is time that you and many others in this club took a good, long look. There is a big difference between CAN'T and WON'T. You simply cannot group everyone into the latter category as you

seem to think.

- I do feel it should be possible for anyone who can manage an entry fee to come up with \$6.25 once a year for a Breeders' Directory listing just in support of the club and by way of saying "HI" to the membership. We also publish letters from members and articles they care to contribute free of charge. It's a shame that the first thing you felt compelled to contribute was an attack on a fellow member laboring on your behalf.
- P.S. Your address change has been noted I spent an entire Saturday entering corrections and updating our mailing list on my friend's computer (the use of which he donates free of charge); then 6 hours Sunday printing labels for the roster mailing and the 1985 National Specialty mailings - a total of 6 sets. My time is donated - I am NOT on a salary, nor do I receive any "overtime" for the many hours of work which go into production of the Bulletin.

However, if having all those things means losing perspective of other people, forget it!

You obviously also missed the point when I mentioned my salary. I am glad that you can donate your time. It must be nice. But I was not referring to volunteer services, doggie or otherwise. I was referring to how I make a living. Your letter leads me to believe that you do not have to work. What a life! I salute you if that is true and however did you manage it. Nobody that I know draws a salary for voluntary

or donated services. If they did, it wouldn't be voluntary, now would it?

Let me clear up snother point. Any time you receive money from the sale of puppies or from a stud's services, they are "income-producing". Now choose the word - business or hobby - it makes no difference to me. The point is that you must reslize that the sctivity produces an income, whether you like it or not. Let me give you a tip. Should you ever be sudited by the IRS, you better have sirtight proof that you are operating a hobby. On the other hand, if you pass losses & income from your kennel through your tax return, you are loosely viewed as a business.

It was rether stupid on my part, but I did misjudge you. I assumed that because of your position with

the Bulletin that you were mature enough to handle all facets of responsibility that go with the job. I

was wrong. I apologize.

The next time I send a letter to the editor, you can bet I'll be sure that editor has the intellectual maturity to handle it.

Quite the contrary, I referred to your letter as a "contribution" and it, together with my reply, your current letter and this reply from me are, in fact, being published in the next issue of the Bulletin Board Newsletter. I have always published all letters received, and try to respond personally as well. I appreciate any member's taking the time to share input, pro or con, which was why I tried to address your concerns directly. I was wrong to call your contribution "an attack on a fellow member". I can only plead extremely hurt feelings at being so badly misunderstood and so harshly taken to task.

Neither did I say that I had received no other letters regarding my comments. It is simply that all the other response, whether personal, by phone or in letter form, was positive and supportive of my efforts, and shared in my concern for the Bulletin's future.

I do not have a great many dogs, just a few whom I love dearly, as I am sure you love your own. have co-owned cuite a few during my eleven years of breeding and placing puppies in show homes, but the co-ownerships are limited, time-wise, and the dogs reside with their owners. Nor do I have a kennel (other than in my dresms), just a backyard like most of those I know in dogs. A kennel name is free you just make it up and use it, and my "kennel stationery" is a 9 year old rubber stamp with the logo which I designed and drew myself. I do understand careful planning and budgeting; that's how I accomplished and maintain what I have.

In pointing out that my labor is donated, I meant only that I was thus not being paid to quietly accept abuse from those to whose benefit I labor. I cannot nor should I be asked to apologize for my

lifestyle or the fact that I have the free time to donate to the Bulletin.

I am truly sorry to have angered you so greatly. It was in no way my intent. I will make no further attempt to seek your understanding of my position. Emotionally, I am not equipped to handle another such reply from you.

Again, my most profound apologies for what seems to be an insurmountable lack of understanding

between us.
