BASENJI CLUB OF AMERICA AMERICAN KENNEL CLUB DELEGATE'S REPORT

The quarterly meeting was called to order at 2 pm on Sept. 9, 1986 in New York City by William Stifel. New delegates were introduced and instructed to gather later for a picture for the AKC Gazette. A vote was taken on D. Jay Hyman to represent the Rhodesian Ridgeback Club of the United States, Inc.; he was approved. Mr. Louis Auslander, chairman of the AKC Judging Research and Development Committee, spoke of Judges Occupational Eligibility; a complete text of his comments will appear in the Gazette, however, anyone that is a judge may not profit in any manner from the sport of dogs, nor may he or she live in the same household with a person who does.

It was voted to charge a fifty-cent recording fee for dogs entered in field trials. The Board of Directors proposed a change in the time required for a club to submit a judging panel. Currently a panel must be submitted twelve weeks prior to a show - the new proposal would increase the time to twenty weeks. This would permit the printing of judging panels in the AKC Gazette. This change will be voted on at the December meeting. A committee has been established to retain a successor for William Stifel, who will retire in June, 1987. The Board of Directors want to be able to hire a professional person and change the by-laws that now require the President to be a delegate and a director. This change could have a non-dog person in charge of the American Kennel Club. A vote will be taken on this item in December.

Mr. Stifel called on Dorothy Welsh, president of the Dog Museum of America, and she spoke of the new home of the Dog Museum, which will be in the St. Louis, Missouri area, about thirty minutes by auto from St. Louis, on interstate 44. This central location should benefit canine enthusiasts. Mr. Stifel then reviewed dog legislation in various areas of the country, and mentioned a mis-quote in the New York Times that stated the "AKC was out to defend the constitutional right of a dog to bite."

Mr. Stifel then spoke of a letter sent to all judges on occupational eligibility, the household test sent to all delegates on Aug. 28, 1986, and a letter distributed at the Westchester Kennel Club Dog Show. The Chair then recognized Barbara Wicklund of the Basset Hound Club of America to reply about the letter distributed at the Westchester Show. The letter was signed by thirty-six delegates and it requested the Board to reevaluate the management changes occurring, when people like Pat Beresford "retire" as editor of the Gazette, moves of John Mandeville, and Roberta Campbell. These moves were made by a newcomer not familiar with the AKC or dogs in general. The letter also addresses the directors of the AKC to examine the terminations, demotions, discipline policies and dissension now occurring at the American Kennel Club. Mr. Stifel said he would reply to the letter.

PART II:

December 9, 1986

Mr. William Stifel called the meeting to order and introduced new delegates attending their first meeting. The minutes of the previous meeting were approved and the deaths of Mr. Dick and Mr. Savage were announced. A list of proposed delegates was read with one person being refused because of ineligibility, from the Rockland County K.C. An amendment to change the rules applying to registration and dog shows to advance the deadline kennel clubs must submit a judges panel was approved by the delegates; this will permit judges panels to be published in the AKC Gazette in a more timely manner.

A proposed change to the bylaws to permit the president not to be a Director was challenged on the basis that bylaws can only be changed at the March meeting each year. The challenge was upheld by a majority of the delegates present - therefore the proposed change will be voted upon at the March 1987 meeting. Mr. Chester F. Collier, chairman of the Board Show Operations committee read a statement on cluster shows (ED, NOTE: Due to its length, I cannot print the entire report here - for further information, either contact the AKC or check in the Gazette). "A committee of Delegates will be formed to work on (this subject). The results , , , will be forwarded to the full Board, , , for its consideration, , , at the September meeting in 1987."

Mr. Louis Auslander read a statement relative to changes in current procedures for testing of judges. If a person fails a written test on a breed standard he or she must wait one year to take the test again; the waiting time will now be reduced to 6 months. Provisions have also been made for persons to take a test on breed standards orally. The controversial letter sent to judges and AKC Delegates on occupational requirements was discussed briefly by Mr. Stifel with statistics on those persons considered ineligible. Mr. Stifel also announced a review will be made of junior showmanship rules and the date of the September meeting will be September 15, 1987.

A motion was made and passed after much discussion to establish a committee to review AKC bylaws and report in two years to the board of directors and delegates. Finally a research firm was retained by the AKC to evaluate the AKC Gazette magazine in relation to other dog magazines. That report was made available to the delegates and will be used to improve the quality of the AKC Gazette. The meeting was adjourned.
