Nominations postmarked after 4/15/88 or with illegible return name & address shall not be eliquible.

Each voting member of the BCOA can nominate one conformation judge & one sweepstakes judge for each BCOA Independent Nati. Spec.

#### CONFORMATION JUDGE QUALIFICATIONS

- 1. Judges nominated must meet the requirements set forth by the AKC governing the awarding of AKC championship points to the Basenji breed.
- 2. Only judge shall be eligible who have not judged the conformation or sweepstakes classes at a BCDA Independent Natl, Spec. in the 5 years prior to this one.\*
- 3. The selected judge shall be requested not to judge Basenjis within 300 air miles of the specialty site during the six months prior to the specialty. Failure to comply with this request shall disqualify that person from serving as a judge at the BCDA Independent Natl, Spec.

## SWEEPSTAKES JUDGE QUALIFICATIONS

- 1. The sweepstakes judge need not be an AKC "approved" judge. Anyone in good standing with the AKC may serve in this capacity.

### AMERICAN KENNEL CLUB DELEGATE REPORT - Robert House

The attendance was superb for the December meeting due to the fact the proposed rule changes were to be voted on - elimination of Best of Winners and the 18-month old for one major win to finish a Championship. Three hundred and thirty-five persons voted this day on these items as well as other business. New members were introduced and asked to assemble later for a group picture for the Gazette, previous minutes were approved and a change to English Springer field trials were approved. Various other items were voted, such as, signs for unbenched shows, veterinarian responsibilities, controlling suspended persons, increase fees for filing a written protest and finally, custody of dog show entry forms. Please read the Gazette for particulars. It was voted to restrict discussion to twenty minutes before a roll call vote would bed taken for a up or down vote on elimination of Best of Winners. The motion failed by a vote of 265 to 70, which was an overwhelming defeat for the committee and the Board of Directors of the AKC. Ironically this vote also reflects how you all voted on the ballots you mailed in. The roll call vote took about 1% hours and a standing vote was taken on the one major after 18 months of age. This proposal was also defeated however by a smaller margin, again similar to how you voted. Mr. Raiph Del Deo read a report for proposed bylaw changes which will be voted at the March 1988 meeting, the full text of these changes will be published twice in the Gazette. The AKC took a position that no specific breed may be eliminated at a dog show, as proposed by the City of Newburgh, New York, to not permit pit bull type terriers at the January 1988 dog show in the City of Newburgh. The

location of the show has been moved. Mr. Ken Marden announced that the AKC was reviewing methods whereby dogs may be registered "Not for Breeding". I consider this a major step forward to improving quality in purebred dogs. For those of you involved in running a regular dog show a new tape is available on discipline, when and how to hold a hearing, which is required at times. Finally, Mr. Roger Hartinger was made chairman of the nominating committee & asked for suggestions and qualifications for proposed officers.

# 1987 PRESIDENTS REPORT - Judy Cunningham

Thanks for giving me your vote of confidence for another year. Last year with both a new president and a new secretary, we had to muddle along sometimes. With the help of many good member and past officers. I think I have the basics down and now we can go on to a more active year in 1988. The National Specialty in Illinois was well attended and the host clubs did a beautiful job. After the show we received an excellent report from the Auction Committee which will go to future show giving clubs. The auction was put on by the Basen; Club of Greater Detroit. This year we will try to put together a booklet with suggestions from past Specialty committees. There are always new ideas that really work. If you worked at other Nationals and can give some ideas, please send the reports to me for help to future specialties. At the National meeting, it was voted to include the color "Brindle" in the revision of the standard which AKC has us rewriting. AKC wishes all standards to be in the same format and the words used in all standards to have the same meaning. Before this standard becomes law it will be voted on by the entire membership as required by our constitution. The changed

parts will be voted on individually. The color change will be voted on and must be approved by 2/3 vote or it will not be in the new standard. It will be a while before this standard is ready, but your vote will be heard. Just be sure to return your ballot when it does come out. Bob House has tallied the votes for the Dec. 8th AKC meeting. He will be voting no on both of the new measures set forth by AKC. The vote to eliminate Best of Winners was - NO 129, YES 37. The vote requiring one major after 18 months was - NO 88, YES 79. A full report is on file. Finally and most important - if you have a dog who was awarded a title last year, send a xeroxed copy of the certificate or the magazine printout of the title to Jane Williams, PC 80x 69, Good Hope, 6A 30641. These dogs will be honored in the second Bulletin of 1988. A special advertising rate will also apply. Best Wishes for a great New Year. JUDY
