Please in the next issue could you define: Fula, and the initial IPSID? Most appreciated.

Also sent in ballots when received - Bulletin should have arrived before ballot - to bad I'd have voted differently or added a comment. To late now.

Forgot one comment and do not know how to get it included. We hardly mention movement yet most judges judge heavy on it from my few observations. Our dogs do not move as a race horse trotting full out! I'd like to see movement included but will/did (Sh) accept proposed standard.

(EDITOR'S NOTE: The best I can do for you is some extremely brief definitions from my own (possibly mis-) information. Fula of the Congo was imported by Veronica Tudor-Williams after the first tri-colors had already appeared in breedings in England. The tricolors that descended from Fula included a new pattern - called "Fula black", it was a black and white that was not dominant genetically, and showed a tendency to tan hairs later in life (on some it was very young). On a traditionally patterned tricolor, you can tell those that carry the "Fula black" by the isolated islands of black on the cheeks in the mask. The full name of IPSID is "Immuno-Proliferative Small Intestine Disesase; it is my understanding that it is the clinical name for what we had been calling "malapsorption", a wasting disease that includes diarrhea, weight loss, other symptoms, and usually death. You may be able to get more information from your dog's breeder, MEMBERS OUT THERE - Help me please?!?

I am not really a Basenji breeder, or even a serious show contender. I own Basenjis because I admire them as a unique and lovely breed of dog. I think it is wonderful that the brindle dogs are being seriously considered. I am not particularly a brindle fancier, but they have their place in the African population and I believe they should be a part of the American population.

May Kenworthy does seem to have a strong opinion about colors. Surely the health question is more important! In my limited experience, breeds that are color restrictive seem to have an excess of health problems associated with them. Human interference doesn't always build a better dog. The Basenji is an old breed and has turned out very well without much meddling from humans.

The more natural population of African dogs should be combined with the American dogs. Some genetic diversity seems essential for the health of the breed. I believe the concerns should be the health and vigor of the dogs, not the colors. Basenjis should be bred for type and hunting instincts. It would be a shame to have the American dogs become a different type than the African dogs.

For every color there is a person who likes that particular color. Color preference won't ever go away. But an entire breed of dog should not be adjusted to fit the tastes of one or two people. I am relatively new to Basenjis and I hope that the individuals with the power to make such decisions don't all agree with Mary Kenworthy.

Just one owner's opinion, but surely there are others who agree with me!

If there was ever a time for Basenji breeders and the BCDA to "make haste slowly," I think this is it! While our Standard format must be changed to adhere to AKC's requirements, any actual changes should be carefully thought out as the impact will be seen for many years to come. Adding a new color pattern at this time, when we have no idea how it will affect current colors or even if it will produce correct brindles, should be tabled until an extensive test-breeding project can be carried out with the proposed new breeding stock. This will also allow time to determine what this new stock carries genetically in regard to physical, mental and health traits, as well as any problems which may surface with age.

Even a limited amount of test-breeding and the resultant observation of the following generations (a minimum of 3, to have any real value) would take at least 7-10 years if done correctly. We need to know as much as possible about the genetic makeup of this "new blood" before incorporating it into existing bloodlines or we could very easily wind up dealing with more severe problems than we already have. This means inbreeding on these dogs (son/mother, father/daughter, brother/sister, then going back to the original dog). If the quality of the dog prohibits this type of breeding, then I can see no reason to consider breeding it at all.

Equating the brindle color with health is simply not possible as we know absolutely nothing about the genetic makeup or background of these new imports. We can HOPE that they do not carry and/or will not develop Fanconi, IPSID, or possibly something even worse, but anything more than hoping is only wishful thinking at this point!

I wish to stress that, like Mary Lou Kenworthy, I am not (repeat, NOT) against the brindle color, new blood or change. We were both very taken with the brindle and red bitch pups shown at the end of the '88 Safari film and feel that they both are of excellent quality, obviously pure breeding, and have much that is positive to contribute to the improvement of the breed. Our main concern, shared by many other long time breeders, is that this be done in a way best suited to minimize future problems. A long term breeding program, such as John and Margaret Sommer planned for their native import acquisition, is the responsible way to handle such a project. There is no reason at this point in time, other than financial recompense for the people involved, to register these native Basenjis with AKC.

ASFA is an organization that was organized to test the coursing abilities of ASFA recognized sighthounds and award Field Championship Certificates to those hounds that are judged worthy. At the present time Basenjis are recognized as sighthounds by ASFA and are eligible to compete at field trials sanctioned by ASFA and earn points toward their Field Championship. If the BCOA wishes to hold Lure Field Trials in conjunction with their National Specialty Shows, the BCOA must become an affiliate member of ASFA.
