NATIONAL SPECIALTY UPDATE:

By now all BCOA members have received their premium lists for the BCOA National Specialty along with the premium list for the Northern California Specialty. Some may have noticed a printing error on the Entry form. The error is in the small print portion at the bottom of the entry form, where it states "I certify that I am the actual owner of the dog or that I am the duly authorized agent ... I (we) agree to abide by the rules and regulations of THE STATES KENNEL CLUB...". The same error appears on both the BCOA & BCONC Specialty entry forms. Do be assured that both specialties ARE American Kennel Club Events.

Margery Brown, Show Superintendent for both specialties, stated that this error posed no problem. "It was a printer error - someone in the shop tried to be helpful. My proof showed the correct wording but the printed batch was changed." Although no correction is necessary, for those who are concerned, Margery offers this solution: cross or white-out States Kennel Club and PRINT American Kennel Club OR use a blank, generic entry form and manually write in the Specialty information on the top of the official form. Ms. Brown stated that she will handle any problems that may occur with the forms. In addition to BCOA members, many others were mailed these Premium Lists. PLEASE let others with Basenjis, who are considering attending the Specialties, know about this to avoid any confusion. Thank you for your help.

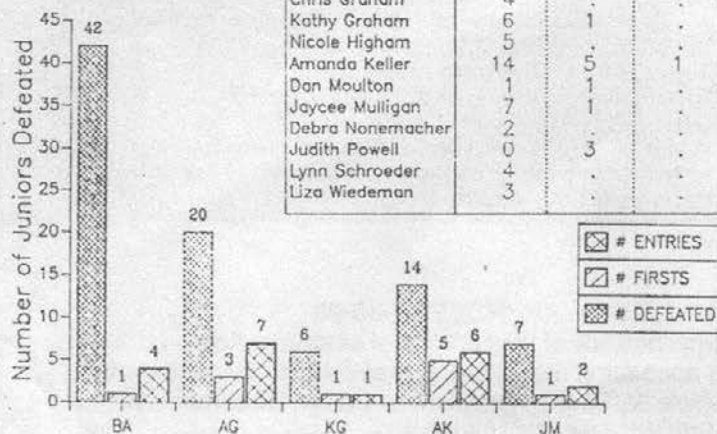
