The New York show continues to draw a maximum entry despite the many inconveniences most exhibitors who have experienced Westminister report. Medallions will be presented to winning champions at the 116th show & it should prove interesting to see if the Champions Only limitation will contribute to further the prestige of this Annual event.

The new AKC video, BEST FRIENDS, is now available. This 15 minute tape covers the benefits of dogs in society, the need for responsible dog ownership & workable solutions to problems of too many pets & not enough homes. It is an excellent educational tool for those that have the desire to teach this most valuable information to all. The Canadian Kennel Club new ruling, effective Jan 1 1992, states that all foreign born & owned dogs entering Canada for the sole purpose of entering CKC events will no longer require a CKC registration number. An Event Registration Number (ERN) only will now be required. The ERN will not register a dog for breeding purposes but will enable the dog to be awarded titles by the CKC. 
