The BCOA Board of Directors will decide on the use of the income from the breeders' listings on the web for matters related to breeders, such as (but not limited to): Outreach (countering commercial breeders), judges' education, breeder education, fighting anti-dog legislative endeavors, the Basenji Health Endowment, and the like. This income will not be used for day-to-day club operations, Club reserves, or funding national specialties.

**All breeders requesting to be listed must sign/execute this release the first year of their web listing.** This release will be kept on file with the BCOA as long as the listing is renewed.

**If you completed the form in 2015, your release is on file and is not required to be resubmitted.** Your release will remain on file with your 2017 renewal of your Breeder Web Listing. By Lapsing, your release will be discarded, and will be required to be submitted with a new listing.

**By renewing (payment required) your listing, the breeder agrees to renew/extend their contract with BCOA.**
