In response to the questions raised by Mr. Wallace's article, "The Brindled Basenji, "in the September issue of "The Basenji, " I offer the following: I fear that Norman has approached the subject from the wrong premise.

He says that the so-called Basenji Brindle is not a true brindle. His premise is that the true brindle is what is often referred to as a "tiger" brindle. According to Webster, he may be right but we are functioning under AKC rules and they state in their book that, "Brindle is a fine even mixture of black hairs with hairs of lighter color, usually tan, grey or brown."

Brindles did not occur in Basenjis to any noticeable extent until after 1950. The first reference to the color appears in the English Standard of 1954 when they refer to it as "sable" which AKC describes as "A lacing of black hairs over a lighter ground color." This color is not faulted under "color" but appears under "faults." In our present 1954 Standard we follow suit. There is no mention under color, but under faults we say: "... Creams, shaded or off colors, other than those defined above, should be heavily penalized." Whether the words "heavily penalized" apply to color only or to the few other faults mentioned is not clear. The most recent or English 1961 Standard simply lists "off colors" as a fault. In no recognized Standard is brindle mentioned as a "disqualification."

I am inclined to believe that AKC might allow us to write a Standard wherein we could "disqualify" a dog FOR SHOWING but I know positively that once a dog is registered by AKC they will not prevent the registration of the progeny so long as both parents are registered.

We were told as long ago as 1955 that AKC did not approve of any individual or club telling their judges how to judge and that the Standard should have been so written that it required no explanation or illustration.

The matter of brindles was not a problem until the early 1950's. In 1947 an accidental inbreeding of two of Miss Tudor-William's Amatangazig's grandchildren litter-mates produced a tri. A later intentional inbreeding produced

another. Then the craze to get in on the ground floor resulted in breeding tris to reds. I warned my friends that they were in danger of producing some weird-looking crosses. They assured me that my fears were groundless as they had bred reds and tris frequently, with the result that they either got good reds or good tris. The trouble with their thinking was that they had not accumulated a "History" on the subject. I do not know of any brindles from a mating of this type but I do know of brindles occurring when the resulting reds were bred to other reds also carrying the black gene. It is these second and third generations that are producing the brindles according to my limited information on the subject. If so, it looks as though we are "locking the barn after the horse has been stolen."

Inasmuch as the breed is pretty well infiltrated with black genes among the reds, it looks like a hopeless task to arrive at the answer. My advice is to accumulate a lot of pedigrees of offenders and turn them over to a trained geneticist for study before we go any further. Otherwise you may do more harm than good. In other words, let us "make haste slowly."

Editor's note: The Basenji will publish any comments on this subject from our readers. We believe a free discussion and dissemination of such information will be helpful to the breed--which is the primary purpose of this publication.

From Norman Wallace: (In reference to the article, "The Brindled Basenji" in the September issue.) I believe my article—as brought to my attention—should be amended. Somewhere in the description of what we call "brindle" should be inserted a statement to the effect that a few black hairs on inner side of tail or behind the ear should not be considered as "brindling" or faulty. It is indicative of the fact that, where only these hairs show, the dog is a tri-color carrier and should not be faulted. I'm sure that those of you with some years of experience in Basenjis are aware of this matter but, of course, the newcomer is not.

Canine Psychology

"THE PUPPY AND HIS ENVIRONMENT" by Barbara J. Nolan

Much has been said in many fashions about how one should raise puppies. Topics on this subject have "ridden a good horse to death" - so I won't kill the horse. I merely want to convey some thoughts on the environmental effects on puppies.

A lot of T.L.C. (tender, loving care) these days termed psychology, needs to be employed when raising a new generation, whether they are dogs, chickens, hogs or horses. Puppies are the most unique of all animals and need special care in developing an untraumatized psyche.

Raise a dog so that he won't be shy and retiring, this is a good start. To define a "good start" means that a puppy should be handled or fondled by humans from the beginning. But this needs to be explained before all of the doghandlers in the country set up a hound cry. It is a popular belief that show dogs should never be held because of bowing the puppies' forelegs or elbows. This, as we all know is possible, but there are correct ways to handle them without these ill effects. Many people have witnessed shy dogs in the show ring and also the selfconfident ones, who are usually receiving the first place ribbon. As a general rule, I can almost predict that these shy and retiring dogs were raised by very quiet people in a very quiet home. When these shy dogs reach the hustle and bustle of showdom, they don't know how to act. Sometimes this will really traumatize an excellent show dog.

To help eliminate the unstable or to insure a well-adjusted dog, one should start from puppy-

hood. When you are first dealing with a puppy, don't overprotect him, expose him to every-day life. This should be done in a manner to give him confidence in his master or handler. When you begin handling the pup, you should assert your confidence through your hands to him. Don't make the mistake of trying to fool him. Think confident and you'll be confident. To earn a dog's confidence, you must begin by being understanding and conquering your own nerves. If a puppy shies or pulls away from you, don't jerk and yell at him. Just reassure him that everything is under control and pet him in a gentle manner.

It has been said by many people in the field, and not just theorists, that when you start something, go through with it. If he overcomes one of his fears, rejoice with him even though it may be a little undignified.

To the final handling in the show ring, the difference between a professional handler and a novice handler is usually a great deal of consideration and understanding for that dog and that breed. Dogs really don't know where they placed in a show until they are told. Where first place receives extreme praise, I feel sometimes that as the ribbons progress towards the bottom, so does the praising. With the right attitude, a good showing can be just as fulfilling as a first-place ribbon. A definite goal is reached when both dog and master enjoy displaying their abilities. A puppy taught this attitude at an early stage will keep it with him always.

Insert the name of the Breed of the litter; the number of male and female puppies living at the time the application is submitted; the Month, Day and Year on which the litter was born; and the City and State of birth. Any change or erasure in the number of living puppies or in the Date of birth requires written verification by the Owner of the Dam on the Date of Birth of the Litter.

2. Insert the exact Registered Names and AKC Numbers of the Sire and Dam of the litter in addition to the Registered Names of the parents of each. Print this information clearly. If either the Sire or Dam is not registered, or if either of their applications is in process at our office, the registration of the litter should not be applied for until the certificate for the Sire or Dam is received by the owner so the Registered Name and AKC Number can be inserted on the Litter Application.

3. Section Amust be personally signed by the Owner of the Sire on the Date of Mating, and the Month, Day and Year of the mating must be inserted by that person. Any change or erasure in the date of mating requires the written verification of the Owner of the Sire.

4. Section B must be personally signed by the Owner of the Dam on the Date of Birth of the Litter. If that person was also Owner of the Dam on the date of mating, it will not be necessary to complete any other Section with regard to the dam. The litter will be registered in the name of the person whose signature appears in this Section.

5. Section C on the reverse side of the application must be personally signed by the Owner of the Dam on the Date of Mating only in a case where ownership of the dam changed during whelp. Whether or not the actual mating was witnessed, is to be checked.

6. The fee for registering a litter of puppies is \$2.00. In all cases, the necessary fee must accompany application(s) when submitted to us.

PLEASE NOTE THE FOLLOWING. . .

A - The normal period of time between dates of mating and birth of a litter is approximately 63 days. Special care should be taken to insert correct dates. (See paragraphs 1 and 3 above regarding changes or erasures.)

B - Personal signatures are required when called for, as printing or typing will not be accepted. If dog is registered in joint ownership, all owners should sign.

C - No other person may sign for a Registered Owner without a Power of Attorney or other official authorization in our files. Power of Attorney forms may be obtained from our office upon request and without charge.

D - Signature of the owner shown in each Section must correspond with the specimen signature in our files.

E - Leasing forms are available at our office to those persons who actually lease a dog for a specified period of time for stud or breeding purposes. However, one-time use of a dog for stud purposes does not necessarily constitute a lease; in such cases, the actual owner of the dog should complete Section A.

F - The name of the person signing any Section must be shown on our records as owner of the dog on the dates of mating or birth, as the case may be. Unless we are notified on official form of a transfer of ownership, we shall be forced to return a litter application if names appearing on it are not shown on our records as registered owners.



SOME TIPS ON GROOMING

George C. Jones, III

Taking a well groomed Basenji into the show ring is just as important as his conformation...if he is to win. Being a breed possessing very short hair, the Basenji is relatively easy to groom, and should take no more than fifteen to thirty minutes to prepare for the ring, assuming of course that the dog is clean. First I always start with the nails, and for this, I use the Resconail cutter, which is far superior to anything I have tried, and makes a nice, clean, even cut. Here however, care must be taken not to remove too much of the nail. I always try to "hit" the quick, but never go beyond it. If the nails do bleed, the bleeding can be stopped by applying iron sulphate powder. or if that is not readily available, any powder (such as talcum) will work almost equally as effectively. From the nails, I go to the head and muzzle, where all whiskers must be removed. For this, I use a pair of Oster electric clippers, Model #A2, with a #30 blade attachment. After removing the whiskers, I use these same clippers and completely take all hair from the inside of the ears, and the backs of the pasterns. To those of you who do not wish to invest in the Oster clippers (about \$50.00) a pair of manicuring scissors with curved show ring.

cutting edges will do the job with less speed. Here in the Deep South, we are not troubled by the untypical heavy coated Basenjis that are common in some areas. The thick undercoat can be taken out by using a Resco (or other make) stripping knife. This however, takes considerable patience on both the groomer and the dog. Next, comes the chalking. I have used many different brands of chalk, but have found nothing that comes even close to "French White" (in block form) manufactured by the R. C. Steele Company in Park Ridge, New Jersey, as far as quality is concerned. The chalk is worked into all parts of the dog's coat where there is white, and then must be removed, using a small stiff brush, making certain that no chalk remains in the coat, as this can disqualify the dog in the ring. That just about covers it, except for a final touch of adding a small amount of oil to the dog's coat for added sheen. Here, I recommend either Bain de Soliel (a suntan oil) or Alberto VO-5, the latter being less expensive, and both give just about the same result. A small amount is rubbed into the palms of the hands, and then over the dog's coat.

Good luck to you and your Basenji in the show ring.





A satisfactory litter bed can be made from a strong cardboard box. Put layers of newspaper on the bottom, then a *USED but not ragged blanket over this so that the puppies won't get tangled in the bedding. Secure the blanket with Brass Paper Fasteners to the side of the box, quite high up so they can't wiggle under it. Leave the top on the box and cut a side opening for the dam high enough so the puppies won't fall out.

*New blankets have loose fuzz which could be harmful to the puppies.
