THE WHY AND WHEREFORE OF BRINDLE BASENJIS

A clear red Basenji is one with a red coat with no black hairs in the coat except on the top of the tail or on the back of the ears. These black hairs are not present on all red and whites. The black hairs on the tail denote the animal is a tri carrier, not a brindle carrier. Black hairs on the ears have nothing to do with either tri or brindle genes. Red and whites carrying no tri and no brindle can have and often do have these black hairs.

The brindles as now seen mature with a clear red back-line, and have black hairs down either side of the back-line, widening out just back of the shoulder area in a "boomerang" shape. (These are, of course, completely separate from the tiger-striped dogs.)

The "saddled" brindles are separate from the usual brindle. Saddled brindles are whelped looking exactly like tris, even to tan eyepips. Gradually the black hairs on the face and legs shed out, leaving the dog marked like a saddled beagle. The saddle is not dark brown. It is black. Often it is not a jet black, but a dull black with a biege undercoat showing through. Often the black hairs themselves are beige at the root, shading to black on the outer end. I think that all such dogs are dead. I believe I owned one of the last living "saddled" Basenjis. If I am wrong, I would appreciate hearing from anyone who now owns one.

A clear red Basenji that has a tri parent cannot be a brindle carrier.

The perfect way to find out if a dog or bitch is a brindle carrier is to breed to a tri. A brindle gene meeting a tri gene brings the brindle gene out in the open, i.e. it produces a brindle coat. Not all genes thrown by a brindle carrier are necessarily brindle. A brindle carrier bred to a tri will produce r/w pups and brindle pups. Keep in mind that in an experimental litter, a small litter of 3 r/w pups will not be proof positive. If the bitch had had 5 pups, 2 or 1 could have been brindled.

The r/w pups will not be brindle carriers. The brindled genes passed by the carrier have to come out in the open when bred to a tri.

Brindles are produced by two methods: A brindle gene meeting a tri gene, or a brindle gene meeting a brindle gene. Therefore, two clear r/w coated Basenjis can produce brindles.

A brindle also can be a tri carrier.

I have not arrived at these conclusions by guess. I have known of all such breedings that resulted in the tables listed below. In the years past, several breeders worked closely in experimental litters to arrive at these conclusions. I subsequently owned several of the Basenjis involved. The experimental litter using a brindle is not necessary. The experimenting already has been done, and the results known. Unfortunately, the results should have been published every year, but weren't. Very few know them. (continued on page 15)

WHAT??
YOU CAN'T MAKE HIM MIND??

Did you ever have a friend brag that his child is the best behaved boy that ever lived? Sure you have. Then you get the chance to see their pride and joy give a very good demonstration by throwing a tantrum right in the middle of the living room floor, while Daddy stands by and says, "Isn't he just the cutest little thing?" Anyone who has raised a child or seen the neighborhood voungsters running wild knows just how they try to get their own way. Sometimes by opening their mouth and letting out a scream (just to make a noise) or just as often by being cute, coy and down right sneaky.

Are you getting the feeling that I might be describing a typical Basenjipup? You are right. As with children, the basic training program must start as soon as he is able to learn. In dogs this is usually on the 21st day of life. Your Basenji must become accustomed to the fact that you, a mere human being, are master of the house.

We start training our pups with the simple 'stand stay.' This is started as soon as they are able to stand reasonably well by themselves, usually about three weeks old. As a very young pup they learn that they can and must stand still for us when told to do so. At first it is for very short periods - - even a few seconds is sufficient. It is here that the pup's willingness to learn and to please is developed. Before he has a chance to develop the normal Basenji ways, he has learned that if he does as you say, he gets much praise. Don't let me mislead you, this does not, in any way keep him from being just as mischievous as his ancestors. It does help however, when it comes time to teach him that Dad's new slippers were not bought just for him to teethe on. As the lessons on standing progress, we find that just telling the pup, in a firm but not harsh tone, what we want is all that is needed. He stands still quite readily, waiting for the praise he knows will come.

It is most important that once your "baby" has done what you said, whether you had to "help" or not, he should be praised very enthusiastically and told what a wonderful fellow he is. Your tone of voice is very important. He can tell much more from your tone than the actual words you are saying. You must be genuinely pleased or it does little good.

When the new owner arrives to pick up his pup we stress the point that the Basenji is very intelligent and quick to learn, good as well as bad habits. But, he also has a strong mind of his own. Dumb animal? I hardly believe this applies to any Basenji.

We had one interesting occurrence about a year ago. The owner of a six month old pup called to see what we would suggest he do about his "baby" that had, during the last couple of months, chewed all four corners off a \$75 coffee table. We invited them to come out and bring their pride and joy. He behaved more like a four legged monster than a six month old pup. He even tried to pull one of the cushions off the couch while we were sitting on it. They wondered why they couldn't get him to mind. First of all, both husband (6'4" tall) and wife never TOLD the dog what to do, they always ASKED him. In fact, it sounded more like begging him to do it. ASKING almost any Basenji to do something is just as good as saying, "Sure, go right ahead and do whatever you like, dear." This is exactly what the pup did. With the owner's permission, we took their boy out to the back yard. We put a training collar and leather lead on him. He knew very well what the word "sit" meant, but he wasn't about to do what a stran-

you want comes easily. He was a bit dumfounded until he realized he was doing what he had been told. He immediately got up. We went through the same procedure again. This time he didn't waste any time letting us hear his opinion of the whole affair. It was at this point the husband began to realize that his dog wasn't hurt at all, but just making a lot of noise to try and get out of doing what he didn't want to do. The husband told me later that this is just what the dog did at home and more often than not, got away with it. Needless to say, that afternoon he didn't. After working with the pup for about a half an hour he was quite docile, obedient, and happy with his tail held perfectly. A dog, just as a child, likes discipline. They want to know just what they can and can't do. The owners were quite surprised and a bit ashamed of themselves after seeing what they had allowed their pup to get away with. They realized what a little consistently applied discipline can accomplish. The owners and dog left after being given a few instructions on how to continue the training. We have since seen them quite often; the dog is always with them and behaves like a perfect gentleman. This is because he no longer is allowed to get away with "just a little bit - just this once because he is so cute." It took much perseverance and consistent firm correcting. They say it was well worth the effort because now they have a dog they can be proud of rather than one they were apologizing for constantly. The pup has since attended an obedience class and graduated first in his class, which was made up mostly of Poodles that are known to be excellent obedience It is the owner and his

LOOKING AHEAD IN GREAT BRITAIN

The British show season is now developing in momentum. Exhibitors are beginning to look forward to the start of the open-air Championship and Open shows, many of which are delightfully situated in the best of the English countryside and are often run in conjunction with large agricultural shows, thus providing alternative attractions for restless spouses and children. With this anticipation goes the eternal optimism of the English about the weather. Past memories of howling gales, of flapping marquees, - which have on occasion been known to collapse - of thunderstorms and pouring rain, with judging taking place in hurriedly organised spaces at the ends of benching tents, on squelching grass and in a cathedral like gloom, have been purposefully thrust into the recesses of the mind, and hopeful pictures of dogs showing at their best in the warm sunlight against the bright green contrast of the grass and trees, of picnic meals at the benches, with the sideflaps of the tents removed and a smooth ride home over the hills in the cool of the evening, are conjured up instead.

The season of indoor all-breed championship shows is now drawing to a close. Last week-end was the turn of Glasgow, one of the two shows run under the auspices of the Scottish Kennel Club, and held in the Kelvin Hall. There was a record all-around entry for this show, but attendance was badly hit by unexpected snow blizzards which swept the whole of England, Scotland and Wales and which hit air, road and rail traffic badly. Basenji entries at this show are rarely good mainly because of the predominance of Basenji breeders in the southern half of England, and the uncertainty of the weather at this time. This year was no exception with only 16 Basenjis present. Mrs. Stringer. making her debut as a championship judge of the breed, found herself in

the unenviable position of withholding the dog C. C. - one of three withheld at this show. British judges, as pointed out in my article in the Feb. issue, have a plain duty to do this when none of the animals present in the sex is considered worthy of the title of Champion, and it cannot be otherwise than good for the breed to do this when necessary, although very disappointing to exhibitors. The bitch C.C. and B.O.B. was won by Mrs. C. Tress's homebred two year old red and white bitch. RIDINGSGOLD FANTASIA, her third C. C. thus making her a champion. I had the pleasure of awarding this bitch her first C.C. at Blackpool last year. Mrs. Tress had a nightmare journey to Glasgow, having had a flight cancelled, queued for a train which was full before she got to the end of the queque, waited seven hours for another one, which was also full before she reached the end of the queue, and only getting on it eventually by demanding of the railway authorities that they put on extra coaches, arriving in Glasgow twelve hours later. I am sure however. knowing her, that her win will have compensated for her exhausting experience.

Next Thursday we are off to Manchester Ch. Show, a very large two day affair, held at Belle Vue, a large entertainment center on the outskirts of the city, with a zoo, various stadia, ballrooms, exhibition halls, sideshows and fairground entertainments, etc. Manchester is of course, a great port at the end of the Manchester Ship Canal, and an important industrial and commercial center, particularly for the Lancashire textile trade. As the suffix "Chester" - a derivation from the Latin "castra" implies, it was a Roman camp during the Roman occupation. It has a long and distinguished history, although most of its architectural antiquities now derive from the mediaeval period with

its 15th century cathedral and scattering of Tudor and Elizabethan halftimbered houses, one of which is a delightful pub frequented by the writer fairly frequently after a hard days work.

The Basenji entry is rather better than at Glasgow, 22 Basenjis making 51 entries, for Mrs. Percival to judge. Mrs. Percival is the owner of the well-known Little Breach Kennel, and is also a Ch. Show judge of other breeds, particularly Cavaliers and Dachshunds. Perhaps her most famous Basenji, among the many champions which this kennel produced, was CH. BENEDICK OF LITTLE BREACH. from her very first litter of Basenjis. "Benedick" proved a great sire. siring a large number of champions, and died only quite recently.

April will see the first of the outdoor Ch. shows - the West of England, Ladies' Kennel Association show, a two day show held in the lovely grounds of Boddington Manor, near Cheltenham, a famous spa town noted for the elegance of its many Regency buildings. Because of the alleged healing properties of its mineral waters, Cheltenham was a favourite, out of season, retreat for the dyspeptic Regency aristocracy.

The judge elect is Mr. William Burrow, this time a noted all-rounder who judges most breeds at the Ch. show level but who has only recently been added to the list of accredited Basenji judges at this level, so that his opinions will be awaited with interest. The classifications for these shows held earlier in the year are, of course, more restricted than in the second half, since the new crop of puppies does not appear in the ring until June. We are also bedevilled because of our climate at this time of the year by the casting of coats in readiness for the summer.

I'm sorry that my article on Crufts went astray - through my own stupidity, I'm afraid. In my excitement after our young bitch, Rinkleknut Princess, gaining her title and B.O.B. at this show, I put the wrong stamp on the envelope-the correct one is the same colour, unfortu-(continued on page 13) "Win Both Hearts And Shows"



Then too, the Hip displasia problem, and what should be done about it, sometimes makes for heated discussions and hard feel-

you an idea of the atmosphere I came from, into Basenjis--and the wonderful people connected with this breed.

I had no sooner received the "kids." Tinas Coma Cumfy Cozy and Tinas Coma Rinkadinkadoo from Norm Wallace, when I received several letters welcoming me to the breed. This was a pleasant surprise.

Our first show was the Specialty at Devon, Pa. At first glance I felt lost again. I thought Basenjis were a rare breed -- first show and eight in our class! There were name cards, done up very nicely, on each of the benches. Sort of added the "personal" touch, and gave one a feeling of "something just a little bit special" about these people.

A few weeks later we entered the "kids" in another show, this one closer to home. We went Winners Bitch, but lost out to the male for Best of Winners, and a major. While

waiting for the judge to hand out the ribbons, the GENTLEMAN handling the Best of Winners dog turned to me and APOLOGIZED -- explaining he already had both majors, and it would have been nice if Cozy had taken the win.


I think a benched show more than anything, shows people up for what they really are. You are grouped close together, and the attitude of the Basenji people is really something to observe. We have exchanged chalk, brushes, tips on grooming, handling, etc. And the conversation is just as congenial after the judging as before. You may come across an exhibitor now and then that hardly says more than a mere, "hello". . but it's not because they have a "better than thou" attitude, more than likely it is because they are either new in the "game" or shy. So meet them a little more than halfway . . . you have nothing to lose, and another friend to gain!

I recently traveled to a show with a gal who had her bitch entered in the same class as mine. I enjoyed every minute of the trip down, as well as back! Talk about being a good sport . . . congratulations were passed around after the judging, and I teil you all this, only to give that was the end of it. Talk on the way home was of the dogs in general. the excellent manner in which the judge went over and observed the dogs, and which show we should go to next. A little note here . . . we

went reserve to her bitch. Here was a gal who knew how to take her win without gloating, and I hope to travel to many more shows with her, since, regardless of who wins, the trip itself will be most enjoyable. I have traveled with Shepherd exhibitors who have bragged all the way home when they won, and sulked when they lost, refusing to say one

Another Basenji friend wrote to tell me she had hired a handler to take her dog in a show and the same class that I had my bitch entered. She didn't want me to think she was trying to "pull" anything. I thought no such thing, and didn't blame her at all, since this particular handler knewhis stuff, and was able to get a lot out of her dog.

Don't misunderstand me - - we show our dogs for one reason - - to WIN, and when we don't, we are disappointed. This is only natural, and you're kidding yourself if you say otherwise. Once in awhile we get mad at what we feel was an unfair placing - - we let go. Well, this is natural too - - we don't claim to be 100% perfect, anymore than our dogs are. But don't change from the kind of exhibitors I've grown to know and like so well. If you don't win - - then root for the friend in the ring. I've always felt if I must lose. I'd rather it be to a friend - and with so many friends, how can I really lose?

A dog, is a dog, is a dog just Basenji, but none so unique. isn't so, and the Basenji is perhaps the most unique breed of dog in the with your Basenji. world. He has observed a stark, realistic portrayal of humanity in virtually all of its stages, from the most primitive, to complete sophistication. Further, the Basenji has gone from the raw world to one in which only the very best abounds. Therefore, it is easily understandable that he can adapt himself to practically any situation or environment. The same body conformation that gives the lithe, agile Basenji his endurance and speed in an open field, also allows him to move with fluid grace through the smallest apartment.

Fortunately for me, I have never owned one of the "screaming" Basenjis, and I guess I am just lucky, as there seem to be quite a number of these around. All of mine have proven to be almost totally silent, and the only sounds heard, are an occasional yawn. All of them have had a very audible growl however, which by no means indicate viciousness, but rather they are being protective. I have never attempted to discourage the growling, for when it occurs it is always for a good reason. Whenever they are left loose and alone in an automobile, they will immediately start to growl if a stranger so much as touches the car, and I feel that should an unwanted guest attempt to enter the car, he would surely have "a tiger by the tail." Whether or not Basenjis are labeled vicious, should dependentirely on the circumstances. Growling as a warning that the Basenji is protecting his domain, to my way of thinking is perfectly alright and absolutely the way it should be. However, growling at a Judge in the Show Ring constitutues an entirely different situation, and is strictly taboo, and never acceptable.

Who owns these unique dogs? Someone once said that it is not unusual for the unusual dog to be acquired by the unusual person, and to a certain extent; I would have to agree

with this. Surely, the person who seeks out, buys and keeps an un-EXPOSURE common dog, is showing above average curiosity, discrimination, initiative and daring. Certainly there are many breeds more unusual then the


