



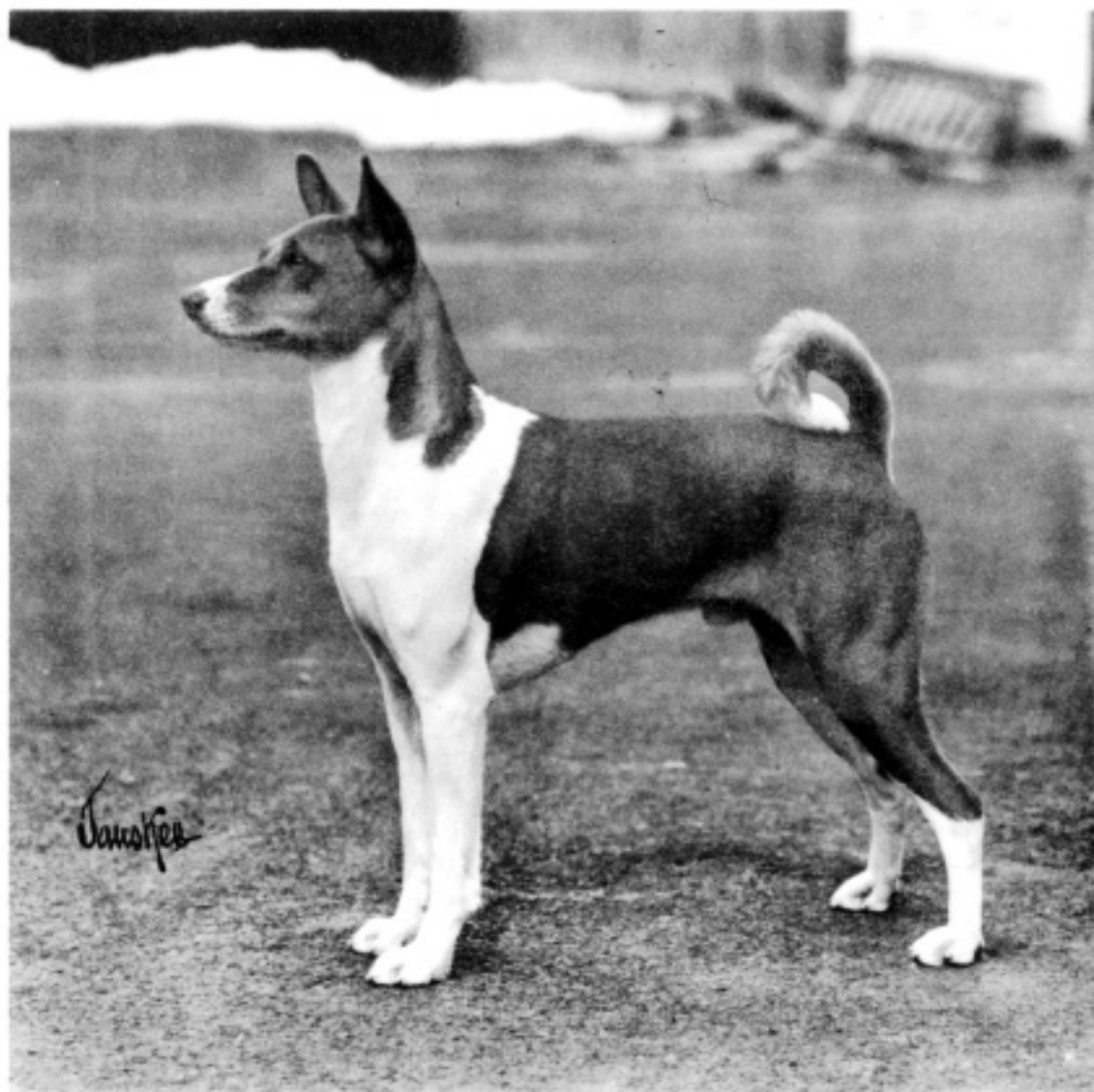

"WAGGING TALES FROM NEW YORK"

"WHAT ARE DOG SHOWS COMING TO?"
(Or have they always been that way?)

What are dog shows coming to when a coarse, heavy, brindled dog is put up to Best of Breed over a noted, beautiful champion? And this same dog is actually able to obtain his championship?

When a dog so unsound in temperament that he goes after his owner/handler as well as the judge, show after show, and is still given the points by some of our judges?

When notes must be kept on judges, pointing out their preferences; small dog, large dog, fine bone, coarse, movement, head, etc. When we must cross a particular judge off of our list as being anti-tri.

Then there are the judges who always take their winners from the Open Class, another prefers to give it to the puppy. At a show here in the East recently, a judge was seen placing puppies to Best of Breed over champions in three of the breeds that he judged that day. I'm not against a puppy taking the points if he really deserves them, but how many are truly matured enough to be put over a number of champions to Best of Breed? We wonder why our breed does not place in the group as often as we'd like, or even a Best in Show at times; but can you, in all honesty, say that an 8 month old puppy is ready, physically, as well as mentally, to compete in the group ring with three and four year old seasoned champions? Some of our judges seem to think so!

It has come to the point where breeders no longer pick

the best quality dog from the kennel to be shown, but the one best suited to that particular judge.

I have great admiration for the many breeders who have imported stock in this country, and because of an A. K. C. ruling, these dogs, at puppy age, are forced to compete in the Open Class. They win, not because they are merely a good puppy, but because they are mature enough to beat their adult competitors. In the judge's eye, this was a mature dog.

How many breeders refuse to show their dogs in the Bred-by-Exhibitor Class, because his chances, he feels, aren't as good as in the Open Class. Why should this be?

The Bred-by-Exhibitor Class should have a large entry, since breeders should be proud of their own breeding, and not feel they don't have a chance for points here.

Another thing, since Basenji males usually carry their testicles so high, I'd like to know how some of these judges can tell if they are all there or not by just looking!

Our breed is unusual in that a cold or excited dog is capable of retracting one or both of their testicles. However, the veterinarian can feel them in the scrotum. Nevertheless, since the judge would be unable to distinguish between the dog who has merely retracted the testicle(s) and one whose have never come down into the scrotum, he would be forced to disqualify him. It is without a doubt, a shame that the male who has merely retracted them must suffer disqualification, as well as the dog whose testicles have never been there.

I cannot help but feel that after certain judges have had their license for so many years, they tend to take their assignments rather off-handed. Under these judges, few of us feel that we have gotten our money's worth. We've all shown under them - some never put one hand on the dogs before them. They just assume both testicles are in the scrotum and that they have the correct bite. Others don't even gait the dogs

CALIFORNIA CRUCIBLE

Breeders and veterinarians are becoming aware of the increasing frequency of hereditary eye defects in purebred dogs. A variety of such defects have already been described in Miniature Poodles, Irish Setters, Bedlington Terriers, Collies and other breeds. Some defects are mild and do not affect vision appreciably, while others may seriously impair vision or even terminate in blindness.

The following information may be of interest to Basenji fanciers who wish to preserve the good characteristics of these fine dogs.

During the past few months we have examined some forty Basenjis of which twenty (50%) had abnormalities of the cornea, the iris or the anterior chamber of the eye. The abnormality consists of residues of embryonic membranes on the iris, or bands of this membrane that traverse the anterior chamber and insert on the back surface of the cornea where a scar may be found. Sometimes the defect is limited to tiny star-shaped scars of the cornea. The two undepleted litters we examined, all dogs were affected. There is no indication at present that this condition could be due to environment. The origin of the dogs studied and their relationship suggests a dominant inheritance. The condition is congenital and

severely affected dogs usually are recognized soon after the eyelids open at 10 to 14 days of age. For the detection of slight abnormalities, the pups should be examined after they are six weeks old.

It is possible that the defect is presently restricted to only a few dogs or to dogs in limited parts of the United States. No estimate about its frequency is possible at this time. Obviously, all breeding stock should be examined to determine whether the dogs are affected or not. As a rule, special instruments are needed to see slight abnormalities. Magnification of 40 or more diameters is required for study of the cornea and iris, and the use of a slit-beam such as provided by modern biomicroscope is indispensable to identify affected dogs. Since mildly affected parents seem capable of producing severely affected pups, breeders should realize that the greatest care is needed to identify dogs with defects only visible with high magnification.

Once Basenji breeders are aware of this hereditary abnormality, it remains for responsible members of the fancy to mount a program designed to eliminate this threat.

Failure to take remedial steps at this stage may create a larger pool of affected breeding stock and render the problem more difficult to control in the future.

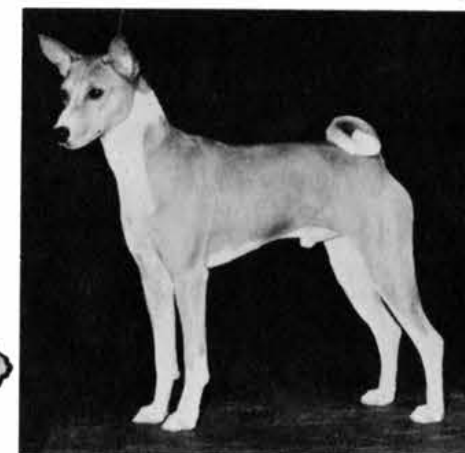

And his currently most famous offspring, CH. ANDERSLEY ATLANTIC (Ch. Kingolo x Andersley Gold Coin of the Congo), also made the list. He now has seven.

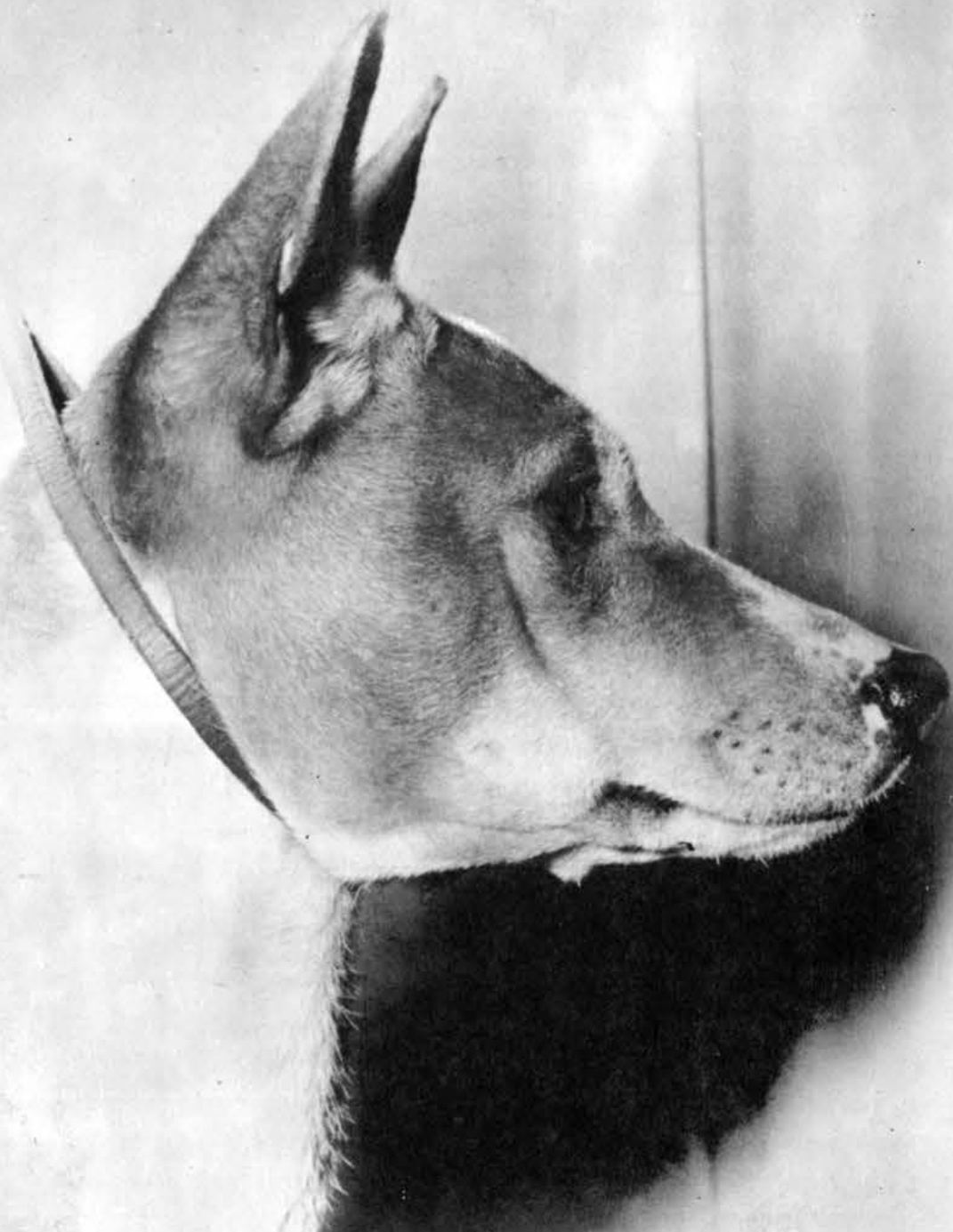

EASTERN PARTY LINE

by Shirley Chambers

Our series of answers to the questionnaire that was sent to all judges has ended. In compiling the final statistics we find that a total of 35 answers were received. This, perhaps, gives us somewhat of an overall picture of what most judges prefer in our breed.

Question #1 was the most controversial. Nearly all judges felt that both type and soundness were of the greatest necessity - combined, and that we should understand that we should strive for perfection in BOTH - neglecting neither. However, in final comparison, about 85% felt that type should take precedence over soundness, as a dog must first look like a Basenji to be considered as one - and "any mongrel can be sound." We, as breeders, must keep in mind that type and soundness should not be separated.

Most judges were in agreement that a Basenji, as well as any other breed, looks better and can be more easily assessed when gaitting on a loose lead. About 75% preferred a moderate gait, while the balance preferred a "sharp" or fast gait.

All judges stated that coat color did not affect their decisions - that is, there seemed to be no prejudice towards reds or tris. About 50% added the comment that whether red or tri, they liked to see a good rich color.

Only four judges felt that they might like to see the open classes divided by color, while the others thought there were not enough entries to warrant a separation, unless perhaps at a Specialty Show.

Also, all felt that they had not seen many Basenjis with either too much or too little white. Two stated that they had seen extremes in both cases.

It was unanimous that temperament and showmanship, particularly temperament, affected their decisions. Most felt that coat condition affected their decision since it would signify the health of the dog. Several pointed out that the time of year should be taken into consideration, since some Basenjis tend to "blow" their coats after the colder months.

Fifty per-cent of the judges claimed that they had

not seen much difference in size. The others were widely divided in that some felt there was too great a difference and about 10% felt that they are tending towards getting too large. No one felt that they had seen any too small. I particularly liked Miss Veronica Tudor-Williams answer to this question as printed in the April 1966, issue. Only six of the judges felt that there should be a definite size disqualification. Most realized the problems that would be encountered and that little would be accomplished by it.

The most important suggestion for improving the breed was that we should continue to improve the temperament. This was also listed as one of the most serious faults. Several judges, during the past months, offered some very sound advice and it would behoove all of us to reread their answers from time to time. I was most impressed by Mr. Ernest Goodman's "general" set of rules, as presented in the March 1966, issue. These are some of the most wise, and most sensible basic rules to follow, and should be remembered by all.

There did not seem to be any one common fault that any great number of judges felt was prevalent - other than the temperament problem. Next in line was the fact that we might be losing the expression and good wrinkle that is so necessary and stamps our breed. Also, movement was mentioned a number of times. We seem to be losing the free moving stride and some tend toward a more stilted gait. Coarseness and heavy bone were mentioned by about five of the judges, and about the same number felt that topline could be improved and that we should strive for better feet. In the minority, mentioned by only 2 or 3 judges, were poor pasterns, bad angulation, bad mouths, poor tails and tail sets, light eyes, and straight shoulders.

On the whole, all judges agreed that Basenjis have improved greatly in the past few years in both type and temperament and they are quite pleased with the improvements, which should be gratifying to all breeders.

We hope, by this series of questions and answers, that an un-biased look at the Basenji world has enlightened some and will be of benefit. In the future we hope to send a similar type of questionnaire to breeders. We welcome suggestions or ideas concerning questions to be asked.

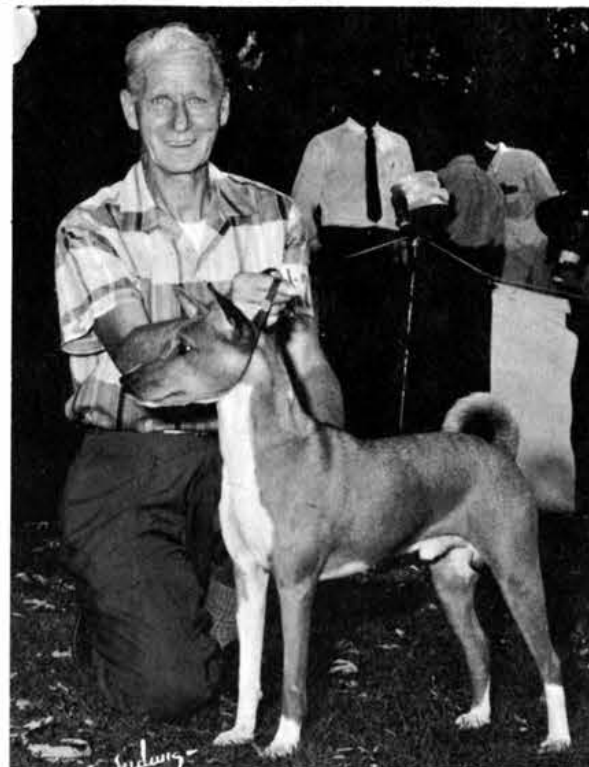

been our constant companion, following us from room to room, and sleeping with us at night. At first, he was quite reserved with our daughter but always gentle; he would simply walk away from her when he'd "had enough." In time he became protective with her and now is not content unless he accompanies her to play in the yard.

In June, we experienced a severe storm and Bomber's reactions were truly Basenji-like. Since he dislikes dampness intensely, the rain-wind combination caused him to balk at going out. He refused until one of us went with him, then looked at us as if to say, "Well, if they can stand it out here, I guess I can too," and he dutifully trotted out into the elements, looking back to make sure we were still there, getting as wet as he!

Patience is the key, and we encourage readers in buying an adult dog to give them much love and affection so they will feel secure in their new home. For the first month it is important that the grown dog be the focal point of the family, as in the initial stages of transition he is naturally unsettled, restless and fearful of another shift in locale. Crate trained as a pup, our dog uses his often as a resting place, and his haven when we leave him alone in the house for brief periods.

We have had no problems with chewing or temperament, but we feel we have an exceptionally fine dog.

For readers who prefer purchasing an older dog, we find that they can adjust as totally to their new surroundings as a pup. Puppy or adult, Basenjis are truly wonderful, as is this publication which allows us "doggy lovers" to share Basenji news each month!

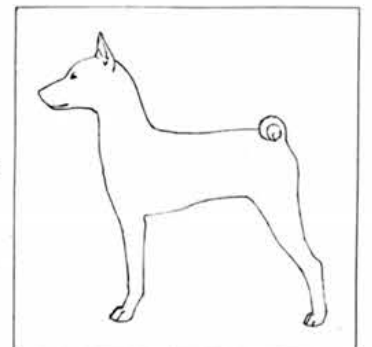

Caution - Customers Ahead

After six years in the Basenji "business," we'd like to share some of our ideas on screening prospective customers for your barkless babies. It pays in peace of mind and good public relations for the breed. I think most experienced breeders and owners agree that not everyone should own a Basenji, so I'll concentrate on the ones who shouldn't.

Families who want a novelty and status symbol, especially those who are strictly interested in the quietness and cleanliness. Many people really think Basenjis are completely mute, do not bite, and never track in mud. The Basenji is, after all, a dog and not meant for these "stuffed animal" people.

The prospect who talks only of "getting his money back" by breeding. Show this one your expense account on dogs and he may decide to raise

chinchillas.

Doting parents who calmly watch their offspring give the pups a thorough mauling and kicking. Try to be diplomatic and say a prayer for the luckless animal who falls into their hands. (Yes, we have a small child of our own who sometimes mauls the Basenjis, but we don't watch it calmly.)

The household where everyone wants a dog except mama. Since she undoubtedly will be with the dog all day, and will have the bulk of his care, there is trouble ahead for the pup. This type usually has delicate, expensive furniture and equally delicate nerves. Don't count on the pup tugging at her heartstrings. He'll probably tug the couch first and get a one-way ticket to the animal shelter.

Parents of teenagers who have waited until the children could take care of their own dog. A typical teenage schedule these days requires a 25 hour day and the dog may never see his young master or mistress except at meal time. Make sure that somebody in the family has time for the training and loving that every Basenji pup needs and is entitled to. These families have had many years to form a schedule of living that does not include a dog and sometimes the pup never finds a place in that schedule.

You're probably wondering what the perfect Basenji customer looks like. He comes in a beat-up station wagon or a Cadillac, with children or without, in an apartment or on an acreage. He asks lots of questions before and after he buys the pup, and he usually makes several visits to see him before he makes his purchase. He THINKS about the living creature that will be a member of his family. Most of all, he truly loves dogs and he has a large amount of patience. In fact, he's apt to be so interested in his breed that he's reading this magazine and thinking how nice it would be to own another Basenji.

HELPFUL HINT

If you have a fence-jumping problem (with your Basenjis, or the neighborhood Romeos) and have a wire or chain-link fence, try this: Get wire edging that is used around flower beds, about 12 to 15 inches in height. Wire this to the top of your fence, but wire it loosely so it will be somewhat wobbly and bend it at a forty-five degree angle. If you have dogs jumping in and also jumping out, you'll need the edging on both sides. This is neither unsightly nor dangerous to the dogs or children, and it works for the most determined dog of any size.

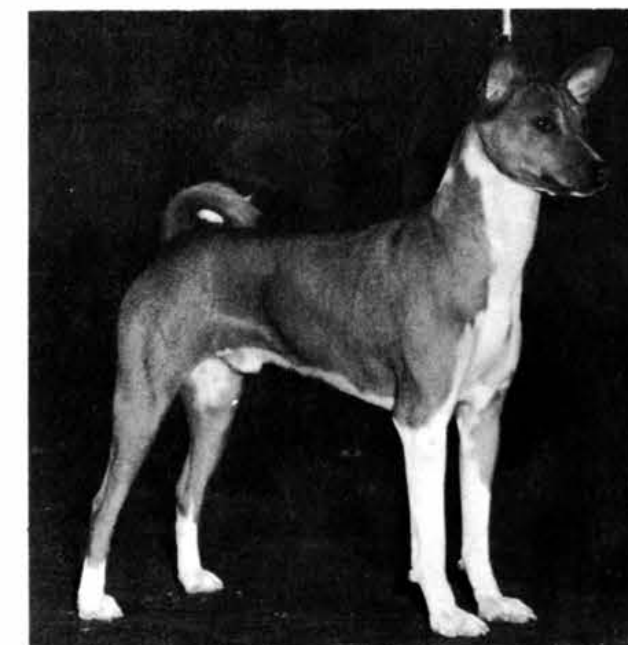

individually, or if they do, one finds themselves gaiting toward
the back of the judge's head or body! Still other judges don't
feel like leaning down and will order the dogs on a table! This
is unusual in Basenjis as they are not used to going on tables,
so the handlers find themselves at a definite disadvantage.

Have you ever shown under a judge that acts not only
bored, but has the attitude that you are annoying him with your
presence? Even if you win (and we have) you walk out of the
ring with much of the joy and excitement gone, since he made

you feel he had to put someone up, and the sooner he does it,
the sooner he can get out of there!

But not all judges are like the ones mentioned above.
I've shown under judges that left me feeling satisfied, even
when we lost, and I'm sure you've had the same pleasure. They
took their time, gave you the impression that they not only
enjoyed their work, but appreciated your entry.

We need more judges like this, we need new judges,
young blood. Support them, since they are the pot of gold at
the end of the rainbow.

As most of you know, Mrs. Helene Vaughan, formerly of Honolulu, bought KINDU and KASENYI many years ago and brought them here. In looking over old pedigrees the other day, I found one in Mrs. Vaughan's handwriting where she indicated that Kindu was the female, and Kasenyi the male! I immediately checked Miss Tudor-Williams' basic pedigree charts in her book, and she has Kindu placed as the male, however the picture shows the female on the left, and the male on the right with the caption, Kindu and Kasenyi which would lead you to believe Kindu was the female and Kasenyi the female. I wonder if all the hundreds of pedigrees typed from this basic breeding pair are wrong?

With KURO CHAN'S present litter, born May 5th, I have found two "ah-hah" items that everyone else may have tumbled to long ago.

I noticed the new pups were slipping on the newspapers in their nursing box, and by whim I bought several crib sheets at the dime store. The pups got a far better footing on these, and the sheets are easily washed in the machine. I had also bought a pair of crinkled plastic curtains for the lanai window which were much too long. After cutting them, there were two good-sized pieces leftover, and I tried these in the nursing box; of course, they didn't absorb the moisture like the crib sheets, but they worked well. I really believe this coarse surface allows the pups to get up on their feet earlier in life.

The other discovery is on feeding mama and the pups. On all six previous litters, I used cow's milk both for the dam and her litter. And everytime there was a problem of diarrhea. I mentioned this to Julie Fulkerson and she wrote recommending a milk substitute (Esbilac, in this case) which has brought both Kuro and her litter along with none of the problems of loose stools. I can't say enough in favor of this substitute.

At 30 days old, Kuro's pups are completely ambulatory. When the sleeping box is first opened in the morning, they tumble out immediately to their run and perform the necessary relief acts. This astounds me, as before I have had a mess to cope with after the pups were closed up all night. Kuro stopped sleeping with the pups at three weeks and re-entered her rightful domain in the house.

She feeds her "kids" about 8:30 at night, and nothing stirs until 5: the next morning. This too, is a switch from previous litters, but of course, I am not sure if this is due to the changed feeding program, or if these pups are simply adapting more rapidly than others to a schedule that allows everyone in the house a fair night's sleep.

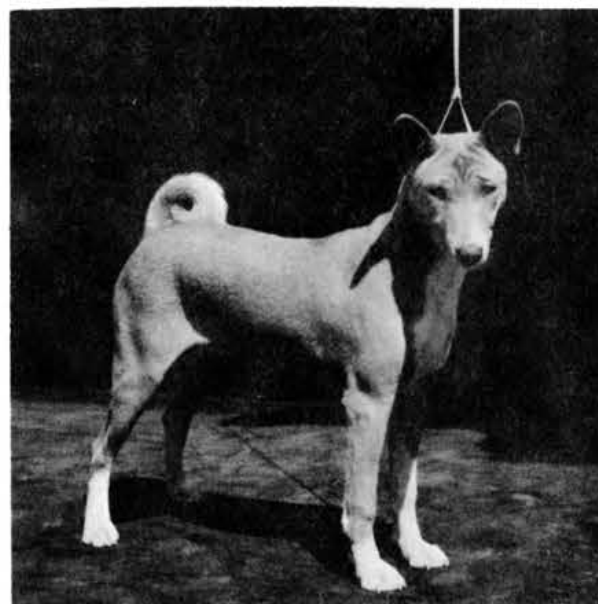
