




THE JUNIOR WARRANT

by Ernest Goodman, our British Correspondent

I have previously given outline details of the procedure involved in making up a champion in Great Britain. Readers will have gathered that this is the equivalent, in American terms, of gaining three majors under three different judges in competition with both specials and non-specials, in entries on an average of between 15 and 40 Basenjis of the same sex, drawn from the whole of the country.

There is, however, another award in Great Britain which, though perhaps not so important, is certainly much sought after, can give a cachet to the dog that does not gain his title, and therefore is to some extent a compensation for the rather tough requirements involved in seeking the title of Champion.

This award is called the Junior Warrant, and is related to the number of first prizes in breed classes gained before the age of 18 months. A total of 25 points must be amassed, three points being awarded for each first prize in a class confined to the breed at championship shows where C.C's. are on offer, and one point for each first prize in a breed class at an open show, or a championship show with no C.C's. on offer. (Readers will remember that the number of pairs of C.C's. available to any breed during the year is related to the number of registrations in that breed). Wins in variety classes, i.e. in competition with other breeds, however important or difficult to achieve, do not count.

To some extent, therefore, the ease with which a junior warrant is obtained will depend upon the number of shows, both championship and open, at which breed classes are scheduled. In breeds like Miniature Poodles, for instance, breed classes are provided at virtually all such shows. There will, of course, be many more animals competing for the award, but there is not a direct proportional relationship between registrations and average class entries.

There are, as would be expected, a number of sideeffects of this award. It obviously encourages exhibitors to show promising dogs as early, as frequently, and in as many suitable classes as possible, thus adding to competition and also to the class entries and therefore to the success of the shows.

A negative effect, however, is suggested by some breeders who feel that the award sometimes leads exhibitors to campaign young stock before they are ready for the show ring and to affect them adversely through the strain of too frequent showing. A certain inequality also arises from the fact that some breeds mature much more quickly than others and are therefore ready for serious competition earlier. Basenjis tend to mature early, and therefore it is not unusual for a Basenji to gain his junior warrant long before he is out of puppy.

In spite of the dangers, I have a strong feeling that until the conditions for making up a champion are made easier, and there are no signs that this will happen in the near future, the junior warrant will remain.

Basenji registrations over here, as recorded by the Kennel Club, totalled 237 for 1965 as against 219 in the previous year. There are 44 breeds with fewer registrations and 65 with more. Thirteen pairs of Challenge Certificates have again been allocated for 1967,

twelve of them to general championship shows, and one pair to the Basenji Club of Great Britain. The 1966 championship show of the B.C.G.B. is to be held in London on the 30th of July next. I consider it a great honour to have been elected by the membership to judge this premier show of the breed, and will ensure that a full report is sent to the Editor in time for the September issue.

Dogs of the Pharaohs

from Lloyd H. Curlee, 1803 Fernwood, Odessa, Texas 79760

The following extract was taken from the book, "Old Africa's Last Secrets" by Lawrence G. Green and published by Putnam and Co., Ltd. in 1961.

My friend, the French doctor, was responsible for showing me one of the strange dogs of the world. I had passed it by as a mongrel of the Belgian Congo. "Regardez le Basenji," insisted the doctor, "there indeed you have a mystery, a relation of the Eskimo dog in the Congo forest."

I observed a coffee-coloured dog the size of a Terrier, wearing a most amusing look of perplexity. Above the network of wrinkles on the forehead were large foxy ears. The muzzle was sharp, the eyes hazel, the small tail curled. "One of the oldest breeds on earth" said the doctor, "old in Africa but new in Europe. You would have a hard job to discover one in Great Britain or France."

That was more than thirty years ago and even now the barkless Basenji is rare outside tropical Africa. I last saw one when I was hunting in Angola just before the war. One of the Kuangari trackers, leading me in search of reedbuck, had a beautiful chestnut and white Basenji with him. I had not expected to see one so far south. In the deep forests of the Congo and Angola, tribesmen use the Basenji for detecting game, driving small buck into nets or chasing them from cover into open country. Basenjis will also tackle the fierce long-toothed twenty-pound reed rats which the natives eat. A Basenji will scent its quarry at eighty yards. The Basenji often carries a little wooden bell or rattle when following game in the bush so that it can be located by the hunters.

Basenjis have never become so common in savage Africa as to be worthless. A native hunter in the Congo will give a dozen good spears for a well-trained Basenji, some wives cost less than that.

Basenji means "wild thing," natives call it "M'bwa M'kubwa M'bwa," (jumping up and down) from their habit of leaping in an effort to see over the elephant grass.

Of course, the Basenji is not entirely voiceless. No one knows why any tame dogs started barking for all dogs in the wild state are barkless. They may whine or howl like a jackal, or growl like a wolf, but the bark is a sign of contact with mankind and Basenjis have been known

to bark. He gives out his typical plaintive yodel or musical crow.

I find the barkless Basenjis fascinating, on account of the mystery the French doctor mentioned to me, "a relation of the Eskimo dog in the Congo forest." Was it possible? I made enquiries in many quarters and confirmed the statement. Baseniis belong to the Spitz or Pomeranian family. Perhaps you know that the four earliest breeds were probably the Pariah, the Spitz, the Greyhound, and the Mastiff. One cannot be absolutely confident about the origin of the dog - some authorities say, the people of stone-age Egypt domesticated a jackal and produced the Spitz, others say that all dogs are descended from the northern wolf. African natives will often tell you that their hunting dogs are derived from foxes but there is no supporting evidence. Dogs breed easily with wolves and jackals, but a cross between a dog and a fox has yet to be identified; similarly, the hyena is in no way related to the dog. Whatever may have occurred many thousands of years ago, it does seem that the Spitz inherited certain jackal characteristics, when it whines or yelps, the similarity is remarkable and anatomists claim to have discovered many points of resemblance between jackal and Spitz skeletons. It is clear that dogs of the Spitz type were carried by navigators from Egypt during the stone age and presented to the barbarians in Europe. My authority is Obermeier, who excavated so many caves, etc. He found evidence in Europe of an Egyptian jackal-type dog which was the prototype of the Spitz and from which the Terrier was derived. Other members of the family are the Eskimo Husky dog, the Samoyed from Siberia, the Scandinavian Elk-dog, the little Schipperke of the Dutch barges, and the Chow-Chow. Examine them closely and you will see they all have the unmistakable tightly curled tail.

Further evidence of the Egyptian origin of the of the Spitz and his descendent, the Basenji, has been found in the tombs. Egyptian artists painted dogs very like the Spitz six thousand years ago. Pictures of Basenjis, wearing jewelled collars and led by dwarves, were found in Tutankhamen's tomb. A Basenji of the fifth dynasty was

found embalmed and perfumed and wrapped in fine linen, evidently a dog of the Egyptian royal household.

It is possible, of course, that the first Basenjis were tamed far down the Nile and brought to the Pharaohs as gifts. When the Basenji died out in Egypt it survived in the lands of the equator and is now only really at home in the great equatorial forests, where it is valued as a friend (and eaten as a delicacy) by many natives. African Basenjis have short, smooth silky coats and those with reddish hair shine like burnished copper under the sun. They become acclimated in Britain and America (like their ancestors in the Arctic) and soon grow winter coats.

Dogs have changed enormously since the small carnivorous mammal, MIACIC, the ancestor of the whole canine tribe, first appeared forty million years ago. Selective breeding has created suchdramatic transformations that a dog may bear little resemblance to his forbears of half a century ago. Yet, in spite of the changes in other breeds, the Basenji remains unchanged. It lived for centuries hidden in the Congo forests and flourished when the glories of Egypt faded. And when it was rediscovered within living memory, it was still the dog of the Pharaohs.

I am grateful to the observant French doctor who knew Africa so well, and did not allow me to miss the Basenji in his forest home.

The following questionnaire was sent to all judges who are licensed to judge Basenjis. This month ends the series of answers which started in the November 1965 issue. Next month, I will try to write a summary from all the judges' answers so we will have an over-all picture of what the judges' prefer and look for in a Basenji.

The questions:

- 1. Do you consider basic soundness more important than over-all type?
- 2. Do you prefer Basenjis to be shown on a loose lead, and do you prefer a slow, moderate, or a fast gait?
- 3. Does coat color affect your decisions that is, shades of red or red versus tri?
- 4. Do you think that the Open Classes should be divided by color, with separate classes for reds and tris, and do you feel that some Basenjis are too copiously marked with white, while others have too little white?
- 5. Do you consider temperament and/or show-manship an important factor in selecting the winning dogs? Does coat condition affect your decision?
- 6. Do you think there is too much size difference in Basenjis and is this (size) an important factor in your judging? Do you think there should be a definite size disqualification?
- 7. Do you have any suggestions to the breeders that you might recommend to improve the breed. What do you consider to be the breed's most serious fault in the ring today?

We want to thank all the judges for taking their valuable time in giving us their opinions on our beloved breed, the Basenji. We are indeed grateful.

Our last four answers in this issue are all from judges of England. Our first from, A. W. Fullwood, Esq., Leeds 4, England.

- 1. I consider combined basic soundness and overall type.
 - 2. I prefer shown on loose lead, and fastish gait.
 - 3. No, coat colour does not affect my decisions.

- 4. For preference, Open Classes could be divided, and some white markings vary.
- 5. Temperament, and showmanship, and condition are my deciding factors.
 - 6. And standard size is a factor to me.
- 7. Hind action, I strongly adhere to. No, I am not a subscriber to any magazine to any breeds, strictly to standards of our over 60 years of judging.

Our second answer this month is a quicky from W. N. Bradshaw, also from England.

- 1. No.
- 2. Yes. Medium gait.
- 3. Type does not just mean colour.
- 4. No.
- 5. Yes. Yes.
- 6. A Basenji is as big as it looks.
- 7. Action

Our third judge's answer is from Barbara Percival, well-known judge and breeder of the Syngefield Basenjis.

- NO it is no use having a sound dog if it is not typical of the breed.
 - 2. On a loose lead yes. A fast gait.
- I do not mind if Basenjis are red or tri-colour, but the colour must be good. I do not like sandy shades of red or dirty black.
- 4. I do not think the Open Classes should be divided by colour I do not mind about the markings as long as it conforms to the standard.
- 5. I consider temperament <u>most</u> important and it does affect my decision-showmanship is a help but not so important, especially in the lower classes.
- I have not experienced much size differential in Basenjis when judging but would disqualify any if two inches either way different to the standard.
- 7. I think temperament needs improving the most serious faults, in my opinion, are straight shoulders, low set tails; pigmentation also needs watching. There are too many light eyes and pinkish noses.

Our last, but by no means least, judge's answer is from Herbert Essam, also from England.

1. This question must depend on two factors, the degree of unsoundness, and how far removed from the breed standard.

The writer feels that a goodly percentage are to some extent unsound, standing, and on moving. This is so of all breeds, but in Basenjis it is more easy to assess, for they have no long coat to hide these defects. I would, if I may, hasten to add that your beautiful breed is one of the soundest in this country and offers no real problem. Now with regards to type, one must endeavour to get as near as possible to the standard, and I imagine it would be absolutely wrong to place an exhibit that is far removed from the standard at the top of the class. Even though it is soundest on view. That, may I suggest, must depend on the merit of the judge. He must be able to appreciate both (continued on page 9)

Traveling With Our Basenjis

by Wanaka Peters - R Bar W Basenjis

Our first dog, a Pomeranian, was in her first show in 1932. That was in the days when dog shows were held at state fairs and 4H Clubs. We won the blue ribbon and were so very proud.

Mr. Peters was with an oil company and during the depression we were shipped to a trouble spot every time they pulled a pin from the map. We were sent to Omak, Wash., during the bank holiday and had to live for eighteen months in one room in the hotel. One couple, one child, and one dog which was the darling of all comers. She sat under the table in the dining room when we ate, slept in front of the huge fireplace which, at times, was the only heat in the whole hotel. When she wanted out in the morning we let her out into the hall; she'd go down to the lobby and wait at the door until someone let her out, wait outside until someone came in and back up through the lobby, up the stairs and to our room. Even then we were firm believers in good training.

Several years later I was in Tacoma, Washington, trying to cash a check on a Saturday afternoon - knew noone - times were still bad and the banks were closed for
the week end. In a drug store a man stepped up and told
the druggist. "I'll vouch for her - she does not know me,
but I've watched her, a small child, and a little yellow
dog, many times in hotel lobbies." He was a cosmetic
salesman from Philadelphia and said he used to watch that
yellow dog and wished his little girl had one like it.

I've told you this just as a preface to traveling with Basenjis. We've had many dogs over the years, many of them show dogs and they have all traveled with us. But traveling with Basenjis is something else again - they cause more comment-people show more interest. During the past eight years we've traveled approximately 60,000 miles a year for our company. Many of these miles have also been covered by our three adult Basenjis, BWANA, FULAFAY, and COSSET OF THE CONGO. They are welcome in all but one hotel, the Fremont in Las Vegas. This hotel allows no pets of any kind. Most hotel and motel people are happy to have well trained dogs. Some go so

far as to say they'd rather have dogs than children. Ours have been taught to go to the back of elevators and sit down until told to come. They will sit on street corners for red lights. People wonder if they could see the red turn to green, but we know the dogs have been trained to sit when we stop and go when we give a slight tug on the lead. Many people think walking three Basenjis in traffic cannot be done.

Only once did I have any real trouble. In Tucson, Arizona, we passed a blind boy with a German Shepherd and an accordion. I had Bwana along and he made a jump at the accordion - probably because it hurt his ears. The doorman at the Pioneer Hotel grabbed him and put him into the lobby and said, "Boy-dog, that music gets on my nerves too."

When we first got the dogs from England, Bwana did not like colored, Indian, or Mexican people. We have many of them in Arizona so we just took him for walks and had every little child pet him. Now he loves them all. We had a feeling it was a matter of odors. We, of the desert, do not smell of Lavender, Pear's soap, or London fog.

One time in Carlsbad, New Mexico, the dogs jumped out of the refrigerated car onto the hot sticky asphalt and we had to treat blistered and burned feet on that trip. Another time our veterinarian had recommended lean raw meat and the stores were all closed in El Paso, Texas, with the exception of a drive-in market. I picked frozen cube steaks, selecting those with the least fat and the clerk told me the ones with fat had the best flavor. When I told him they were for our dogs he looked as though I needed mental help.

Another time we were walking on the street and came to a rather large colored woman standing on the curb. Bwana took one look at all that nice shade and laid down and would not move. The colored lady said, "Let him be, honey, he knows shade when he sees it." I was afraid she'd be offended.

In Clovis, New Mexico, Bwana and Toots snatched a sparrow out of the air. I had on a white knit suit and had never known how much blood was in one little bird. I was miles from home - had no other outfit to change to and I (continued on page 11)



of these points, and then assess them in accordance with their deviation from the standard.

- 2. Personally I like them on a loose lead, for usually, when handled on a tight lead, it is an endeavour to hide bad frontal movement. I should say a moderate gait, for it permits an easier assessment of movement.
- 3. Not really, a good judge should learn to appreciate the competitors in accordance with the breed standard, not his own personal ideals.
- 4. I do not feel that in open classes colours should be separated, this would be uneconomical, for in this country an average entry in the open class would be about eight, but it would certainly be a good point of interest at a club championship show, also at Crufts, for there the entry would justify the added classes, and thus provide more interest. This is what happens in Cockers.
- 5. Temperament and showmanship must be an important factor in judging of dogs. For an exhibit on his toes, proudly showing off his many attributes, must have more appeal than the one that shivers on his stomach with his tail between his legs. Coat condition must be taken into consideration in final assessment, for an unhealthy specimen must lose appeal in a battle of outline and beauty.
- 6. I don't think the question of size gives too much apprehension in this country for they generally appear to be fairly standard in size here. Naturally size must be taken into consideration for there is a suggested standard of dogs 24 pounds and 17 inches, bitches 22 pounds and 16 inches, one gets used to judging to these standards, and I cannot imagine any serious wander from these measure-
- 7. Lack of length in neck, too much length in body. Light eyes, bad mouths, heavy bone. Imperfect tail and tail carriage.

I know that Rusty would have been killed had he not been in his crate.

The first A.K.C. Sanctioned Basenji match in the East was held on Sunday, May 29, 1966. The match was held at the home of Bill and Ruth Hill in Tallman, New York, and was a tremendous social success. puppies; 1 male and 4 female adults present.

Below are some of the general comments on the dogs by the judges and some of the breeders:

In general, the quality of the tri-colors was better than that of the red and whites at the match. Most of the Basenjis were in very good coat, had good wrinkle and were quite alert. The major criticism seemed to be that many were too long of loin, and most of them needed more ring experience.

The puppy Best of Breed, AQUIA'S JACK OF SLEEPY HOLLOW was a lovely tri with short loin and a level topline. He was showy, moved well with the proper reach.

The adult dog, ROSE-BAY'S GAY RINGLEADER, the only adult male at the match, is a stylish, well marked red and white, and is very flashy.

The adult Best of Breed, HENTY P'KENYA'S CORISTA, was the best quality red and white at the show according to the judge. She is short of loin, good topline, and generally sound and quite elegant.

The best competition was among the puppy females where FETTY'S T-INKER BELLE OF BOMAR wound up as Best of Opposite Sex. This is another flashy tri. She is a gay mover with a long neck, and is quite a responsive showman. Second in puppy female was AQUIA'S DIXIE BELLE, a well marked red and white with high set little ears and good wrinkle. Third was KHAJAH'S MIDNITE AMBER, a very sound 3 month old tri, with exceptionally short loin and good tail-set, feet and topline. This young pup has much promise. Fourth place went to another tri, KASAI'S DARK BRANDY, with a beautiful coat and markings.

Everyone was happy with the judging and the experience acquired, and a good time was had by all. An especial thanks go to the neighbors of the Hills - Mrs. Walter Naumann and Mrs. Martin Walles, who helped in selling coffee and soda, and to Mrs. Clora Bradley, who came as an exhibitor and performed invaluable assistance in taking entry fees and admission fees. Thanks too to Dr. Martin Abelson, who talked everyone into buying rore and more raffles, for their own good, of course. 

"WAGGING TALES FROM NEW YORK"

Where will it stop? The cruelty, mistreatment, and petnapping? Unless pet owners and breeders "see the light" and take better precautions to protect their pets, or new laws are passed by congress, never! Open your eyes and realize that right in your own home town there are unscrupulous people who go around collecting pets for the purpose of resale to research laboratories.

I'm the first to admit that research is necessary, but under no circumstances should stolen pets and those obtained under false pretences be used to this end. True, if there were no research labs, the dealers supplying them would soon be out of business. However, there is research, and now only you, the breeders and pet owners, can protect your animals from such dealers.

How do they operate? Strays are their easiest prey. By the time the neglectful owners realize "Lassie" hasn't come home and start to check, all traces of their pet have been wiped clean. How often have you, as a kennel owner, left your dogs protected only by a fine mesh fence that could easily be cut with wire cutters? Some dealers operate by painting their trucks the same color as that of the local S. P. C. A. to throw off suspicion.

Breeders are often the target through their ads in their local town paper, advertising a Basenji to someone willing to give a good home to a retired brood bitch or stud. While it is true that the younger dogs may be preferred since the average going price is \$1 per pound, the older, often heavy dog will do in a pinch.

Through a weekly pet column that I write, I have advised local pet owners to use the following contract when placing a pet:

- a) Party receiving the dog promises to give it a good, loving, healthy home life.
- b) Under no circumstances is this animal, described in full as to sex, color, size, and breed, to be given or sold to research dealers or laboratories.
- c) Party is not to give the animal away or have it put to sleep without first notifying you.
- d) Take license number and address of the party directly from their driver's license. Both you and the party should sign this agreement along with the date of the signatures. Give the party a carbon copy, keeping the original for your files.

Maybe this won't stop the dealers, but it will certainly slow them down and make them think twice. Lack of proof has always been the biggest obstacle to authorities. Keep in mind that the legitimate pet seeker will not object to signing this contract so if he balks, beware!


