# ARCTIC CAPERS

In an effort to help those who, like myself, are really amateurs at this game, I am going to take a chance and offer a little service. (There is a chance that this will be completely ignored or that I'll be swamped.) If you will send me a pedigree of one (and only one) dog, I'll check it against my records and tell you the number of American champions produced by each dog named on the pedigree. The pedigree can run up to six generations.

This is NOT a pedigree service. That part you'll have to get for yourself. Don't count on getting it back immediately, either. I'll also tell you through what issue of the AKC Gazette the information is complete.

If you want to challenge my count, list the names of the American champions you think any one, or more of the dogs listed on the pedigree produced. I'll be happy to check that too. It is just possible that someone will catch me in a mistake. (The little erasers they put on the ends of pencils aren't big enough for me - I have to buy the great big erasers.)

At some point I hope to acquire a list of English champions (also Canadian), but this will take some doing. Right now I'm trying to make sure I have all the information currently at hand, catalogued correctly.

Looks like obedience is finally coming into its own in the world of 'senjis. The November issue of the Gazette listed five new CD title holders. That must be an all-time record. And one cannot overlook the new CDX listed in December. From my experiences, I sincerely hope that someone has discovered the technique and mastered it sufficiently so that others can be taught.

Of this much I am sure: The methods used on German Shepherd Dogs and Poodles just don't work very well with Basenjis. As in most things, we have a breed that is a law unto itself. And anyone who deals out rough treatment to 'Senj is just "cruisin' for a bruisin'." I haven't found one yet that didn't have a neck made out of case-hardened steel.

One little bitch we took through an obedience class really taught us a lesson. The instructor - a great big guy who could snap Shepherds off the ground with a snap of his wrists, was going to teach me to "down" my dog. He stepped on the chain and yanked one way, the Basenji stubbornly yanked the

Lie down when they were supposed to heel, leave the ring on "heel free," refuse to "stay," and any other mischief they could think of at the moment. Then leave the ring once more wear a perfect halo. Tell me they didn't know exactly

# A Judge's View of Exhibitors

by Ernest Goodman, our British Correspondent

Exhibitors pay to obtain the opinion of a judge on their dogs - judges are paid for the opinion. This in itself suggests that there is more onus upon judges than upon exhibitors to examine their proficiency of conduct. I am afraid, however, that this is offered sub-consciously as an excuse to themselves by some exhibitors who, in their search for prestige and success, fool themselves not to be bound by rules, particularly the unwritten ones, and look upon the show game as a matter of cut-throat competition and, let's face it, rather unscrupulous practice, where to beat the judge, and fellow exhibitors, by whatever means is the mark of the smart operator. Failure to succeed in this is then often compensated for by this type of person by denigration of judges, fellow exhibitors, and other dogs. While most people would agree that this kind of thing is a sign of emotional and moral immaturity, it does exist, particularly in the case of exhibitors to whom dog-showing offers the only hope of shining, comparatively, in an otherwise indifferent world. Exhibitors who think in these terms choose to forget that they serve to debase the dog-game in the eyes of the outside world, and also create a situation in which not only other people's pleasure, but ultimately their own, is considerably reduced. Like any other worthwhile human activity, one derives the keenest and most complete satisfaction by the exercise, among other things, of integrity, restraint, dignity, good-humour, generosity of spirit, and a sense of service to the group.

It is against this background that I would like, briefly, to examine what judges are entitled to expect from exhibitors. I hasten to add that anything I write is set against the background of exhibiting over here, as I know that the American scene is different in a number of particulars. For instance, we do not assume that a judge is possibly drunk or has his judgement impaired if he has a few beers during his judging stint. There is, however, I am sure, a great deal of common ground.

Firstly, a judge expects that exhibitors will not publicly pre-judge the results of any show at which he is judging. If he has consistently shown himself to be grossly biased, I don't suppose he can complain if this happens, but I have known the prophets to be wrong more often than not, and talk of this kind can affect and prejudice other exhibitors unfairly, particularly the inexperienced ones. At it's worst, of course, it constitutes slander.

A judge also expects that exhibitors will respect his right to differ from them on the relative importance of faults and virtues without being dubbed incompetent.

He has a right to expect, in and out of the ring, that exhibitors will treat him with the same courtesy which he displays towards them.

He expects that exhibitors will pay him the compliment of presenting their dogs for his inspection in the best possible condition of what they are capable, and particularly clean!

He has a right to expect exhibitors to be punctial in the ring, and once there, to carry out explicitly, any legitimate directions given by him, without visible signs of impatience, irritation, or rancour.

He should be able to expect that exhibitors to not present for his inspection, dogs which are dangerous to handle, and if there is any doubt about this, that they will inform him.

He cannot expect exhibitors not to handle or move their dogs in such a way as to attempt to hide their faults or stress their virtues, but if he instructs them, for instance, to relax the tight lead, withdraw support from the tail, or stomach, or move at a different speed, he can legitimately expect such in-

structions to be carried out immediately and to the letter.

He expects that exhibitors will not improperly prepare their exhibits by surgery, forbidden applications of colouring or other matter, or in any other way, since for him to take action about this or draw attention to it publicly, is a most embarrassing and unpleasant business, to which he should never be subjected.

In this country, at any rate, he has a right to expect that exhibitors will not arrange to secure an unfair advantage, of which he may be unaware, by arranging for someone to attract their dogs and make them alert from outside the ring.

He expects that, although exhibitors have a right to ask him, after judging is over, his opinion of their exhibit; they will not indulge in comment or question upon other people's exhibits, since it would be wrong and unprofessional of him to comment to an exhibitor upon other people's dogs, particularly adversely.

Although a judge is entitled to a normal social life, and should not be suspect if some exhibitors who show under him are members of his normal social "whirl," he expects not to be embarrassed by offers of hospitality which would obviously not be forthcoming were he not a judge, and he has a right to be suspicious if undue attention, offers of judging appointments, etc., are showered upon him not long before he is to judge an important show. Although there are judges who are careless, if not worse, in their response to such situations, it is equally wrong and inexcuseable for exhibitors to put judges in this situation.

Finally, a judge has a right to expect that exhibitors will acquaint themselves with the simple rules of deportment, procudure, and ethical conduct in the ring - that they should never indulge in practices which might adversely affect the showmanship of other dogs, or take up the wrong place in the line-up in the hope, by confusing stewards or judge, of obtaining an advantage - in short, he expects exhibitors, having decided that he should be competent to judge their dogs, to behave like responsible, honest, courteous exponents of a worthwhile, creative human activity.

## MORE ON GROOMING

by Breeder and Judge, Diana Berry Bygrave, Baldock, Herts, England

I was so completely taken back to read "Grooming Basenjis" by Mary A. Gontarek, that I felt I must get the "tripwriter" out without delay - believe me, a terrific effort at this time of year with school holidays, Cruft's entry, wet weather, etc. Far too much to do forever.

I have always understood that the charm or one of the charms of the Basenji is that it never needs coat attention. In twenty-five years of keeping them, I have never had to do more than rub with a rubber glove for about three weeks when the coat is falling. I never bathe a dog from one year's end to the other unless they fall foul of 'something' in the fields as all my dogs hunt and can come in covered with mud, but this quickly dries and falls off as the dogs do NOT HAVE ENOUGH COAT TO HOLD IT. The only time I have ever chalked a dog is when it had to wait about on a concrete floor for the vet's inspection. My dogs are never crated or carried. And, as for using clippers on the dogs, there is nothing to cut off with the correct coat of a Basenji, as it is never longer than an eyelash - how can one cut that? Apart from the fact that it is breaking the Kennel Club rules to cut any dogs' coat except those on a very strict list, of which the Basenji is not on. The chestnut will gleam as it should without any cream if the dog is properly fed, and has lots of running. My dogs are never on a lead - some have hardly seen one until about twenty-four hours before the show. Only stupid dogs jib at a lead. I find Basenjis accept the lead within five minutes when old enough to understand why they are put on.

Hard baked marrow bones will keep the teeth clean, but I do agree that with some dogs that are lightfooted, they never wear their claws down, and will need cutting. All my Basenjis hate this, and I clip the nails as far back as I dare risk without cutting the quick and then file with a rasp.

The subject I laughed myself sick about was "Dear and Honey" by the Lukes, and the first page I read is "Poets' Corner," which tends to reveal the dogs better than any other

Someone said that in your country you think of Basenjis as all the same as other dogs - just read the last six months of this delightful page, and think again.

# California Crucible

"K-9 BIRDS AND BEES"

At the risk of sounding crude, I have decided to dwell on a subject that most people shy away from, the mechanics of breeding, and its side effects.

Due to the common interest we all share, most of us have been, or will be called upon to supervise a breeding. This act, the propagation of our breed, is an integral part of our hobby, and should be carried out with common sense, tactfulness, and good taste. Relatively, few of us have handlers, or kennel help to accomplish these tasks for us, so this is written for the majority of new Baseniites.

Much has been written about the care of the female after conception, but little has been said, describing the events before. Assuming the chosen female is in top physical condition, free from external and internal parasites, it remains for the owner to watch for the first show of color, signaling the advent of estrus. Prior to this, the owner should have located an acceptable male, and made tentative arrangements with the owner for breeding: later notifying him of the onset of estrus, and agreeing on the time to send the female.

Owners of only females who send away for service will escape the burden of responsibility of breeding. Their responsibility resumes, however, when the female arrives home as they must continue to guard against a re-breeding with another male for a time.

Determining the correct time for breeding is often a tricky task at best, and most dog books, dealing with many breeds, will place the ovulation period from the 6th to the 10th

day from the first show of color. This is particularly frustrating to the owners of the breeds which follow a somewhat longer cycle and ovulate considerably later in their cycle. Basenjis being one of these breeds.

From personal experience with my own females, and with others that have been brought to my studs for service, I have approximated the best breeding time to be between the 12th and 17th day after the advent of estrus. There are always exceptions to every rule, and breeding entirely by the calendar is a risky procedure. Other sign posts to the proper time is the change in color, and the amount of vaginal discharge. At the time of ovulation, the flow will subside somewhat, and will change from a bright red, to a lighter pink or orange, as tested with a tissue. The female's body temperature may also rise slightly from the normal 101.6, hence the term of "heat" which applies to the week, more or less, during her cycle that she is fertile. During this time the vulva will enlarge and soften, and the female will have developed quite an amorous state of mind. Some females also show their readiness by switching their tail out of the way when being touched on the rump. Her attitude towards the male should also be considered, however, with a first breeding or frigid female, her acceptance and affection will be non-existent to the point of nastiness, even though she is physically ready. Should the breeder wish to make certain of her readiness, he should take her to his veterinarian who will analize a smear of her vaginal discharge to determine if she is ovulating. As the ovum is known to live for 72 hours awaiting fertilization, there should be enough time left to consumate a breeding.

The actual breeding is a subject of some controversy, with each breeder believing his way is best. Some brave souls, noting the selected female is in season, will just kennel her (continued on page 10)

# SKIN PROBLEMS IN DOGS

by the Florida Veterinarians

Doctor, my dog has mange. This is a common complaint that Veterinarians hear frequently. Yet this disease is one of the less frequently occurring. The truth is that there are numerous skin diseases, many of which create the same symptoms, but which must be cured by different treatments.

The difficulties in treating dermatological disorders are:

First, diagnosis is often difficult, and even a well trained veterinary clinician frequently will have to rely on laboratory procedures to reach a diagnosis.

Secondly, there is no one drug for treatment that will effect a cure in all skin diseases or sometimes even in a single disease. One of the reasons is that even though many diseases look similar, the basic cause is entirely different. Another complication is that sometimes, particularly in chronic diseases, there may be multiple causes.

For example, shortly after a dog has picked up a few fleas, he may develop an itch and a redness to the skin. If the fleas remain long, the dog will start to lose hair around his tail and up the middle of his back. The oil glands become overactive and he often becomes allergic to the fleas. Due to loss of vitality, fungus and bacteria may invade the area. Now the dog has added to his simple parasitic dermatitis, allergy, seborrhea, fungus and a probably bacterial infection. Such puzzles as this often demand detailed histories, fine clinical art, proven scientific aids and time for a correct diagnosis.

There are skin diseases which will get well without treatment and many that respond to a variety of treatments.

There is no method of diagnosis or treatment which cannot be made more successful by the complete cooperation

of the client. For this reason we recommend some basic tenets to pet owners who truly want to help their animals:

- 1) Seek veterinary help before your animal becomes badly diseased.
- 2) Deal with your veterinary clinician with complete bonesty and objectivity.
- 3) Since many skin conditions are chronic and recovery is slow, be patient enough to allow your veterinarian to effect a cure.
  - 4) Follow his directions to the best of your ability.
  - 5) Never fail to be constructively critical.

Cures in skin diseases are always very rewarding to veterinarians. However, the basic approach to medicine is to prevent disease. One of the simplest ways to avoid some of the problems mentioned is to consult your veterinarian before purchasing a dog. I say this because some breeds of dogs do not adapt well to our environment. To purchase a member of one of these breeds is to invite trouble.

Once a dog is obtained, professional advice should be sought for the general feeding and care of the dog. Some breeds such as Cocker Spaniels and German Shepherd Dogs have an inherent tendency to have oily skins. These will require more bathing and less fat in the diet. Other breeds like the Poodle have inherently dry skin and will require greater fat intake and less frequent bathing. Also too vigorous grooming of Poodles can cause hair loss. The Dachshund is often a hyperallergenic and frequently may get hives if his diet is not properly regulated. Large short haired dogs are more likely to develop callouses unless provided with a soft place to lie.

Whether Rover has long or short hair, dry skin or oily skin, if you have him a month you'll be in love with him.

Following the basic tenets mentioned above will make him much more of a pleasure to you and help him to live a happy, full life.

We spent a most enjoyable couple of hours with Helene Vaughan the day after Christmas. Helene is here from California for two months. We scooped her up at her hotel in Honolulu and took her over the Pali to Kailua to meet the dogs. Helene had hoped I would have a red and white pup for her to take back to California with her, but alas, all our seven are tri-colors, and Helene won't go that route. I can't say I blame her considering the glorious burnished red coats that her KOKO CRATER dogs carry almost as a trademark.

We publish a monthly news letter, and we would be happy to exchange news letters with all other local or regional Basenji Clubs in the United States, Canada, or elsewhere.

with her intended mate, and let nature take its course. Others will wait until the date the female's appearance is right, and

then will confine her and the male in a small, private room for a period of time unbothered by any eager meddlers. These ways are fine and have probably produced many healthy litters with no ill effects suffered by either participant. I prefer to meddle and make sure things run smoothly.

I have found the best procedure is to select a quiet room with no through traffic, affording the least amount of distraction as possible. A large old rug on the floor or an abrasive cement floor will provide much better traction for the male. These are small things, but may mean the difference between a frustrated male, and a successful breeding. Exercising the two briefly before breeding may be of benefit. It is also best not to feed them before as they may become lethargic at a strategic time.

After several unpleasant incidents, the best way with most females is to muzzle them before breeding. There will be some breeders who don't agree with this, but have noticed that even the sweetest female could turn snappy during a time of stress. Assuming the male and female are ready, and the muzzle in place, I turn the two loose to romp around the room. Often the female is so busy working at the muzzle, the male is afforded the privilege of an unprotected rear, and can get on with things. If the female is determined not to hold still, I will calm and steady her while the male makes contact. I continue to steady her throughout the breeding as some females have the urge to dart about the room causing undo strain on herself as well as the male. If the owners of the female are present during the breeding, I prefer them to steady and calm her as she naturally feels better close to her loved ones. The position assumed by the male at the start of breeding is generally known by everyone and the proceedings up to this point are universally recognized. After the contact has been made, many unseen changes take place and it is a wise idea to have studied about this in a good canine anatomy book. After the tie is effected, most males will have the urge to turn around, facing away from the female. Considering his physical structure, this position is quite comfortable for him.

The male may not need to be calmed during the breeding, depending on his self control and experience. However, with first time males, they sometimes decide to flee the scene after the tie has been made, being flustered by the whole procedure. Others grow quite droopy and lazy and decide about midway through to lie down for a quick nap. If this is suspected before hand, it is wise to have a second person to steady the male

Most females will give vent to some vocalization during the breeding while others will become quite upset. The male and the female sometimes experience mild contractions as in birth. This is a very normal reaction and should not cause any worry. The length of time for each tie varies with each (continued on page 12)

## THE REGIONAL CLUB AND THE B.C.O.A.

At the recent Basenji Club of New England meeting at the Eastern Dog Club show, I was asked to express my views on the value of the regional club. Being caught off guard, I said little more than that some B. C. O. A. members thought it would hurt an already small national club, while others felt a real need for it. Now, my thoughts are more definite. Depending on the scope of activities, the regional club can either hinder or greatly advance The Basenji Club of America.

In some areas of the country, the parent club's activities must seem very remote and the regional club can serve as a basis for substitutes. The first object seems to be a social get together which can be achieved by anyone with some food and invitations. But beyond this, you have a need for some sort of organization - especially when the object is a match. So here is the value of the regional group: It can also attract novices who may want to associate with "neighbors" having a similar interest, yet not join a seemingly large impersonal organization. So, for getting people together, and running matches, it seems a fine idea: Greater Chicagoland Basenji Club meetings, are at times, of an educational nature and the New England group is considering the match as a means of acquainting the exhibitor with the judging aspect. The latter club shows how the local group can effectively organize a supported show on behalf of the parent club.

Likewise, the regional club can be a real asset in recommending national specialty sites and providing workers, should it be in their area.

Three things bear watching: First, that the club does

not become a special interest group whose main purpose would be catering to those who were at odds with personalities in, or policies of the parent club. Dues and newsletters are apt to pose problems too. The newsletters issued so far, look pretty ambitious. And they are soliciting ads. This, I feel, can only hurt OUR Club Bulletin and OUR independent The Basenji. It's the advertising dollar which enables them to get better quality paper, photos, articles, mailing, etc., and keep the subscription or subsidy cost down. Since the group may want some form of written communication, how about a mimeographed secretary's letter to all members? - with news or club business, but omitting features, ads, etc., which are not urgent and can be used to enhance our regular publications.

This could save the local club's money and efforst so that dues could be kept down to such a level that membership in both the parent and regional club is not costly.

I would like to congratulate the New England club on the way their meeting was conducted. Non-members were invited to attend and contribute <u>after</u> "new business" and before adjournment. This enabled them to act on anything suggested by a guest, yet kept discussion on club business limited to members so that things didn't get too prolonged or go far afield.

breeding, and it is generally assumed that if a tie is held for more than five minutes, sufficient sperm was released to culminate in pregnancy. Most ties, however, last considerably longer than that. Some breedings of less than five minutes that did not result in a tie, have produced puppies. This is caused by the male slowly releasing the semen in small amounts soon after entry, and continuing throughout the duration of the erection. After the two have separated, it is a good idea to place them in their crates for a light snack and rest.

The same disk jockey was sent a "doggy" calendar for 1967 with a picture of a different Collie for each month by the Collie Club of America. Nice idea Basenjites!



you must be aware of. Some say it will ruin a bitch's bone structure, top line, hind-movement, etc., and others say that it will tighten her top line, etc. What has been your experience? . . .

Splendor That was Egypt, but try the following pages, keeping in mind that there may be much more: page 169 "Mother of God, Lady of Heaven;" page 170 "Mother of Anubis," etc., "his death, burial, and resurrection."

From When Egypt Ruled the East, by Steindorff and Seele: "At a very early time indeed, the priests undertook to bring various of these gods into some relationship with one another. As a result, it not infrequently happened that a goddess was assigned to the principal god of the city as his wife, and a third divinity to the two of them as their son. At Karnak in Thebes, for example, the chief god Anum shared his worship with his wife, the goddess Mut, and their son, the moon god Khonsu; in Memphis, the tutelary god Ptah was given Sekhmet as a consort and Nefertem as their son; at Abydos, Osiris, his sister-wife Isis, and Horus "the son of Isis" constituted the "triad" or holy family."

This card (on the opposite page) is a result of all this research. The costumes and setting are from the time of Tutankhamun. The beginning of the upper verse has many quotes from actual Egyptian writings. The children are my own copied from photos of them. The hieroglyphics are authentic and meaningful – parallel with the card.

Do you think this card would sell for next Christmas if I advertised it through "The Basenji?"

. . . Why doesn't the B. C. O. A. write a code of ethics for breeders, asking for suggestions from all the members?

Each point would be followed by a logical explanation of why it is advisable. Then we could learn from each others mistakes, thereby preventing trouble, and in some cases, hardship.

The code of ethics idea - I remember reading in the Dog World about one of the breed clubs writing one. The idea is not my own as it has been done before. They listed rules such as: not selling to puppy dealers, etc. These would not be laws as such, and certainly unenforceable, but if the hard-learned "do's" and "don'ts" could be consolidated and put on paper, some careless mistakes may be avoided by well-meaning, but ignorant owners and breeders.

. . . My husband tells me that I fault our dogs too much, but I'm determined not to catch "kennel blindness" that I'd much rather be too critical. I only wish all other breeders felt this way. I'd love to have a few experienced breeders give me a realty honest, critical appraisal of several dogs, especially ours. There is so much to learn and too few sources. Books can only help so much.

If this is true, and if, as .rumor has it, the same situation has occurred in kennels from coast to coast, then it is time people started stepping forward and volunteer information. If they do, the problem could nearly be controlled in a couple of years if everyone will have their breeding stock checked by the nearest specialist.

### "WAGGING TALES FROM NEW YORK"

New York state celebrated a white Christmas, and many of us living upstate watched as a foot or more of the lovely white flurries arrived on Christmas Eve alone. Perhaps many who drove over the holidays considered it anything but lovely, but those of us accustomed to a white Christmas were happy to see it. The New York weather has been a little topsyturvy the past couple of years, and we've spent Christmas with weather warm enough to wear a suit or sweater, and Easter in ten or more inches of snow! So, at least we're back to normal.

Watching the dogs step out into their first snow was quite comical, it took them little time to realize that racing through it could be a ball! With their sweaters on, they were not only willing, but preferred to stay out racing madly about. However, our breed should never be forced to stay out in the cold with the idea they will learn to adjust to the cold. While some seem to thrive in the cold weather, others could become ill if forced into staying out longer than necessary.

For those who do love to stay out, a foot check upon re-entering the house is a must. Ice can get packed between the toes and pads causing a very sore foot. Those who walk their dogs in the city streets want to be especially careful, since rock salt is used, and not only can it damage the dog's health as well if he licks it when drying himself.

By the time you read this column, there will be but a few more days left until the big event at Madison Square Garden. Their entry of 2500 dogs was filled and closed in December. They have a change in policy this year - in order to qualify, a dog must have won one or more championship points; puppies also qualify as long as they have a point, where in the past dogs must have won one or more blue ribbons and be over one year of age. I'd say that they will pick up on quality, and at the same time, it's obvious they have not lost quantity.

For those who will be exhibiting in New York City, it would be wise to re-vaccinate your dog for distemper with a booster shot. There are many seasoned exhibitors who also advise giving your dog a shot of penicillin to be on the safe side - it is only natural that with so many dogs in an enclosed building, not to mention the thousands of people, germs will be plentyful.

Upon returning home, some borax mixed in water, in which your dog is made to stand for a few minutes, and then rinsing off, is another safety measure that will destroy any worm eggs that the dog may have picked up on his feet. Borax, by the way, as well as salt, is excellent for destroying worm eggs in your runs and should be used often.

I am frequently unable to see exactly what makes a really excellent example of this breed. . .



# Memories During A Basenji-less Hunting Season

by Fred Jones, Bury St. Edmunds, Suffolk, England

The hunting season came and went, and as I was without a Basenji, the sooner it was over, the better.

During the autumn JOYFRED FOREST KING and FOR-EST ROAMER were still here and indeed expected to have increased the numbers - but how soon one's expectations are dimmed. So, it happened that I was left dog-less with only memories of previous hunting seasons.

FOREST KING was completely taken over by an American youth over here with his parents at the Air Base. They were devoted to each other and he will soon return with them to the States.

FOREST ROAMER was mated but whelping time brought complications. An operation was necessary during which time the puppies died - and sad to relate ROAMER also did a few months later. So during the sad Basenji-less hunting season, time was spent remembering past sporting days.

There was ALANA, a good allrounder. Very successful in the show ring and an excellent hunter. I shall always remember her catching her first hare. This hare turned her course once, and once only; a split second later it was caught. The sight or scent of deer used to send her rushing in hot pursuit through the trees and out of sight; many a time I thought she was lost but, sure enough, she would emerge from where she started her chase. When driving rabbits to nets, she seemed to know from the start what it was all about - yes, unforgettable memories.

 $FOREST\ KING\ was\ not\ introduced\ into\ the\ hunting\ game$  until he was three years old because of his show career. On

this uneven land, I often feel afraid that the dogs will injure themselves. I well remember his first hunt - we had several hares in a three year old plantation. There were deep furrows five feet apart; we had already put the nets up, and started driving forward, shooting any hares within range as we went. Suddenly FOREST KING put up a pheasant and gave chase, keeping his eyes upwards on the bird and not noticing the furrows, this mistake made him stumbel headlong; slowly he picked himself up, looking frightened and sore - he soom learned to negotiate the furrows during the chase, and was a keen hunter.

Finally, FOREST ROAMER brings back happy memories; her first chase after rabbits in a large area of heather was very amusing, it is very difficult for a dog to keep sight of these small animals in such cover; the heather is thick and tall, and the rabbits twisted and turned so much, we soon had a rabbit moving and a grand chase was in progress - this is where the "jumping up and down dogs" were really enjoying themselves. ROAMER was jumping to keep it in sight, then with a twist and a turn, and finally a dive forward, she missed it, and carried on hunting nearby, but hadn't noticed the hole where the rabbit disappeared; she soon found it and started digging and tearing the heather roots - wonderful memories.

The sight of these dogs standing still before they flush their quarry can only be appreciated by those who have seen it and no Basenji in the show ring will provide that stance and expression.

I have another Basenji, a daughter of FOREST KING, and she is already providing some happy times although not yet a year old. Bygone hunting days bring back such happy memories to all owners of hunting Basenjis. "Good Sport."

# TEEN TIMES

Teen-age handlers are a joy to behold. A lot could be learned from observing a teen-age handler when it comes to ring manners.

I recently observed a young man from Newberry, Florida - Jeff Philpot by name, as he paraded his MR. PEA-NUTS OF POTSPRIDE to a first place win in his class, and the joy this boy felt was marvelous, to say nothing about Mrs. Philpot! I have also seen "Mr. Peanuts" lose his class and the graciousness with which Jeff accepted the loss. Teens are very valuable to the future of our breed, and are too often neglected, or just overlooked. The breeders are too often too busy to answer a letter from these young handlers. I recall this past summer when young Archie Smith was staying with us, and Archie wanted information on field training and hunting with a Basenji. He had no intention of buying a puppy from the breeders he wrote, merely wanted information. He received one reply, but it made up for the ones he didn't get. Mr. A. L. Braun (of HENTYPKENYA) sent Archie a wealth of material, and a letter of encouragement. There are no words to express how Archie felt about Mr. Braun's reply.

The first step (and a big step) towards teenage recognition as prime breed boosters and handlers, must come from the teens themselves. It can't be urged enough that they make use of the various junior columns in "dog publications." These columns are the prime starting place for the teens' views to be expressed, and their ideas explored.

The second step, and equally important, is for the dog clubs to support the teenager with as much training as they desire.

And, third, but far from least, is for the breeders to make a sincere and earnest effort to encourage the teens in their fields of endeavor with their dog.


