True, over the years, the breeders have endeavored to improve the breed, but I wonder? Is it being improved or torn down? For instance, we have a picture of PHEMISTER'S MAESTRO, published about twenty years ago and MAESTRO doesn't look anything like the Basenjis we saw. He's built! He looks as though he could do a full days hunting and be ready for more! Isn't this what the Basenji is? A hound? A hunter? Though he's to look "aristocratic" and "fine bones," can't he also look like he's built to endure that which he surely must, if he is a hunter?

To sum up: Breeders Beware! Let us not let our breed fall by the wayside as so many breeds have before - let us keep the breed strong and healthy, full of vigor as they were meant to be. Their Congo ancestors would yodel some of their descendents out of the ring if they could see them today.

IUDGES

by our British Correspondent, Ernest Goodman

Whenever dog-folk meet, the talk is bound to come around, sooner or later, to the virtues and weaknesses of judges. It occurred to me that it would be useful to try to list what most exhibitors would consider to be the attributes of a good judge. It also struck me that although judges are examined in print fairly frequently, we rarely experience the reverse process, that is, judges publicly analyzing exhibitors; so I propose, in another article, to do just that.

Here then, are some of the things which I look for in a judge - for the sake of convenience, I will use the masculine gender throughout:

- 1. This is a personal statement, based on experience in Great Britain only, but judging from letters which I have received from readers, I am sure it is a burning issue in the United States too, and I would be most interested in your comments. I don't think any intelligent, experienced exhibitor expects a judge to think exactly as he does - this is a fault of the disgruntled or inexperienced. It is expected by the fairminded, that within reasonable limits, there is room for differing views.
- 2. A judge should know his job this means not only a sound and thorough knowledge of canine anatomy, but also have the ability to recognise breed type and to give it its due importance in his assessments.
- 3. A judge should be scrupulously honest, not only morally, in the sense of not putting up inferior dogs deliberately for personal gain or advancement, but also intellectually honest in that he should not develop the capacity to persuade himself that when he is being influenced by the wrong motives, he is acting objectively.
- 4. He must have courage the courage to put up the best dog irrespective of handler, owner, or any previous record.
- 5. He should be of independent mind uninfluenced by awards made by other judges, however eminent.
- 6. He should know how to handle a Basenji this means, in particular, not over-handling. I have often seen judges making a prolonged series of mysterious passes which could not possibly tell them much more than they could see. but could serve to unsettle the dog.
- 7. A judge should be decisive nothing is more frustrating to exhibitors than the judge who, after spending more than adequate time on summing and handling, is still undecided and further disappoints by rearranging his placings several times.
- 8. He should not use the ring for a display of showmanship. He is there to do a quietly efficient job, not to catch the eve of television talent scouts.
- 9. He should be understanding and courteous. Many exhibitors have travelled long distances and spent hard-earned money to show their dogs. This is a complement to the judge and should be rewarded by scrupulous courtesy and good manners. The ring is no place for the display of a judge's powers of intimidation or sarcasm. I have known lady exhibitors almost in tears because of the brusque and arrogant manner of the judge. This is boorish and quite inexcusable.
- 10. A judge should not be a faddist. Whatever the degree of his dislike of such things as light eyes, or large ears, he must make the effort to assess a dog as a whole, and make his placings accordingly.



bitch. It would be lots of fun to turn her loose in the fields, and she goes hunting for her own amusement! That is too dangerous on account of the hunters and the traffic. She can be very obedient if we show her a wee bit of chocolate or cooky. She will do everything for it. The first year she tore everything to pieces but now she is lots better.

'Isn't it strange that when she is in season, no other dog in town will pay her any attention. There are many characteristics which we do not have with domestic dogs - it would be very nice to hear from other Basenji owners on what they can report on this matter.

My bitch RIVIANA BLACK PERLE holds her dish with her paws when it slips and gets empty. She follows everything that moves: horses; trucks; trains, if possible, and of course birds, fowl, rabbits, etc. She also buries her digestion with her nose in loose gravel!

In closing, my meaning is, we should not force this breed to complete obedience training! Their great attraction is their behavior to follow their nature of a "wild dog" breed we have enough trained common dogs! The Basenji's sense of absolute cleanliness is wonderful. Our "Black Perle" never soils a room! And they are tropical dogs and hate the cold, it is cruel to keep them in unheated kennels. My bitch stands on a chair and leans herself over the radiator as soon as she comes from a good long walk every morning. I did not mention her funny appetite. She loves (besides her full dish of meat and rice) Brussel sprouts, cabbage, raw and cooked, cauliflower, and sauerkraut!

I read that there were found, in the graves of the Cheops - Pyramids chiselled images of the Basenjis, 2520 B. C. and 3600 B. C., a relief was found which shows a Basenji under the chair of his master, and his name was Xalmus.

BASENJI CLUB OF AMERICA MEMBERSHIP DRIVE

The BCOA membership drive was previously announced to end December 15, 1966. However, some difficulties were encountered in obtaining and distributing sufficient membership application blanks. These blanks are now available, and the drive has been extended to January 15, 1967.

For those of you Basenji owners who are not already members of our Club, the following resume of our purposes, aims, and activities may be of interest:

The American Kennel Club is the organization responsible for maintaining the Stud Book, and registering purebred dogs in the United States; for sanctioning and maintaining records on shows and trials leading to conformation championships and obedience titles; for licensing show judges and handlers; for registering kennels; and many other similar services. This organization is made up, not of individual members, but of member breed clubs. The Basenji Club of America is the only organization that represents Basenjis to the A. K. C.

The B. C. O. A. was formed in 1942 by a small group of dedicated Basenji owners. They wrote the original American Standard of the Breed, and furnished pedigree records which were accepted by the A. K. C. in 1943, making it possible henceforth for Basenjis to be registered in the United States.

In order to carry on its important work, the B. C. O. A. needs the support of all Basenji owners. This support can best be given by membership in the Club and participation in its activities.

These activities, all of which are of benefit to you as a Basenji owner, include:

- (1) Representation at all business sessions of the American Kennel Club, in the formulation of policies and procedures pertaining to the A. K. C.'s activities as listed above.
- (2) The publication of a Club Bulletin. This publication is of vital interest to all Basenji owners, since it contains information on, and results of shows; articles and comments on history, feeding, care, training, showing, breeding, hunting, and other information peculiar to the breed, news of Club members; and other information on Club activities, including reports of Club meetings it even tells you who, on the Board, voted for what, so that you can decide which officers are best representing you.
- (3) Maintaining the Standard of the Breed in a current status. This is a most important function since changes in breed characteristics can come about as a result of breeding programs, good or bad, and possibly through environment.

Some of these changes may be good, but generally any change from the original Standard is frowned upon. However, when changes come about which have the approval of the majority of of the Club membership, the Club may recommend a change in the Standard to the A.K.C. — and the only way you can have a voice in this is to be a member of the B.C.O.A.

- (4) Maintaining records on the breed. Much valuable information on history, pedigrees, etc., which could not be gained otherwise, is available to Basenji Club members.
- (5) Arranging for and supervising annual regional specialty shows. These shows are held each year Western, Midwestern, and Eastern. A great deal of preparation goes into each of these specialties and this is where you see the top specimens of the breed. A win, even of a class at these shows, indicates that this dog is one of the best, and is a great thrill for the breeder. The prestige so gained is of great value.
- (6) Maintenance and publication of a list of all members. This is a ready-made mailing list of potential customers and friends. Some people carry the list with them on trips so they can visit other Basenji owners.

These and many other advantages of membership in the Basenji Club of America can be yours for an annual membership fee of \$6.00. Junior memberships, partnerships, and family memberships are also available.

We hope that you will decide to join the B.C.O.A. If so, please contact the Membership Drive Committeeman nearest you. Their names and addresses are listed below. They can provide you with a membership application form and other information pertaining to our Club.

EARLY TREATMENT OF NEPHRITIS MAY SAVE A LIFE

In the last decade medical science has extended man's life expectancy by approximately eight per cent. The life expectancy of pets has undergone an even greater change on a relative basis. Not only does the animal live longer, but he is a much younger animal at 10 today then he was 20 years ago.

As man's life span was extended, his disease problems have also undergone change. Where once he died of smallpox, flu, and TB, more people today die of heart disease or cancer. The plagues that once swept Europe have become a thing of the past, and all is due to the great advancements medicine has made. There has also been significant changes in the diseases that affect animals. The incidence of rabies in dogs is on the decrease, due to vaccination of the canine population and public awareness of the importance of this disease. Proper care with respect to housing and nutrition has also contributed to the longevity and well-being of our pets of today. However, with all of our advancements in new methods, drugs and professional ability, there still remain some conditions and diseases that are a threat to our pets. Chronic nephritis is such a condition.

COMMON KILLER OF AGED PET

One of the common killers of the aged pet today is chronic interstitial nephritis (CIN). It has been estimated that approximately eighty per cent of all dogs over eight years of age have some degree of CIN. This disease usually is due to a series of problems, often a progressive type, over a period of years. Damage to the kidneys may occur when the dog is young and suffers from such diseases as leptospirosis or distemper. Some kidney tissue is damaged or destroyed at this time, but due to the large reserve supply of kidney tissue available to care for the functions of the animal, there are usually no symptoms. The first indication of trouble may come from a disease such as pyorrhea (infection around the teeth) that is common in older animals. Actually, each time your pet is ill there is danger that some of his normal kidney tissue may be destroyed. Fortunately, if he is normal at birth, he has enough reserve tissue to compensate. When an animal's kidneys are healthy only a small portion is functioning at one time. Because of the large reserve of kidney tissue there are rarely any symptoms of this disease until a large portion of the kidneys is destroyed. Even at this stage, however, an animal may still have several good years if the disease is recognized and proper measures taken.

CARDINAL SYMPTOMS OF NEPHRITIS

The cardinal symptoms of chronic nephritis are increased thirst and frequent urination. Nocturis (wetting at night with no control over the act) is often a problem. As the symptoms progress over a varying length of time, the animal may develop uremia, due to the inefficiency of the filtering ability of the kidneys. At this time a commonly observed symptom is severe vomiting usually bile or yellow in color. If left without treatment at this state, dehydration, severe lethargy and diarrhea rapidly follow and the prognosis is usually grave. However, even at this late stage, there are a few animals that will respond to treatment.

Detection and early knowledge of the condition are the important aspects of nephritis. If the owner is aware of the problem, very often the stress or otherwise insignificant small infection may be taken care of before any damage is done. Many animals with signs and symptoms of nephritis live many years without problems if the owner is appraised of the condition and measures are taken to prevent an acute attack.

WAGGING TALES FROM NEW YORK

I can recall as a child, my mother upon being told by someone that doing so and so was "easy," her stock answer was, "everything is easy when you know how."

And so it is for many of us who have delivered many litters, it has become "old stuff" to us. But not any of us know so much that we can't learn more. The most important thing is to be prepared.

I'm not going to dwell on the whelping, since this can be found in just about any dog magazine or breed book. A very good article on whelping can be found in "Basenjis The Barkless Dogs" by Veronica Tudor-Williams. I would like to dwell with other problems that may or may not occur, but would be advantageous to know about - could, in fact, save your puppy's life.

Usually, a bitch in whelp will eat like a "pig," but occasionally, for no known reason, will go off her feed. One or two days of this is no reason for concern, but some bitches will carry this "no eating" habit for weeks. They will turn their nose up at the most tempting morsels, even steak, but I have found most of them will gladly accept a dish of oatmeal, prepared as for yourself, with milk and honey - never give a dog sugar. They will also eat milk bone biscuits by the handful, but often, like a spoiled child, only if you hand them one at a time, but it is worth catering to the mother-to-be.

Your litter has been whelped. Have you accounted for each and every placenta? If you have not, or if you think there may be another puppy yet unborn, and enough time has elapsed since the last one, then it is time to take the dam to your veterinarian for a shot of pituitrin. This will cause the uterus to contract and force out any left over placentas or offspring. We have our veterinarian give it as a safety measure, to clean the dam completely. Her puppies can be kept quiet and happy by placing a heating pad, covered with a towel in a box.

Your next step is the removal of the puppies' dewclaws. This is the extra toe that appears on the inside of the front legs. Show or pet, these must be removed if you are to avoid the problems they can cause in later life. This is best done at around three days of age. If you wait too long, bone has formed and then it is major surgery and the puppy will have to be anesthetized. This is not necessary with two or even five day old pups. Within one half hour after all dewclaws are removed, the puppies are back nursing. We've had puppies fall asleep as we changed their position getting to the other dewclaw.

The next step in the life of your puppy, are his distemper vaccinations. It's a good idea to revaccinate the dam about the time she is bred. It seems that most veterinarians have different ideas of when the puppies should start their temporary shots. We like to give our own, however, I would not recommend this unless one is experienced. Some vets will sell you the MLV (modified live virus) and show you how to administer it. It is very important that the MLV is fresh, and that the needles are sterilized. We like to do this at home as there is always danger of bringing home diseases whenever the pups are taken to the veterinarian as all manner of sick dogs are there. The temporary shots are only good from ten to fourteen days. Most veterinarians recommend these every two weeks until the puppy is old enough for his permanent shots - usually from three to four months old.

Local And Regional Basenji Clubs

On September 22nd of this year, I was designated liaison between the Basenji Club of America and local or regional Basenji clubs. Since that time, I have been in contact with twelve different groups which are active or just starting. Some of them are primarily social, but most are interested in holding fun and sanctioned matches, and possibly point shows eventually. A.K.C. sanction is required for the latter. Such sanction would almost certainly require the previous recognition of B.C.O.A. the parent club for the breed.

To obtain B.C.O.A. recognition, approval of the Board is required. In order to assist local and regional clubs desirous of obtaining B.C.O.A. Board approval and Club recognition, I have devised a standardized procedure and list of documents required. Upon receipt of these documents - most important of which are the By-Laws, membership and officers lists, and a resolution recognizing the Basenji Club of America as parent club. I will forward copies to each Board Member for their information, and prepare a ballot for their vote. If the Board vote is affirmative, the B.C.O.A. delegate to the American Kennel Club will be provided with copies of the pertinent documents and instructed to request A.K.C. sanction of the new club.

Anyone interested in B, C, O, A, recognition and A, K, C, sanction of a local or regional Basenji Club may write to me. I can provide them with a sample Constitution and By-Laws, A, K, C, rules and regulations, and other material which may be helpful.

Aunt Mary's Pet Talk

by Mary Motley, 421 Lake Shore Drive, Daytona Beach, Florida

"Never make a pet of a hunting dog" or "never make a pet of a show dog" is a fallacy. We still hear this old saving even though it has been disproved often.

Without affection, trust and confidence between dog and man, there can be no real understanding. Without understanding what kind of team can they be?

I don't mean the dog should be pampered, but he deserves attention and affection, as does every dog.

In addition to caring for such essentials as proper food, fresh water, adequate shelter and sanitation, every dog owner should spend some time every day with his dog. This is even more important if the dog isn't a house dog and part of the family routine. Outside dogs and kenneled dogs especially need this period of play, talk, and "togetherness" with their owners, but it benefits all dogs.

A lively romp in a safe open area is ideal. If this isn't possible, a walk on a lead is good. These periods together are an excellent time for training, or you may prefer to use the time for grooming and attention to the dog's coat, skin, eyes, ears, toenails, teeth, etc. However you spend this daily time, give the animal your complete attention. This is his time. Talk to him. Let him fully enjoy his time with you - it will become the highpoint of his day.

Ear care is especially important to dogs with ears in which air can't circulate freely. The ears of a dog are extremely sensitive. Care must be taken not to irritate them. They must never be washed with soap and water. When the ears need cleaning, swab them out with cotton and a little baby oil. Be gentle, and don't probe. Clean only as deeply as you can see. If your dog develops an ear infection, see your vet.

The earlier an ear ailment is treated, the better. If neglected, it can easily become chronic.

Because their ears are so sensitive and give them so much pain when infected, even a very gentle dog may snap if his sore ears are molested in any way.

Eve care is usually more preventive maintenance than actual treatment. If your dog romps in high growth, tiny weed seeds and other foreign matter get in his eyes and should be washed out with boric acid solution. A cotton swab can be soaked in the solution, squeezed over the eye, and the gentle flow will rinse the eye.

Tooth care usually is not difficult. Dogs that are permitted large bones to gnaw generally keep their own teeth fairly clean. (Give only large bones that can't be broken up into pieces and swallowed. Knuckle bones are excellent, as are marrow bones, which contain much nourishment. The teeth should be checked frequently and cleaned if necessary. When your dog is at the vet's for a checkup, ask the vet to also look at his teeth. When your dog has foul breath, teeth are sometimes the cause.

Foot care can save a dog much pain. The feet should be examined daily - after his run or exercise period, preferably. If the pads have any cuts, they should be treated at once. If the nails are kept trimmed, there's little danger of trouble from a broken one. A broken nail can cause severe pain and should be treated promptly. It may be necessary to remove it.

Never use kerosene to remove tar, gum or anything else from the pads and coat of a dog. Ether is safe, and so are small amounts of nail polisher remover. Kerosene burns the skin.

For warm weather, this review of general care is given because that's when grooming and special attention to health is most important. We can't cover everything, but we strongly urge a never ending war against fleas. Fight them (continued on next page)

This is how we game is played. First, you make a 3 x 5 card for each American champion and obedience-titled Basenji, showing the name of the dog and also the name of his

Second, you sort the cards into alphabetical order by the names of the studs. Then you make another 3 x 5 card for each stud, listing on the back side the names of his pups which have finished their championships.

Third, you sort the first set of cards into alphabetical order by the names of the dams. Make still another set of 3 x 5 cards, one for each dam, and list on the back side of these the names of her pups which have finished.

Fourth, you sort the first set of cards into alphabetical order by the names of the dogs that have finished, separating the champions from the obedience-titled dogs. At this point you have four sets of cards.

All you have to do now is keep your list up to date. When you get mail, you recheck your records. Of course, I owe a large debt to the work done by the late George Gilkey in compiling the list of champions published in the BCOA Bulletin several years ago. And to Norm Wallace who got me interested in the numbers game and furnished me with stud books going back to the first AKC registered Basenjis and also did a lot of the research into pedigrees.

Others, too numerous to mention, have assisted with the work at one time or other. I would like to add that Bettie's patience has been sorely tried as I whiled the hours away playing with cards, etc.

If you'd like to challenge the correctness of the list (and I certainly make no claim to infallibility), drop me a line about any dog you think I have credited with too few (or too many) champions. If there is a mistake, I'll be most happy to make the corrections as needed. (Please remember that I have not counted anything except American champions.) The list as published here is complete through the November 1966 issue of the AKC Gazette.

For what it's worth, here is the honor roll of brood bitches. You will note that I have included dams which have produced at least four American champions. I chose this cutoff point in order to have approximately as many bitches listed as there were studs on the list published in October 1966. For your information, the rest of the dams break down this way: 47 with 3 each; 84 with 2 each; and 229 with 1 each.

The accompanying list also points out some interesting relationships, Thus, CH, GLENAIRLEY BLACK MUNIA (A) (j) is the dam of CH. TINAS COMA VENUS (a) and the daughter of WIDGEON OF THE CONGO (J) (K), with CH. GLENAIRLEY SONG BIRD (k) also being Widgeon's daughter. The "*" behind the names of CH. MY LOVE OF THE CONGO and CH. POPPET OF THE CONGO indicates that these two are full sisters, but their dam GOLD PIPPIN OF THE CONGO is not on the list.

what I have said and put yourself in my position, you will know the regret that plagued me. Yes, we took them to the veterinarian - he had not seen it before. He was an extremely kind. understanding man and did all in his power to help, but there was little that could be done. He estimated that the pup with most affliction was 90% without sight. The rest were progressively better. In all but one pup, the clouds could be seen with the naked eye. One was doing well to find the eye itself for the white areas.

I could not believe it would not clear up. We nearly lived at the vet's office. I ran tests at home to see if any improvement was being made. One pup, the one with the most coverage, was afraid to jump from any height unless he could reach the floor with his paw. This is not my idea of what a Basenji should be. Eventually, I found homes for them with the understanding they would simply be pets and never be allowed to reproduce. Please remember, I did not do this all on my own, but had asked advise from others who knew more than I.

I continued in my efforts to seek an answer to the perplexing problem of my puppies' eyes. No one had ever seen or heard of it before. Finally, a breeder viewed my problem with understanding, one who felt her animals might help me produce fine pups. I accepted this advise and bred the bitch again. Anyone can come up with a problem in a close breeding which the first one had been.

The bitch was bred, and again the pup's eyes were afflicted. Not so badly this time, but the white spots were there just the same. So where do I go from here? I know I will be cautious of the animals I breed in the future, and are given a thorough investigation. I write this in the hopes that perhaps one of you will be spared this heartbreak. I wish this could be ended with a happy note, but unfortunately, the only part that is related to a fairytale, is my desire that it all was one.




