

CAPITOL QUIPS

by Karin J. Quam, 10643 Maple Street, Fairfax, Virginia PHYSIOLOGY AND FUNCTIONS OF THE CANINE EYE

The dog's eye, like the human eye, functions in the same fashion as the camera. Light enters the eye through the cornea, passes through the aqueous humor and the pupil to the lens where the light rays are focused upon the retina. A chemical change in the nerve endings of the retina occurs, which in turn starts the nerve message to the brain via the optic nerve. Interference with any part of this chain can produce total or partial blindness. For example, if the optic lobe of the brain is removed, the dog will be totally blind although he may have perfectly normal eyes.

The principle function of the eye lids are to help protect the cornea, aid in drainage of tears, and reduce blurred images by the involuntary act of blinking. The cornea is the transparent foremost part of the eyeball, which initially admits the passage of light through the eye. Pupillary size is controlled by the iris on a reflex basis regulated by the brain to produce the correct amount of light needed for clear vision. The lens approaches optical perfection only at its center. Therefore, light is automatically regulated by the iris to pass through the center of the lens. The lens itself changes its convexity for further clarification of the image projected on the retina. This focusing power of the lens is called accommodation. The accommodation reflex in the dog differs from that of other domestic animals and man, since the pupil dilates for near, rather than contracting, and contracts for distance vision.

The great majority of animals, including the dog, lack binocular vision; that is, they see one object with only one eye at a time. Also, most animals discern movement rather than actually see figures. Most animals are color-blind and see

only shades of grey, varying in brightness against a grey background. They rely, instead, upon their keen noses for more detailed direction finding. One of the most important characteristics of the dog's eye is its relative nearsightedness, according to most observers, and it is for this reason that veterinarians rarely need to prescribe glasses or contact lenses for the animals following cataract surgery. Dr. Smythe in "Veterinary Ophthalmology," however, emphatically disagrees with this thesis; he contends that most hunting breeds are slightly farsighted. But, all authors agree that dogs, like all animals, tend to become presbyopic with age. This corresponds to the presbyopia in the human which necessitates the use of reading glasses or bi-focals by the age of forty-five.

If the dog is truly nearsighted to a moderate degree as contended by most veterinary ophthalmologists, this would mean that any object beyond thirteen to twenty inches from the dog's eyes would be seen very blurred, in addition to being entirely without discernable color. This fact would indeed support the visual perception of motion theory, rather than the true visual acuity being present in the dog. However, if Dr. Smythe's contention is correct as he has observed in certain Retrievers, Pointers, and the Greyhound, Saluki, and Afghan, then at least some breeds of dog have quite acute vision. It would be most interesting to know the status of the Basenii's eyes in this regard. The next article in the series will deal with common afflictions and diseases of the canine eye.

"WAGGING TALES FROM NEW YORK"

Those of you who know me are aware that before I got into Basenjis, my first love was German Shepherds,

When I inquired for my first Basenji I stated that I wanted a breed that was as far removed from hip dysplasia as possible. Now you may be wondering what German Shepherds and HD has to do with Basenjis, but I hope to make my point by using it as an example, so please bear with me.

To explain what HD is in simplified layman's terms it is when the hip bone of the dog does not fit properly into it's socket, thereby leaving a space and creating wear on the hip bone, which in turn may or may not cause the dog to become lame.

HD has been a problem as far back as the 1940's. Not only in German Shepherds, but in many of the large breeds: Boxers, Old English Sheepdogs, and Gordon Setters, just to name a few. The smaller breeds can also be afflicted, but it is not so common. HD research has gone on for as many years.

When Shepherd breeders became aware of the affliction, it was the topic of conversation whenever they got together. As more and more cases were reported, panic set in, so that X-raying all breeding and show stock was a must at one year of age at the earliest. And advertisements offering stud service or puppies for sale, carried the statement, "X-rayed and found clean," or "So and so has been X-rayed." (No mention of the results, merely that the dog had been X-rayed) or "Guaranteed

There was one serious problem, however, not all veterinarians knew how to take the proper hip X-ray! Any slight movement of the anesthetized dog could create a shadow on the X-ray and was promptly diagnosed as HD.

One by one, as the panic rose, dogs of top quality were put down because of HD, until it was realized how many of their beloved breed has some degree of HD - about 70 to 80 per cent. As this was realized by others, veterinarians in particular, it became a case of "normal for a German Shepherd" and clean hip certificates were issued.

Most Shepherd breeders finally reached the point of considering HD just another fault to contend with. They still X-rayed, but those dogs showing HD in a lesser degree were retained for breeding. Breeders who argued against this pro-

cedure refused to have their dogs X-rayed after two years of age by someone like Dr. Leonard at Cornell University for the simple reason that with Dr. Leonard, they either have HD or in his own words, you are either pregnant or you are not there's no such thing as a little bit.

After 40 years of this problem, they still do not know how to rid the breed of this affliction. For it is an affliction without an answer at present. Perfect hipped parents can, and do throw dysplasic offspring, and dysplasic parents can throw puppies with perfect hips.

Perhaps some of you already know the point I am trying to make in regards to the Basenji and the present eye problem we are faced with. Step by step we are going the way of the German Shepherd breeders. First the realization of the problem; second the examination and the consequent "putting down" and destroying some top quality dogs; thirdly the statements in advertisements of dogs having been examined and found free.

The cause is still guess-work, and different bloodlines will receive blame, the big breeders will be the object of criticism. But since we do not really know the cause of this eye problem, let us, for just a brief second, consider the possibility of this not being a genetic factor. What then? For the sake of argument, just suppose this problem is caused by an infection such as staph? A staph infection is highly contagious. A person or dog can be a carrier without showing any signs of the effects of the infection, but can pass it on to others. Some people, and again dogs, will be more susceptible than others; hence a carrier might not pass it onto those he lives with but to another more susceptible animal coming in contact with the carrier.

Working on this theory, the proper medication could bring the problem under control. Unaided it will continue it's way while we grope in the dark.

If it is a genetic factor, we do not know exactly how it works. It is dominate or recessive. If not a pure recessive, as in the case of HD, as stated by Dr. Leonard, how do you expect to control it. If you put down quality dogs based on the genetic theory, why not all the litter mates and parents as well?

We are all in the dark concerning this problem. To ignore it would be criminal to the breed, but to go off halfcocked in a panic, will bring similar results.

We are very sorry to report that Mrs. Herman Genth passed away June 14, 1967. Our sincere sympathy is with Mr. Genth (former B. C. O. A. president) and son Frederic.

BASENJI NOTES

EXTRACTS FROM "OUR DOGS," ENGLAND, June 16, 1967

As the Dog Press has quoted from the American Journal, "Modern Veterinary Practice," Feb. 1967, which deals with eye problems in dogs, especially Collies and Poodles, and a newproblem in Basenjis, "persistent pupillary membranes," I feel I must try to reassure Basenji owners.

This trouble was first noticed in the States as long ago as 1953, and when I was there in 1956, I was shown an afflicted dog. Nothing more was heard of the problem, and I hoped it had been bred out, as other problems such as severe hernias, bad mouths, and cream coloured dogs had been. Although, having been alerted, I was on the watch for it in England.

Last summer I was told of an afflicted puppy, whose owners asked my advice. I told them to take it to the Veterinary College, which they did, and I placed the report before the Basenji Club Committee. In view of the fact that there were no other recorded cases, the Basenji Club felt there was no need for further steps, except that a close watch be kept for any further eye trouble.

Early in 1967, I had a report from America that this trouble had increased, and the report went to the Basenji Club Committee. This time they agreed with me that it was not caused by outside circumstances, such as injury, infra red lamps, inoculations, virus diseases, or any other excuse, and immediate steps have been taken which I think reflects great credit to the Club Committee. The Basenji Club's veterinary surgeon was contacted straight away. She advised Dr. Keith Barnett, who is in charge of the new opthalmic unit at Cambridge, which is being opened next week. No choice could have been more opportune; Dr. Barnett having recently been in the States, and in touch with Dr. Roberts of California, who has been conducting the research into the eye problem in Baseniis in America. I feel we could not be in better hands.

We were awaiting more detailed information before making any of this public, but the Press has beaten us to it. However, Basenji owners are responding in a wonderful way, and are already asking to have their dogs tested. It seems nothing is being hidden and all want to cooperate for the good of the breed. There are two very heartening factors - one being that from incomplete data, it is hoped that the trouble is caused by a simple autosomal gene - this being far the easiest gene to deal with, and the other makes it especially worthwhile, that although the groundwork is with dogs, the primary interest is that it will help similar eye abnormalities in human beings.

It is hoped that facilities will soon be available for all Basenji eyes to be tested by the few people fully qualified to undertake this very specialised task, and for this our gratitude must go to Miss Cook, who is being a tower of strength in this problem.

California Crucible

This is to answer the many questions directed to me recently concerning my association with Ohio University for the investigation of the Basenji eye problem. Shortly before the B.C.O.A. made the final arrangements with Ohio for this eye research, I had acquired a badly afflicted red and white male Basenji that was donated by his owner/breeder for examination and test breeding purposes. This was around Christmas when I shipped this male to the Midwest at my own expense, the eventual destination was Ohio University. Unbeknownst to me, this pup was never forwarded to Ohio University after the arrangements were made, but died of an unknown poisoning.

During this time I shipped two other afflicted pups to Dr. Wyman. One pup to complete the original pair, as I was still under the impression that Dr. Wyman had received the first pup, and an extra pup was also sent. The shipping and necessary phone calls to send these two pups were paid by the B. C. O. A. The latter part of April, I called Dr. Wyman to see if he had received the pedigrees on the donated pups and learned that the female pup of the pair had died of distemper. Since he was in the process of requesting funds to support this pilot research program, he was very anxious to have a replacement female pup, and he desired the promised \$75 from The Basenji Club of America be used to cover expenses to ship another female. I wrote to the B.C.O.A. requesting that this money be made available explaining that I had access to another afflicted litter that contained a female. Not wishing to retard Dr. Wyman's progress by a long wait for confirment, I went ahead and shipped the female, accompanied by an extra litter mate.

Shortly after shipping the last two pups, Dr. Wyman

sent me a letter and pamphlet describing his findings in the Basenjis he had examined. This pamphlet was designed to show the need for funds to support this project and has been submitted to the University Foundation Department for consideration. Dr. Wyman requested that the pamphlet covering his findings not be published. I will abide with Dr. Wyman's wishes however, I am sure he will not mind if I pass on the title which is: "An Inherited Ocular Defect in the Basenji Breed." In this paper, Dr. Wyman goes into some detail about his proposed breedings, genetically planned to learn the mode of inheritance. Fortunately, we are living in a computer age, and much of the information gleaned from a few breedings can be programmed in the computer for quicker results. I have requested a release of this pamphlet as it is of vital importance to all breeders. I also strongly feel that every breeder has a right to this information, not a select few. I also requested that Dr. Wyman send his findings to the Basenji Club of America.

If the University grants funds to this project, Dr. Wyman will need help. He expressed the desire that any and all information from anyone pertaining to this abnormality be sent to him. He also will be needing another afflicted female. two clean females, and a clean male for test breeding. He has promised that the results will be made available to us. This is not a problem that can be viewed with little concern by the majority of Basenjites. One has only to start researching their pedigrees and see how few dogs our breed started with. In other words, this is not a small problem concentrated in just one locale, but a national breed problem of some proportion. Perhaps you have not experienced puppies with clouded eyes yet, but who is to say you won't with the next breeding? All of us who have suffered were caught unawares. This investigation is going to bring about intensive pedigree research, and pure objectivity of cause is going to give way to accusations and

PYOMETRA

by Mrs. Joan B. Clague, 116 Des Moines Street, Ankeny, Iowa

As pyometra appears to be fairly prevalent, I felt that our experience with it might be of help to others. First of all, pyometra means 'pus in the uterus" and occurs between the mating cycles.

It apparently started just after STAR'S first litter was about three months old - she showed signs of coming in heat, with the vulva swelling and a few drops of blood. Nothing else, so we assumed she wasn't coming in heat. Three weeks later, she came into the house afterher morning exercise all hunched up and in great pain. I immediately called my husband to come home so we could get to the veterinarian as soon as possible. By the time he got home her temperature was up to 103 degrees and she had a very copious, odorous discharge. Our veterinarian diagnosed it as pyometra, and we debated on the pros and cons of spaying her. Since she was a champion and had just produced a nice quality litter with one outstanding male, we felt we'd like to try to have her cured.

Then started seven frustrating months. She responded beautifully to the medication - the discharge cleared up completely and the WBC (white blood count) was nearly back to normal within two months, but after she was taken off the medication, the discharge came back within a couple of weeks. It was then decided to culture the discharge (this I would advise doing immediately) and found that the original medication had taken the infection down to a minimum, another type of antibiotic (and very expensive, I might add) was needed to clear it up completely. So she was started on this and within two months was given a clean bill of health.

Our veterinarian recommended breeding STAR at her next heat, even though he felt she would not conceive, as it would clear out her reproductive system. Then she pulled her stunt of starting to come in season and changing her mind. She was given a shot to bring her all the way in, which it did. Only one problem - it was not a true heat as she would have nothing to do with BARNEY. We tried again the next morning without success. In two weeks she was back in heat, and this time was bred successfully. Nine weeks later, much to the veterinarian's surprise, she produced one pup which died six days later.

We were encouraged that she produced at all, since our veterinarian felt sure she would have a normal and healthy litter next time. The following May, STAR was her usual uncooperative self - this time she had a false pregnancy. At this time our veterinarian and several local breeders told us we were only wasting time and money on her - that she would never produce again. Since the stud owner was willing to give it another try and she was bred again in October, 1966. This time she came through nicely - four live, healthy pups with a fifth born dead as a result of a fall two days before she whelped.

Since there is a strong probability that STAR will develop pyometra again when she's 6-7 years old, we will breed her just once more and then have her spayed before we have more trouble. Was it worth all the time, money and effort? We'll see when CHEETAH hits the show ring, and in turn produces STAR'S grandchildren, also when we see STAR'S next litter. Only time will tell, but yes, I think it was.

Right now I'm helping some local hound owners with plans to bring field trials to Alaska. Since I first fell in love with hounds generally by following them in the field, this is fun for me. How does this apply to Basenjis? Sad to say, we have no field trials - why not?

Seems to me that some of us who scream the loudest about the "natural" breed we have, and those of us who love to brag about the fabulous field exploits, should start not only the agitation, but also the work. Conformation shows are wonderful; obedience trials are terrific - I don't downgrade them one bit, but the Basenji is most attractive as a companion. I love to head for the woods, although I get far too few chances, and there is no better friend to take along than 'Senj. This is where I find the truth of what Norm Wallace told me: the Basenji that our show standard describes is also the best dog in the field.

Wouldn't you like to be able to demonstrate that the dogs we show are actually the brilliant hunters we talk about so glibly? Can you imagine the thrill of owning a Field Champion? Or better yet, a Dual Champion?



Some very interesting correspondence has come in on tattooing animals. Doug Wilson of BAKUBA BASENJIS writes that he became interested in tattooing, but has not vet tried it on his dogs. The information he enclosed in his letter is as follows: A brochure from the "National Dog Registry," inaugurated, January 1966, suggests you tattoo your social security number in the 'right groin' of your dogs. Send this number with your name, address and phone number to "National Dog Registry," Box 55, Stanton, New Jersey 08885, with a fee of \$3. You will receive a certificate of registration to acknowledge that your dog's tattoo is filed with them. All dogs owned by you may be tattooed with your "S. S." number for the same fee, and only your social security number is on file. If you sell or transfer your dog, notify the Registry. The new owner should add a letter or his initials to the dog's tattoo and re-register this new number under his name and address. The Registry will notify you when it receives word that one of your dogs has

turned up and you can take the necessary steps to recover your dog. I have sent a letter to the National Dog Registry inquiring how effective the project has been in securing registrations and in recovering pets. I will pass this information on when I hear from them. I can think of many improvements in their suggested method of tattooing and eliminate the need of more than one tattoo. Mr. Wilson states that there are two suppliers in the states for tattooing equipment, and from the price list he sent, the price of a complete kit will run close to \$28 and said that today's tattooing is painless and sanitary.

An article from the February-March issue of THE CONSERVATIONIST describes the use of tattooing on wild game for research purposes. A reward is paid for each animal that is properly returned and bears a tattoo. Identification materials and information should be sent by express collect to: "Big Game Project, Wildlife Research Laboratory," Delmar, New York. A battery-operated portable tattoo kit is now in action for permanent installation of identifying numbers on bears. The inside of the upper lip and the inside of the upper hind leg are the two places tattooed. The article states that the lip was chosen as it is one area easily examined at check stations, etc. The leg was chosen because the hair is thin there and the tattoo is more noticeable to the hunter.

Many thanks to all of you who inquired about our GARY and his heartworm treatments. The method used on him was a two day treatment of an arsenical compound given intravenously in fractional doses. This treatment is followed by a second. and in GARY'S case was given three months later, and he will be re-examined in six months. There was an excellent article in the May 1966 issue of "Dog World" by R. W. Kirk, DVM on heartworms and the treatment.

### A MAJOR DISEASE BREAKTHROUGH

May I tell you a little about my background, and then my reason for writing to you?

From 1946 to 1962 I bred and exhibited Collies. My kennel was small, sometimes no more than eight mature dogs. There were usually a few boarders with us. I had several club affiliations which I enjoyed and which were helpful to me. During this time I was employed as secretary in federal hospitals and in the research department of a university. (This last I mention only because it gave me an insight into the methods of verification used in scientific research.)

While my chosen breed was Collies, the hopes of all fanciers are much alike: to produce winners, to leave our breed better than we found it, to sell healthy puppies to the best owners. Also our problems are common. The most careful of us, working with the best stock, has his heartbreaks. You may have a minimum of problems but it takes only one dead litter or one dog put to sleep to hurt badly.

When moving to California five years ago, I had to give up my hobby, but my interest remains high. When I recently came across a new research development, I wanted to know more about it. I read everything available to me in literature, reports from State Colleges, the publications from symposiums, and I tried to apply it to my personal experience. I asked Dr. H. C. Burns, a pioneer in its exploration, if I might tell dog breeders about it. Veterinarians receive information through professional channels, and newspaper and magazine releases go out to large numbers of people. But I thought of this "grass roots" approach to reach the most concerned person, the breeder. I know the breeder to be an aware person, alert to new knowledge. Through club associations, the most good could be done in the shortest time, and the individual pet owners who are in close contact with the breeder, would also become informed.

Here is a paper briefly descriging this new concept in the treatment of "chronic" and "incurable" canine problems. It carries a message of hope and the sincere wish that you will introduce it at your club meetings for discussion and reprint it in your publications. Copies are yours for the asking and technical literature available for your veterinarian. If I can be of any help, I'll be glad to hear from you.

Researchers\* and practicing veterinarians\* report the saving of many dogs whose only relief would have been through death. ". . . a Dachshund who had been treated for months with penicillin and hormonal tissue stimulant tablets with thyroid, finally stopped eating, scratched and chewed herself all night. . ."

". . . a Basset Hound, unable to stand on its hind legs, radiographs revealed bilateral coxofemoral subluxation. . . "

". . . 11-year old Golden Retriever with radiological evidence of hip dysplasia. Lameness and muscle atrophy was increasing even though being maintained on Butazolidin. . . "

". . . 10-year old German Shepherd was presented because of inability to see. Examination showed bilateral cataracts. In the right eye, a traumatic cataract was as opaque as Italian marble, and no fundic reflex could be elicited. . . "

These symptoms that appear so diverse are all responding to the same treatment. This is more readily understood in the light of recent findings which show them to be related to a metabolic imbalance. By increasing the metabolic efficiency, a wide variety of diseases are being both alleviated and prevented. Thus far, 18 species of animals, and man, have demonstrated this faulty metabolic process, and many of their disorders are being viewed as a specific one. These range all the way from nutritional muscular dystrophy in lambs, abortions in cattle, muscle tieup in horses, to infertility in turkeys. Millions of doses have been given to livestock with effectiveness and without harmful results even on prolonged use. According to O. H. Muth, DVM Professor, Department of Veterinary Medicine, Oregon State University, millions of dollars worth of farm animals are being saved each year.

Metabolism is the flame of life. It can be likened to the flame on a gas stove. When parts of the burner are clogged, the flame becomes feeble and flickers. This poor combustion releases end products that can attack any tissue and organ in the body and produce a variety of clinical disorders depending

on the organ involved. A reduced flame may cause a reproductive problem - or a muscle disease, etc.

Of course, a spark is needed to ignite a fuel. In our biochemistry there are several that are essential to maintain this flame of life. Two of them are tocopherol and a trace element, selenium.

Here is where a research breakthrough has been made. When these nutrients are used together in a certain balance, each enhances the other. Selenium becomes 7 times as effective with tocopherol and tocopherol twice as effective with selenium. It's a case of one plus one equals five! An imbalance of these causes a disturbance in normal fat, protein and calcium metabolism. Until this sparing effect of tocopherol on selenium was discovered, the veterinary profession, and even more so, the medical profession, was disturbed and influenced by "selenium toxicity." Now new knowledge is accelerating research in all phases of its use. While it may not hold all the answers, it offers much that is valuable.

On 335 dogs clinical investigation\* showed 88.66% marked improvement and 6.43% slight to moderate improvement, in cases of chronic lameness due to arthritis, hip displasia and disc syndrome. One investigator\* plainly says, "It has done a wonderful job on real bad hips from dysplasia."

On the basis of the remarkable interrelationship of selenium and tocopherol, and its success with livestock in preventive treatment, there is much interest in its use on certain breeding problems in dogs.

Many stubborn eczemas are undiagnosed. Many dead litters dismissed as victims of "lethal genes." Even inability of a bitch to conceive is considered to "run in families." If "tainted blood" lines may be often and simply a metabolic disturbance which can be corrected, then there has been much (continued on page 14)

The Dachshund? ". . . Put on selenium-tocopherol, inflamation and scratching was reduced within 24 hours. Two months later hair was rapidly growing in, all scratching stopped and she was gaining weight."

The Basset Hound? ". . . The puppy was walking nine days after selenium-tocopherol therapy and the hip appeared normal radiographically at 13 months."

The Golden Retriever? ". . . Condition has improved considerably and maintained for 6 months without Butazolidin. "

The German Shepherd?. . . Within 4 months the dog was able to catch a ball, which he had been unable to do for more than a year. Maintainance dosage of selenium-tocopherol was reduced to two capsules weekly."



### TAILS, CURLY AND BUSHY

by PAUL VAN ORMER 724 East Franklin, Clinton, Missouri 64735

This is about the bushy tailed squirrels, and the curly tailed Basenjis who delight in pursuing and treeing them.

Unfortunately, or perhaps I should say fortunately, we do not have the same wildlife that is found in Africa - the Leopards or the Gorillas. Therefore, it follows that if we like to use our Basenjis for hunting we have to pursue some of the lesser animals, and next to the rabbit comes the squirrel. The little sciurus comes in several varieties. Here in the Midwest we have two - the fox or red, and the grey squirrel. One preferring the upland timber and the other the river bottom timber. Either one might be termed "a natural" for the Basenji and an animal that the Basenji will pursue and tree without any training. A little praise for your dog after he has treed and a little help in showing him the squirrel is fine and best of all, is shooting the squirrel out-the Basenji will have it the second it hits the ground and give it that old Basenji shake.

After the winter months and the end of the various hunting seasons, it's spring. Everything is green, birds are back and it's a fine time to be out. A really pretty sight is a hickory grove in full flower. A squirrel hunt affords you this opportunity and if you do not think the squirrel is a sporting enough game, let me say that a young fox squirrel makes mighty fine eating.

On one occasion last summer when out with one of my Basenjis, I heard a squirrel scolding in a patch of mixed timber - oak, hickory, walnut and sycamore, so decided to try to get it. Sure enough, the Basenji found the trail on the ground, and with the surety of an old Coon Hound, proceeded to unravel it and rear up on a tree saying, "this is where it is." Now this happened to be a Jack oak, one of the twenty varieties native to Missouri, and fairly tall and while about fifteen feet from the next tree, yet the upper branches were interlaced. After much looking, in fact 'till my neck was tired, I finally decided the squirrel had traveled the branches to other trees. Satdown and after awhile the old Senj came over and joined me, so we both rested. All of a sudden he took off at a dead run like a bee had stung him and circled a tree about thirty feet away, and as the squirrel moved to watch the dog, I caught the movement and got the squirrel. Whether the Basenji heard or scented the squirrel, I know not, for they are adept at both as well as having good vision. Have seen them discern a movement two hundred feet away, and at a dead run give chase.

A squirrel that made a mistake last year was one that came out of a patch of timber and started across a three hundred foot patch of grass towards another stand of timber as I pulled in a drive. One of my Basenjis was with me, so I let him out of the car and away he went in hot pursuit of the squirrel. Oh yes, the mistake - you see there was a huge burr oak tree in the center of the clearing and the squirrel passed it up to try for the other timber - didn't make it.

A draw back to squirrel hunting is the fact that when you go after quail in the fall, the Basenji will be looking for them in trees and you just don't find too many there. However, after the first hunt he will settle down to the business at hand.






### Junior Handlers


This month I received an article on Judith Ellam's problem of a fence climbing Basenji.

Diane Berry, a breeder and judge in England has three suggestions: 1. A fence or top of rather loose chicken wire. 2. If the fence is turned over on the inside so when the dog bumps into it, he can't hold on long enough to get over the top. 3. Have small laths placed about every ten feet and string wire from lath to lath with about 1-inch pipe then when the dog tries to climb over the pipe, it would roll, causing the dog to fall back.


The suggestions are illustrated below:

Mrs. Berry also wrote, "We don't do things over here quite as you do. Most owners handle their own dogs. It is unheard of to have anyone else handle unless the owner has two dogs in one class or is unable to make the show.

"Most shows can be reached in one day, and be home again.

"Also, there are very few young people in Basenjis. I think I am right in saying that my son, aged 16, is the only active exhibitor who handles my dogs, and owns an Ibizan himself.

"He handled HOBBY HORSE to Best in Match the other evening at what you call a fun match. We have all breeds at these shows and three classes: puppy, novice, and open."
