From Francis Dalvin, 38 Windsor Road, London, England

The September number of your excellent magazine carried an article, "The Basenji in Africa" by Mrs. E. Ford. This is so full of unfounded hypothesis - not to mention downright inaccuracies that it demands to be challenged. An examination of all the doubtful issues raised by Mrs. Ford would take up too much of your space and my time, however, you may find room for the following six observations:

#### 1) THE MAP

This is decidedly peculiar. Mrs. Ford's Tanganyika is in fact, Ethiopia; her Sudan is approximately Chad (well over a thousand miles from the source of Sudanese Basenjis); her Egypt is a strange shape comprising Egypt, Sudan and part of Libya.

2) "The Congo and the Sudan may have been the first countries visited by the white man and specimens of their dogs brought to England."

The first Basenjis to be shown in England, in 1895, came from the Congo. Then, in 1923, six were obtained from the Southern Anglo-Egyptian Sudan. Now, it must surely be agreed that all the coastal areas of Africa were "visited by the white man" well before these dates. If true Basenjis were to be found there, why were they never reported? All the earliest reports of barkless hunting dogs came from comparatively inaccessible regions of the Congo and the northeast Congo-Sudan border area. It must be assumed that, if the Basenji had ever penetrated further south and west of this area, its stock would have been so diluted by crossbreeding that it was unrecognisable as a separate breed with very marked characteristics of its

3) "More than likely, gifts were made of breeding pairs to neighboring African Chiefs."

There are no records of such gifts. Indeed, there is no reference to any "African" (i.e. negro) chiefs throughout the history of the ancient Egyptians. When they traded at all, they did so with civilisations, not with negro tribes, whose existence was either unknown to them, or unworthy of their notice. If such gifts had been made to anyone, surely the fruits of these gifts would be perceptible among the Mediterranean nations with whome they did trade.

4) "The Egyptians were explorers, traders and wanderers, and . . . their Basenjis would certainly have gone with their masters on their trips."

This hypothesis is ingenious butunsupported. There is, however, a theory that I have not seen put forward, which might support the presence of Basenjis, or Basenji-like crosses, in East, Central and West Africa. The slave-traders of a mere two centuries ago, trampled their way down the east coast; they might have brought Basenjis with them if they had passed through Basenji country in their line of march. This is not likely, however, since their forays took them, for the most part, well to the east of such country. The trains that crossed Africa to the west, on the other hand, passed through Basenji territory on their way to Northern Nigeria and beyond. Their cargoes of "black gold" were then dispersed to the west from the ports of West Africa. Their influence was powerful and prolonged enough, over the years, for their Muslim faith to be adopted by most of the peoples they regularly visited in their traffic, and if their faith had time to take root so successfully, their livestock might also have left more than a failing item. Moreover, since it is the glory of the Muslim to journey to

Mecca as a "Hadj" at least once during his lifetime, the long, steady "caravan" of such pilgrims may yet be another path for the dissemination of the Basenji.

5) "The African male eats first, then his wife, followed by the children, and about all the poor dog gets is to lick out

This is less an inaccuracy than a meaningless generalization. Can Mrs. Ford really believe that such a procedure is common to all the myriad tribes and sub-tribes of Africa? There are few records of the relationship between tribesmen and Basenjis, but those we have stress the high regard in which the man holds the dog.

6) "The original Sudanese owners perhaps did not care for the black and white dogs so they were the poor unfortunates who ended up in the cooking pot."

This conjecture is nonsence. Black and white Basenjis are very highly prized, since they are considered to have magic properties (or medicine) of great value. The brindled Basenji, whose very existence appears to be denied by some self-styled "experts," is also prized, and is therefore rarely offered to an intending purchaser's view. Whether this is because of its magic worth, or because it is a more successful - and less vulnerable hunter, by reason of its "camouflage," is still a matter for investigation.

You will notice that, far from denying the possibility of the existence of Basenjis elsewhere than in the Congo and Sudan, put forth (at 4 above) a theory that could explain their presence. However, I do not know that they exist elsewhere, for nobody, so far as I know, has yet produced a photograph of a recognisable "pure" Basenji from any other place. Perhaps they are to be found as far west as Gambia, but the contention that the St. Paul River impeded their discovery in Liberia cannot be correct. Masks and other objects from the Gribo, Kran, Guere,

The 1967 Western Specialty was held in conjunction with the Colorado Kennel Club All-Breed show, on Sunday, September 24, with Mr. Louis Murrjudging the regular classes and Mrs. Dessie Lutes judging the Puppy Sweepstakes.

A pre-show dinner was held Saturday evening at the Holiday Inn - Airport, where 65 Basenjites enjoyed a most delicious buffet dinner. A film on Crufts Dog Show, held in England, pointed out many of the differences between the American and English dog show system, provided interesting entertainment for the evening.

Basenji judging was scheduled for 8 A. M. The ring was very large and the trophy table most impressive with the numerous pieces of silver lined up, waiting to be taken home by the lucky winner. The Hi-Country Basenji Club members decorated a breed booth, which was placed a short distance from the Basenji ring. Members of the decorating committee for the booth and dinner certainly are to be congratulated on their skill and imagination in working up the decor. The miniature native village, complete with grass huts, natives, etc., that was on display attracted a good deal of attention and certainly spoke well for Jeanne Theno who created it.

There were 82 Basenjis entered in the regular classes plus 1 veteran and 4 obedience entries for a total of 87 entries representing 16 states ranging from California and Washington on the west coast to New York and Pennsylvania on the east, and Texas and Louisiana in the south, and Wyoming from the north. With 6 absentees, the final breakdown was 27 dogs, 32 bitches, 17 specials, and 1 veteran.

The Puppy Sweepstakes classes were judged first and Mrs. Lutes had an impressive entry of 15 dogs and 18 bitches anxiously awaiting her decision. Mrs. Lutes was quite thorough in her examination of each dog and her choice for Best Puppy was Mrs. Jan Magee's puppy bitch, SPEARWOOD SASHAY OF SARTARTIA (Merlea Sunshine of Spearwood x Spearwood Moonlite Witchery). This little gal has a deep red coat, an abundance of wrinkle and should mature into a lovely bitch.

The judging of the regular classes immediately followed the puppy sweepstakes. Mr. Murr was very deliberate and spent an equal amount of time with each dog before choosing the dog in each class that he felt most closely represented the THE BASENJI NOVEMBER 1967

breed standard. Mr. Murr chose for his Winners Dog, the open dog class winner, TAMARANGO BRIGHT ALPENGLOW (Ch. Bwana Akers' Solemn Promise x Ch. Ringtail Yodel Lady) owned by David Seaberg. He is a very flashy dog with excellent expression and good movement. Reserve Winners Dog was SANSABRA'S BEZNEE MARTINEE, owned by Carl and Gladys Valence.

Winners Bitch, also Best of Winners, again from the open class was JOLLY RED ROBIN OF KELYN (Ch. Peregrine of Rossanty x Ch. A Black Corker of Ouimac) owned by John and Barbara Thibault. She has a lovely head, neck and topline and is nicely built. Reserve Winners Bitch was SPEARWOOD BEDAZZLE OF BAKUBA, owned by Ragna Spears.

The final moment of judging arrived when the 17 specials, one veteran and best of winners all lined up in the ring for Best of Breed. Dogs were judged first, then the bitches and after much deliberation the final nod went to CH. KHAJAH'S GAY LANCELOT (Soubrise of Horsley x Ch. Khajah's Gay Fula Charm) owned by Robert and Betty Yanowitz. LANCELOT is a real showman and deserved this fine award.

Best of Opposite Sex was awarded to the very typey, sound moving CH. FRAZEE'S FOREVER AMBER (Ch. Forrest's Charmin 'Lil Buc x Kiljongo Royal Jennifer), owned by Mrs. Catherine Frazee and expertly handled by junior Basenjite, Terri Wood.

### Basenji Club of New England YANKEE DOIN'S

I would like to know what Basenjites mean when they refer to type. It always seems abstract to me that the meaning a breeder is trying to convey when he advertises "typey pups" or an elegant moving showman with plenty of "type."

I have my own idealistic definition of what I think type should be. To me, "typiness" refers to near perfection of the breed standard. If a dog possesses nearly flawless conformation coupled with the ability to move out, I think he can be defined as "typey." Such a dog is hard to find taking the standard

How many of us do rely solely on the standard as a basis for judging our dogs? Many times I have seen examples of personal preferences overruling what is specifically spelled out by the standard. This leads me to think the word "typiness" is meaningless - that it refers to only one owner's viewpoint of type. I have seen a heavy-boned, cream-colored dog who barked, referred to as "typey," apparently because he had an excellent gait and a fairly level topline.

I don't think kennel blindness is the problem. Most of us know our dogs' faults although we rightly don't go around publicizing them, unless doing so will help the entire breed as with the eye problem. But what about the cases where personal preferences override the standard? Where do we stand when one breeder specializes in heavy-set Basenjis because, "They are a hound and should be rugged enough to do the work?" Isn't heavy bone a serious fault? What is "heavy bone" anyway? There will always be arguments that a dog is not heavy-boned, just because it has more bone than a very fine specimen. Where do we draw the line? With each person having a different idea, what is happening to our beloved breed? Are we, as Bob Mankey said in "The Basenji" some months ago, just trying to preserve the breed? It seems to me that there are enough ardent devotees to ensure preservation - and promotion. With the breed's popularity increasing as it is, we have to think above mere preservation or the breed may very well turn into a degradation which would have been better left wild in the jungle. Since Basenjis are a natural breed, perfection is not the correct word to use regarding their development. Shouldn't we be striving for a universal interpretation of the standard? We already have two types emerging - the light and heavy-boned dogs. There is also the color preference and the known fact that it is more difficult to finish a tri than a red and white. I am not saying all this to criticize and condemn half the Basenji fancy, but we all have to stand together from the beginning.


It is not too early to be thinking about what happened to several other breeds, for instance, many years ago the English Setters virtually split into two different breeds - the Lavarack or "bench type" and the Llewellin or "field type." It was maintained that the bench dogs were too large to be of great value in the field so the Llewellin strain was bred which is smaller, lighter, and considerably faster, making showy field trial dogs. Our differences are not so vast and no one wants to separate the Basenjis into two breeds. But it is something to ponder: what are our aims and what are our dogs going to be?

Recently there was an article in a well-known dog magazine entitled, "What Judges Want." Let's change this to "What Breeders Want," and see if the results will be better. If you disagree with the present standard, then endeavor to change it, don't take it out on the breed by creating dogs to fit your personal likes, disregarding the rules set down by the B. C. O. A. To function for the betterment of society, rules must be set. To function for the betterment of humanity, they must be fol-

We've been trying to find out some information about you so that other juniors may meet you, but not many of you have answered. We know you're out there, and active.

- 3) Request the local clubs we belong to, to write to the A.K.C. in our behalf.



# TIPS FOR TRAINING Especially for Basenji-owned people

as told to Jo Ann Weller, 6430 Estes, Arvada, Colorado by Sally Terroux, Professional Trainer and Handler

(Continued from October issue)

#### CORRECTIONS IF NECESSARY

A major goal in training a Basenji is to PREVENT bad habits. Hopefully, you will make it impossible from the beginning for him to do it wrong, or make a mistake, so he works only knowing what's right and does it enough times so it becomes a well-formed pattern of behavior. Stop the dog from doing the thing wrong when he BEGINS to do it. Catch him the moment he STARTS to misbehave - don't wait until the deed is done and then correct him - it's too late at that point because the Basenji does not respond to corrections as do other dogs. The Basenji is more likely to resent the correction (even to the point where he will completely refuse to do the exercise regardless of what happens to him) rather than react with more effort to please you. If you get to this impasse, you generally have to go back to an early form of exercise and "guide" him with firm control into doing it right. This should be repeated until once again, doing it right, is the pattern. In a way, the Basenji's intelligence is a handicap, for he and you must see progress, but you must not progress too quickly for he may not be secure in the exercise and this may make it necessary to repeat, which is boring for both of you.

Corrections must be kept to a minimum, and once a correction is made, you should not have to repeat it. Corrections should be fewer and gradually firmer. Compromise, if necessary, to succeed, but make sure your Basenji does succeed in doing what is expected before the exercise is left. If he won't go and get the dumbbell after a number of tries and you figure it's about time to quit on that, make sure he picks it up from right in front of him, or back track the exercise until it gets so simple he does it. Then, after lots of praise (his kind) repeat the steps of the exercise until you are back where you left off with a row of successes behind. Don't let the Basenji stay at the same stage too long — if he repeats the same mistake time after time, make sure the corrections become more firm with each correction.

The nylon training collar is a tool for guiding the dog into doing what's right. It is ideally suited for making it impossible for him to err - a key to successfully training a Basenji. The nylon collar is especially effective as it is used to give a long pull rather than a sharp jerk. This is not a form of discipline but instead forceably guides the dog into doing what you want. It prevents him from not doing what you want! The chain training collar is used for the short, sharp corrections. Start training your Basenji with the nylon collar (get one that fits closely - just barely goes over the ears) and use if for about the first six weeks. At any time later that he goes not respond well to the regular chain collar, go back to the nylon collar to reestablish his attention (by making him very uncomfortable when his mind or attention wanders). Use a very light weight, quarter inch, leather or web lead and snap. Have a 4inch handle which can be used as you start off lead work. This will be after you have had him on long and lighter cords for some time.

The less a Basenji sees a correction coming, the better. The more it can appear logical, the better. If it seems to be that the correction comes from his not paying attention, e.g., when you run into him on a left turn, he responds by paying attention. In other words, when heeling, if he forges ahead or lags, a quick right or left turn with a short, sharp jerk comes as his fault for not paying attention. Wandering attention is

often a problem with the Basenji and sometimes even for the handler. A quick change of pace or direction which brings a quick correction (or in his mind, causes him to be run into or stepped on) should serve to re-focus the dog's attention on the business at hand. It is better to keep the corrections with the handler and not have an outside person do any correcting. Again, you know your dog, and you are the one who should administer corrections.

OFF LEAD

The dog that is secure and sharp in his on-lead work, tends to behave just the same off-lead. Therefore, you should follow the same sort of steps in off-lead work as you have for on-lead. However, start carefully - extend the length of the lead to six feet, then twelve, then twenty and thirty, have him drag a light line before trying the recall completely off lead, but when you DO go off lead, have confidence in him. Do your first off-lead work in a confined area (room, porch, etc.), this will again help you avoid the need for corrections - there will be no place for him to go. The positive and confident attitude of the handler is the essential ingredient in off-lead work. therefore, only when the handler has true confidence in his Basenji, should he attempt to go off lead with him. Don't run the risk of doing it too soon, it's better to delay it a couple of weeks than have to retrench because you did it too soon. Despite a high degree of confidence in your dog's readiness, however. do take the normal precaution, i.e., short strap or handle on collar, confined area, etc.

On off-lead, expect and demand the same attention as on-lead. Never act as if you have less control because the lead isn't there. The Basenji is quick to sense a helpless or less than positive approach. Remember that anytime your dog is in a confined area, you do have control, off-lead or on. If the dog does not obey, shout "NO" at any distance immediately. Walk calmly to your dog, take him by the active ring of the collar and correct gently, but firmly. Always walk, even if the dog runs away. Never run, never grab for the collar, never correct harshly when you catch the dog (it will only take longer to catch him next time). Approach him matter of factly, correct him the same way. If two off-lead corrections are necessary in one lesson, place the lead or cord back on the dog.

The way each session ends is as important as what goes on during the session. If you finish a training session by immediately taking the lead off and letting him tear around, he will probably get the idea that anytime the lead is removed, (continued on page 23)

### VETERINARY JOURNAL

"LEPTOSPIROSIS: FIERCE AS IT SOUNDS"

Most "germs" are rather dull looking even when viewed through an electron microscope. There is, however, a noteable exception to this - a particular one belonging to the family of spirochetes. It belongs in the genus leptospira and looks as mean and vicious as the disease it produces. . . leptospirosis (lep-toe-spy-row-sis).

Leptospirosis is of great importance because it infects man and the animals he associates with: horses, cattle, dogs, cats and rats. There are two main species of the organisms of

This disease is of considerable importance to dogs and cats in which it produces symptoms similar to those found in man. It is also found in rats which are considered to be the natural reservoir of infection. Both species will be treated under one heading for the purpose of discussion.

The disease in man was first noted by Dr. Weil in 1886 and was called Weil's disease. It was confused with yellow fever as late as 1928. This disease is world-wide and has received considerable attention from the World Health Organ-

Leptospirosis attacks the kidneys and if the infection is not treated early the kidneys become damaged so severely that they are unable to function. Kidney function is vital for the removal of wastes produced by the body cells. Without proper kidney function these waste materials build up in the body and death results from uremic poisoning. The body literally poisons itself.

The disease can be either acute or chronic. As it grows in the kidneys it is also shed in the urine which is the method of infection to other animals, although it is probable that some cases result from mating contact.

If the infection is present in cattle, it will be passed in the urine, washed into ponds where it can live and children who swim in the water; dogs, cats and other animals who drink the water can become infected.

The disease is most common in male dogs from two to six years of age. This is because of the sexual-social habit of male dogs to leave the odor of their presence by urinating on shrubs. Other male dogs come along and sniff the odor and contact the disease.

The disease is not as common in cats because of the habit of burying their body wastes.

The prevention of leptospirosis is primarily vaccination. The vaccine contains both species of the organism and your veterinarian will advise and recommend the proper times for vaccination, Booster shots are necessary. Dogs should be discouraged from "investigating" shrubs or hydrants when they are walked.

All dog food should be in rat-proof containers and only commercial dog food of proven cleanliness should be used. Beware of the "special deal" from an unknown dog food manufacturer. The cheapness of the food may be due to the original soiled condition of ingredients. Kennels should under all circumstances eliminate all rats. The disease is of such a serious nature that hospitalization in an isolation ward would be necessary. Serum, vaccines, antibiotics and intravenous feeding used by your veterinarian, followed by special diets can save the life of your pet, but not always. Leptospirosis is a killer. Immunization is the answer.

When it's necessary to give your dog a pill, try to put it inside a small ball of hamburger. It usually goes right down and your Basenji has an unexpected treat.

I have never before tried to keep an entire litter of pups until I could be sure which one or ones I wanted to keep. The pups at age three months are proving almost too much for this working woman to cope with. In between litters, I forget just how full of energy these little devils are. Beverly and Don Shurts bought the sole red and white pup, but since their home hasn't been completed, I offered to keep KAM until they can take him. Every Sunday I pack a box lunch for the pup and his folks come over from Honolulu to pick him up for the day. An extra dividend is that sometimes Bev brings me home-baked (or apartment-baked) bread.

A puppy match, benefit for the Humane Society, is slated for October 8, and I hope for a fantastic turnout of Basenji pups. After that we will look forward to an obedience match in December with five Baseniis entered in competition.

Lt. Col. Beverly Neal, who bought one of HAK TIM'S pups a year and a half ago, wanting to breed his JADOO to KEIKI. Col. Neal has decided that Basenjis have the sight and nose, the size, and the intelligence he is looking for to quail hunt in his native Georgia. So far, all attempts at breeding has failed, but at 20 days in season, JADOO is still showing bright red, and I have read that sometimes Basenjis don't reach the top of their cycle until 25 or even 28 days.

Bev Neal pig-hunted JADOO just once with a pack and said she outran the pig. When Col. Neal retires in Georgia, he should find a real meeting ground with Basenji-oriented folks.

It seems like every female Basenji in town is in season. I got a call from a stranger the other night wanting to breed to one of my males, and honestly told him I thought the market would be strained unless he already had homes lined up for the pups. I think it also sobered the man up when I told him about the shots, worming, etc. That it ran about \$35 per pup, not counting food. I still have vividly in mind that little pet store pup last year who led such a wretched life until the Toths took

#### TIPS FOR TRAINING (continued)

this is the thing to do. It is better to make a point of removing both collar and lead, perhaps shifting to the collar he associates with play time. Watch the kinds of patterns and habits which you establish.

If you plan to enter competition, or in any instance, move quickly during training sessions. Take short, brisk steps, make sharp right and left turns - keep the Basenji moving fast on the recall - don't give him time to think! If you move quickly, he will tend to move with you since you don't give him time to figure out that he might prefer doing something other than what you want him to do.

IN SUMMARY

A Basenji is different from other dogs in many ways. These differences can be an intriguing, though challenging asset to you if you learn to understand the "hows" and "whys" of your Basenji's reactions. He understands and reads you better than you may realize - spend some time learning to understand and read him - it will be time well spent.

SO: Learn to know your Basenji as well as he knows you. Praise him according to his individual likes, know what your dog considers praise.

Prevention is the best training technique you can use with a Basenji.

Corrections must be logical and judiciously employed. Persistence is an essential pre-requisite for anyone training a Basenji.

Plan now to train your Basenji and begin building confidence in yourself and your dog. The process can be fun, and the result is a most rewarding partnership.

The dog's name on the entry form should not include the prefix "Champion" unless the championship has been confirmed by AKC.

Further, no points will accrue to a dog that is entered and shown in "Specials" as an unconfirmed champion. If through error in the owner's records it is determined that additional points are needed, the dog must be returned to regular class competition.
