

Handled by Mrs. Ellen J. Snyder of Memphis, Tenn., SHANGU went Best of Breed at Biloxi and Pensacola, then placed second in the Hound Group at both events, under Judges J. W. Trullinger and L. J. Murr.

Great things can be predicted for this remarkable red and white dog, who is just a few months past his first birthday.

SHANGU was first shown in the puppy class last summer at Champaign, Illinois, just past six months old. Going Winners dog there, he earned his first two points and at Kankakee went Best of Winners, adding four more points toward his championship.

It was a daring step to enter the puppy, then not eight months old, in the Chicago International all breed show where Shang faced an entry of 88 of his breed, including 17 specials.

He took the puppy class with an entry of 11 easily, showing like a veteran, then marched to victory as Winners Dog and collected five points. Mrs. Snyder relates that Shang seemed infested with the will to win; he never once faltered in his impeccable showmanship.

After taking Best of Winners, Shangu met with his sire, CH. RAS AMIR OF HILLS HALF ACRE for the selection of Best of Breed. It was a proud moment for Ellen Snyder when Judge William Kendrick pointed to young Shangu as his choice of Best of Breed.

This was an auspicious beginning for a mere puppy, against such stiff competition and he continued his winning ability the following day at the International by placing third in a group of 20 Hounds, under Judge Hollis Wilson.

This remarkable dog, whose glistening coat picks up rainbow hues, has been a consistent B/B winner and on March 7. 8. and 9 was again B/B at Chattanooga, Knoxville, and (continued on page 9)

### **CURLY TALES FROM THE ROCKY MOUNTAINS**

The Hi-Country Basenji Club, Inc., held its bi-monthly meeting on Sunday, March 5. After an informative film on hunting dogs, a brief business meeting was presided over by our Vice-President Jan Magee, in the absence of the president.

One of the main issues under discussion was a letter received from The American Kennel Club rejecting the club's bid for recognition as a specialty club at this time. The A.K.C. suggested several changes in our by-laws might be in order, and our by-laws committee is now studying these recommen-

Just prior to our meeting, our secretary Mora Huskey received word from David Hill, the National Specialty Chairman for The Basenji Club of America, that the club's request for a B. C. O. A. supported show on June 9, in conjunction with the Southern Colorado Kennel Club show in Pueblo, Colorado, has been approved. The Hi-Country Basenji Club will be donating trophies for this show for Best of Breed, Best of Opposite Sex, Winners Dog and Winners Bitch, and first place in Puppy Dog and Puppy Bitch classes. In addition, there will B. C. O. A. medallions for first place in all five regular classes (Puppy, Novice, Bred by Exhibitor, American Bred and Open) and also for Best of Breed and Best of Opposite Sex. This supported show is the second of two shows to be held on this weekend. The Saturday show being the Colorado Springs Kennel Club show. The club is planning an informal luncheon after the judging on Saturday, June 8, for all exhibitors who wish to get better acquainted with their fellow Basenii fanciers.

TOP SCORING OBEDIENCE BASENJIS DURING 1967 -The American Kennel Club has now published all show results for obedience trials during 1967. It is interesting to note that in 1967 there were 34 Basenjis competing in obedience trials that earned, at least, one leg toward a degree. Thirteen of these were champions of record at the time they were competing in obedience. Of the total competing, 28 were entered in Novice, 6 in Open and one of the six open dogs qualified for his C. D. X. degree and went into Utility class. I want to congratulate Mr. Vernon T. Cash, owner of CH. BARANFIELD'S CYCLONE, C. D. X., the Basenji that earned his first leg toward his Utility Degree in 1967 with the impressive score of 185 1/2. So far a Utility Degree has been beyond the reach of Basenjis but Mr. Cash is knocking on the door and we wish him every success. For the conformation enthusiasts who might be a little in the dark about obedience degrees - the U.D. is as highly valued to the obedience trainer as a Best in Show award to the conformation exhibitor.

# Basenji Club of Canada

The Basenji Club of Canada regrets to announce that. because of a combination of unforeseen factors, our British Columbia Division people have been unable to proceed with their plans to hold a Far West Canadian Basenji Specialty this year and have cancelled their show date of June 29 and have advised the Canadian Kennel Club of their decision.

The plans for an Ontario Specialty show are still very much alive and at a recent meeting held at the home of Diane Vieira, February 24, the results of a ballot on the choice of location showed a close vote in favor of the show being held with the Greenwood Kennel Club, Toronto, Ontario. Based on last year's show date, this would be a mid-October Basenji Specialty show. The unanimous choice of judge is the well known and capable United States Basenji judge, Norm Wallace.

Confirmation of the actual show date will be announced as soon as official C.K.C. approval has been granted.

Mrs. Heather Logan, Niagara-On-The-Lake, Ontario. is the trophy chairman for all Ontario booster and specialty shows, and not Mr. Tom Potter as reported in February. Mr. Potter was in charge of the advertising project for raising funds and it was assumed (incorrectly) that he was looking after this proposed show.

The report on the Scarborough, Ontario, 1967 Booster overlooked a very nice five point win by a very smart looking little lady KI LEIGH'S ENCHANTING TANYA, owned by Thomas E. Potter, Elmira, Ontario. This win (over 13 bitches) completed her Canadian championship and she should have been included with the other new Canadian champions reported.

It is too early for reports from the recent Victoria. B. C. shows, but a report from Peggy Baldwin, Calgary, Alberta, advises that FULA MIKIA OF THE CONGO, a red and white, owned by Mary Lou Sinclair, Castlegar, British Columbia was Winners Dog at the Alberta KC show, February 17, 1968 and Mrs. Baldwin's WAZIMBA'S HE-HAKU-KA'AO went Best of Breed.

Again I refer to the February report in which it was stated that it was believed that a three color litter from Mrs. Gamble's BLACK M'BUTI OF THE CONGO was the first such litter whelped. This term applies only to Canada. I have been advised that this litter was a year later than the first such litter (continued on page 7)

# Heart O'Northland Basenji Club

One of the largest department stores in Minneapolis had a pre-Valentine's Day "Puppy Love-In" in their auditorium. Local breeders were able to bring their registered puppies here to sell. Cockers, Beagles, Schnauzers, St. Bernards, Shelties, Poodles, Shepherds, Brussels Griffons, Salukis and Basenjis were among the breeds represented in this sale. Sally Robben, Forest Lake, Minnesota, brought two tri puppies and I brought two red and white pups.

Last year, about this time, I had taken a couple of pups to the Minneapolis Boats, Sports and Travel Show, along with our KALI HEIGH, C.D. who was there to demonstrate obedience work. In one year's time we found that the public had learned much about Basenjis and were accepting the fact that they do not bark as being desireable rather than pathetic. Questions and remarks last year went something like this: "What kind of dog is that?" You tell them it is a Basenji. "A what? Doesn't bark! Who'd want a dog that doesn't bark!" Or "Oh the poor things!" "Are those Rat Terriers? Fox Terriers? Or even "What kind of Spaniel is that? Their coats are so short, have they been shaved?"

This year the public sounded more like this: "Oh look, there's a Basenji." (this was generally pronounced BASS-n-ji). "They're the kind that don't bark." "That's what I need, my Dachshund, Poodle, Terrier, etc., is driving me crazy with his constant yapping.""Look at those nice short coats - no dog hair problem around the house. Can you make them yodel?"

One fellow mentioned that he had had a Basenji and always wanted another. He choked a bit after the price was mentioned, understandably so as the price he paid for his first Basenji was one rabbit.

It was the Schnauzer, Cocker and Beagle breeders who sold all they had brought down by noon. Still it is gratifying to know that the Basenji is getting to be better known. Another thing we noticed is that people recognized the tris and reds as

Many of the breeders there, are regularly seen at the shows and obedience trials and it was fun chatting with them. We talked to one couple who raise Salukis. While discussing the origin of both breeds, they mentioned that a mumified Saluki had recently been found that dated back to 6000 B.C.

This "Puppy Love-In" afforded a great opportunity for us to show our dogs to prospective buyers. Advertisements placed in local papers bring calls, but when winter weather is bad, no one comes out. This particular store took a ten per cent commission on whatever you sold there and the beauty of this deal is that if the prospective buyer wanted to he could charge it to his account at the store and by the end of the day the store would have a check for you. However, when someone was very interested, we encouraged them to come to our home to see the pup's sire and dam and discuss it further. We just couldn't see selling the pups right then and there. This system worked very well. The store did a lot of advertising via newspapers, radio and television. Sally had her flashy tri puppy, POPLAR HOLLOW'S DARK CHAKA on a daytime TV program prior to the sale. They also featured other breeds the following day on another program. The evening after the sale the newscasts carried a filmstrip of the sale which included a closeup of our SOFT WIND'S SEA ROBIN looking terribly worried about the whole affair.

Apparently the breeders were not the only ones that benefitted from this sale as I understand the kennel club in St. Paul is arranging the same type of sale at the St. Paul store. I hope it becomes an annual event - it was amazing how many people turned out for it.

On March 3 at Land O'Lakes Kennel Club Sanctioned Match, with four Basenjis entered under Judge Don Sandberg, Best of Breed and Group 3 was SOFT WIND'S SEA ROBIN, G. and K. Pecore, owners.

I was very interested to see the photograph of the black and white Basenji, COPTOKIN THE BLACK ASHANTI in the December issue.

Up until now I had assumed that the black and whites were due to a recessive gene which means that it must be passed on by both parents. However, I was intrigued to see that this dog was sired by ANDERSLEY ATLANTIC.

I am relatively new to Basenjis, but I do know that ANDERSLEY ATLANTIC has been a leading stud dog both in Great Britain and the United States for many years (my own bitch is a granddaughter of his, with FULAFUTURE OF THE CONGO as her other grandfather). Over this period of time I think it is inevitable that a good deal of in-breeding or linebreeding has been carried out with ANDERSLEY ATLANTIC and his offspring. If he carries a recessive black and white gene, then surely this would have shown up well before now.

This suggests that ANDERSLEY ATLANTIC does not carry a recessive gene for black and white. Therefore, as he has sired a black and white pup, the gene for this must have come only from the dam, and is not recessive.

There are several possible explanations for this that I can think of, but the only real solution, of course, is to await the results of further breeding. It will be interesting to see what happens when the following matings are carried out:

(a) Black and white to black and white. (b) Black and white to tri-colour. (c) Black and white to red and white.

If, however, it does eventuate that the black and white gene is a recessive one, then it must be in a different series from the red and white and tri-colour genes. This is readily proved. I understand that ATLANTIC is red and white and that he has sired tri pups. This means that he has one gene for red and one gene for tri. As any dog can only have two genes of any series, his full complement is therefore accounted for, and the black and white gene, if carried, must be positioned in a different place on a chromosome.

I am very interested in the genetics of the Basenji, but have not been able to locate much material. It may be that someone has formulated some rules beyond the simple red and white or tri-colour relationship which is well known. The sort of thing I have in mind is whether or not there are any predictable results of mating two single curl tails, single curl and double curl tails, or mating two double curls. Also coat length. I am aware that in some breeds short coat is dominant over long coat, whereas with other breeds the reverse is true. What is the position with the Basenji?

In a small country like New Zealand, it is inevitable that the choice of top quality sires is limited, and this means that breeders have probably had to compromise rather more than is desirable. It then becomes important to be able to predict results in order to make best use of available stock.

My wife and I have been thrilled with every copy of The Basenji we have recieved, and wish you every success.

PARASITES II

As was stated last month, the nematodes or roundworms, which make up the third classification of common internal worms, may be found in the intestines, stomach, kidneys, lungs, heart or skin.

Two common intestinal worms of this class are the common roundworm and the hookworm. Both are seen daily in this area and both are a genuine menace to cats and dogs. In addition, the life cycles are similar as are the methods of prevention and control.

The roundworm may be easily seen by the pet owner when the animal regurgitates the spaghetti-like shapes or passes them in the stool. Not so obvious is the hookworm, which is only about one-fourth inch in length and thread-like in appearance. For this reason, it is strongly advised that periodic microscopic stool checks be made, especially in the first year of life as the pet has not yet had time to build up any form of immunity against these parasites.

An important fact to remember is that dogs and cats can become infected by these worms before birth - if the bitch or queen was infected prior to the pre-natal period.

HOW TO PREVENT PARISITISM

How do we keep these parasites from infecting our animals? Whenever preparing a bitch or queen for breeding, a routine fecal examination should be made and deworming carried out if diagnosed. When we seek to prevent parasitism from contaminated ground, we must realize it takes about five days for deposited eggs to hatch into infective larvae. So, if the feces are scooped up daily - not hosed down, as this just

tends to spread or broadcast the eggs over a much larger area - we can disrupt the cycle before it has a chance to get started. If the larvae have hatches, the area of contamination is small because the worms do not tend to migrate but rather stay in the original spot. In addition to this, hookworms prefer a moist, sandy soil which further limits their distribution. Conversely, the eggs of the roundworm require a clay-type soil.

After hatching, the larvae are now in the infective stage and ready to complete their life cycle. Upon contact, the larvae, by means of a glue-like substance, stick to the feet or nose of the animal and enter the bloodstream either by ingestion or by boring through the skin. The parasites migrate first to the liver doing microscopic damage to that organ and then the lungs where further injury is inflicted. It is at this point that, as the larvae migrate up the "windpipe," the pet begins to cough and possibly vomit a white, foamy substance. It is here too, that a serious lung condition may develop in the run-down

When the larvae reach the back of the throat, they are swallowed and passed on down the digestive tract to the small intestine, where, in the case of the hookworm, they actually bite the tiny, finger-like projections that line the wall and make a continuous meal of the host's blood; whereas the roundworm merely lies in the intestinal tract and absorbs food intended for the host.

YOUNG PETS SUSCEPTIBLE

The cycle is completed when the adult worms reproduce and pass eggs out in the stools. Frequent re-infection is possible as the entire cycle takes only three weeks for the hookworm, and eight weeks for the roundworm.

However, the problem is more common to growing cats and dogs as adult animals usually develop an immunity to them in that the adjacent bodytissues form cysts around the invading



# CAPITOL QUIPS

#### by Agness Wood, 6913 Rancolph Macon Drive Alexandria, Virginia 22307

Puppies, puppies, puppies! The Basenji population of this area has increased enormously! With something like two hundred new puppies, we are hoping that at least a few of them will look good in this fall's shows. Since puppies are the big topic of everyone's conversation right now, I'd like to make a few personal comments on the subject. Eight litters in the past five years have taught me a few lessons the hard way.

- 1) Try to place your puppy in a suitable home. I consider a fenced yard or run a "must." I look for a home with children and people who sincerely love animals.
- 2) Tell the buyer all you can, bad as well as good, about his new pet. Nothing will completely prepare him for the torn upholstery and chewed Chippendale, but if he knows in advance he may not feel quite so bad. If the buyer isn't willing to accept the problems, then the time to find out is before the sale.
- 3) Advise the use of a crate for several reasons: it provides a place for the puppy to sleep, be fed, and confined for short periods when there is no one around to watch him. This is really essential when there is no warm, dry room where the young character can be kept out of trouble.
- 4) I do not advise young Basenjis for apartment dwellers. They are just too active for such cramped quarters, unless the owner has the time and energy to give them sufficient exercise. I also avoid owners who must be away for eight to ten hours every day. I have sold puppies under these curcumstances, but only after the matter was thoroughly discussed.
- 5) If you have show quality puppies, (and let's face it, many aren't), try to place them with people who will enter them in competition. A little assistance and encouragement offered to the new owner may turn a house pet into a champion and I find I'm just as proud of the customer's wins as I am of
- 6) If, on the other hand, you have puppies who are obviously not show quality; then sell them as pets, at pet prices. The buyer, of course, should be told of the puppy's faults, and why they are serious in a show dog, but not in a house pet. Generally, in these circumstances, and after explaining, I withhold the registrations, and in the case of a female, strongly advise that she be spayed (have this written into the contract, if possible).
- 7) Many new owners are not familiar with Baseniis and the more they learn about their own dog and the breed, the more enthusiastic they become. So, I make it a practice to furnish pedigrees and any other background information that I can. And tell them about all the reading material that is available. The new owners go home as proud of those pups as I would be of a new champion.
- 8) A new puppy is trouble enough for anyone unused to the tribulations, so I try to ease the path for the new owners as much as I can by insuring that the "young-un" is in good health, worm-free, has received, at least, his temporary shots, and is partially trained and house-broken. In short, I just don't sell puppies less than ten weeks old and it keeps me busy to have them ready by then.
- 9) With so many puppies around, one sometimes despairs of finding buyers, and the temptation to cut prices and deposits becomes strong. Resist it! At best, only a temporary advantage can be gained, and ultimately, both the breed and all the breeders will suffer. With partial payments, I insist on, at least half the full price before delivering the puppy. If, after a minimal deposit, the puppy dies, or is killed, the new owner

may be reluctant to pay the remainder. By securing at least 50% of the price upon delivery, I satisfy myself that the new owner has enough financial interest in the dog to take proper care of it. I am protected, and more important, the puppy is protected against carelessness or negligence by the new owner.

I am certainly no expert, and some of these points may seem too obvious to mention, while others may appear overly finicky, but as rules of thumb, they have served me well and I have never had any problems when I followed them.


# THIS IS THE BASENJI



A series on Basenji anatomy dedicated to the better understanding of the Basenji's bone, muscle, and organ

MUSCLES - the components of the muscular system in vertebrates are primarily concerned with locomotion.

1) Striated muscles are those which govern the wilful motion of the head, trunk and extremities. 2) Lever-type muscles are those connected at the shoulder blade and extending to the forearm. These muscles are concerned with flexing the forearm.





The placement of the scapula will determine how well laid back the shoulders are. The points of the scapula should be close to the point of the withers with the shoulders increasing in width to the elbows. The should be firmly placed against the brisket forming a straight line with the ribs, however, the placement of the elbows should not be so far under the brisket that the foreleg appears to foul the ribs while gaiting. The neck, shoulder and legs should present a smooth flowing line which adds to the grace of the Basenji.

Combine muscle development with shoulder and leg placements and you have the governing factor for the proper

larvae and thus prevent completion of the cycle. This explains why the bitch or queen may not show signs of worms and yet produce "wormy" offspring.

Another nematode of some import is the whipworm. This worm inhabits the caecum, a small blind pouch, which is attached at the junction of the small and large intestines. These animals typically suffer from chronically loose bowels that do not respond to treatment. A listless, unthrifty animal results. Identification is made upon isolation of the eggs.

Strongyloides canis, another intestinal worm, differs from the above worms in that the adult females bore into the intestinal lining and lay eggs which hatch in the tissues and so pass out larvae instead of the usual eggs. A microscopic examination is required for identification. This parasite likewise causes diarrhea.

The kidney worm is not common to this locale, so suffice it to say that this worm is long and thread-like and passes eggs to the outside via the urine.

A most interesting and unusual worm is the heartworm and is common in this area. This parasite is common to the

sporting breeds because of its unusual life cycle which uses the mosquito as the means of carrying the worm from one animal to another. House dogs, due to their environment, are relatively free of this parasite.

Stated briefly, the symptoms consist of chronic, unproductive cough, listlessness and easy tiring upon physical exertion. Diagnosis is made via a blood smear. Treatment is available in most cases but prevention is best and this is attained by keeping the dogs in the house at night, away from mosquitoes, or by using screened-in runs outside. This parasite will be discussed more fully in a separate article.

However, such business must not be allowed to continue, preying constantly on the dog fancy, mostly on the ill-informed, but trusting owner.


