A View From The Centre

One sometimes hears from the ringside such remarks as. "I don't know why he's put that one up - it's tail is low set!" Behind such a remark is one of three implications either (a) that the judge is so lacking in perception that he has failed to notice the fault, (b) that he is so ignorant of the breed standard that he doesn't know it is a fault, or (c) that he has noticed it, does know it is a fault, but for some sinister reason has preferred to ignore it. This, of course, is faultjudging at its worst, apart from being more than ungenerous to the judge who should surely be given the benefit of the doubt unless he has proved himself over a period of time to be incompetent or worse, in which case there would seem to be little point in either watching him judge or exhibiting under him. Like all fault-judging, it arises from incapacity or unwillingness to assess a dog as a whole. It is often accompanied by the lack of a sense of proportion, particularly in the difficult area of the assessment of the relative seriousness of the various faults.

The best corrective for such a failing is to find oneself in the centre of the ring, faced with the task of assessing a number of large classes, each containing enough good specimens to make it difficult to arrive at the final placings - at the rate of about three minutes per dog. This is not to say that there are not faddists among judges, so obsessed with a particular fault that their capacity to make a balanced assessment is seriously diminished, but on the whole judges of this type do not obtain many engagements. Generally speaking, it is wonderful how the exposure of one's critical capacities or weaknesses to public scrutiny, and perhaps one's heightened concern for one's reputation for fairness combine to produce a new tolerance and an attempt at generous, rather than carping judgements.

For those who find themselves newly in this position, there are, of course, a number of important prerequisites, chief among these being a complete knowledge of the breed standard, and of those qualities therein which define type, and a thorough knowledge of canine anatomy. Added to these, I feel, must be the experience over a period of time of viewing representative collections of the breed, and a sound knowledge of the most important qualities and failings at the particular point reached in the development of the breed.

Once in the centre of the ring, I am sure that judging techniques can help or hinder in the forming of balanced assessments. In my opinion, it is a dangerous practice to become too immersed in detail at an early stage, as this causes confusion with inevitable results. My own practice is first to take a leisurely walk along the line-up, noting obvious major qualities or failings in type and construction. In a large class, some exhibits can be virtually eliminated from the placings at this stage, although one must be careful later to check this assessment. Then I like to have each dog placed in the centre of the ring and view it from the edge of the ring, as I consider that viewing a dog from a distance helps me to make a truer assessment of its general balance and outline. At this stage I can assess such major points as size, height on the leg, general refinement, colour, shoulder layback, length of neck, length of back, topline, underline, set-on, curl and hindquarter angulation, among others. As I walk around the dog and approach more closely, I can assess head proportions, ears, expression, eye-colour, front and feet, coat and body shape from above. Movement next, often confirming points of construction already noted. All this without touching the exhibit. In my opinion, excessive handling by the judge is unnecessary. particularly in a smooth coated breed, and undesirable. I am sometimes amused to see judges passing their hands over exhibits in a most mysterious fashion, feeling and pulling at the dog in all the wrong places, as though they were playing a complicated blindfold parlour game!


Finally, with the dog on the table, one can check the mouth, width between the scapulae, and muscle tone, using the hands. Throughout these processes, I make very quick notes, using a private system of pictographs. This is not only to help me in writing my report, but is also of great assistance after the judging in answering exhibitors' queries. This can all be done at the rate of about two minutes per dog, on average.

One should then be in a position to eliminate all the exhibits with major faults of type and construction. This would include, for instance, wrongly coloured Basenjis, heavy, shortlegged ones, and those with plain skulls, no curl, undershort conditions, or excessively unsound movement. The second stage is to eliminate, mentally at least, those dogs which have a number of faults of a less serious kind or of a possibly temporary nature. This should leave one with several animals with few faults, and these not in the very serious category. At this final stage where the winners must be selected and placed, one must be positive in giving full credit for style, showman-(continued on page 21)



I started in obedience work in 1951 and had the highest scoring dog in the Nation in 1954 - a Chihuahua, of all things, with Companion Dog scores of 198, 199 and 199 1/2.

I obtained my first Basenji in 1955 - BEE-JAC'S CHUCK-A-LUCK. "CHUCK," now 13 years old is still very active and will still go through all his obedience exercises.

My reason for choosing a Basenji so long ago was because of the fact that I saw many coming through obedience classes that were surly and uncontrollable. It seemed to me that any breed of dog that was smart enough to get away with the things they were getting away with couldn't be all bad, and that it must be the handlers' fault.

I now handle all the obedience classes in Yuba and Sutter Counties and have had many Basenjis go through the course. I have also observed them in other training courses and thirteen years later I still hold strong to my original conviction - IT'S THE HANDLERS' FAULT.

I have yet to see a Basenji that wasn't trainable, but in thirteen years, I have seen many handlers that were incapable of training a Basenji.

I place some of the blame on the people who give the instruction, because so few of them know or understand our breed. Being in the training business, I have had the opportunity to speak with many other trainers. Most of them admit they hate to see a Basenji enroll in their class because they assume they're in for trouble.

I believe the biggest single problem associated with training failure is WOOL GATHERING.

Wool gathering (as defined in "Daugherty's Dictionary"), involves the lack of attention given to the dog by the handler.

All too many people take the dog out for his nightly training period, make the dog sit, command him to heel, take four steps forward and begin "wool gathering."

The women start thinking about "what the kids are up to" or "what to plan for dinner." Men think about "who's winning the ball game" or "what's for dinner." Juniors, who should have the shortest attention span and who (by national publicity) are supposed to never concentrate on anything, really do a better job than the adults.

Meanwhile, down on the ground, the wilv Basenii is not wool gathering - but he is always waiting for the handler to start, and unfortunately, he usually gets his wish.

Wool gathering causes inconsistency. A Basenji can take the wool gathering because when the handler isn't paying attention to him, he can do what he wants. Basenjis CANNOT take inconsistency. It makes no sense to a smart dog if he can get away with something one time (because the handler didn't notice), and gets his neck jerked the next time (because the handler saw him do something wrong).

Basenji handlers so often seem to feel they are handling a fragile piece of fine China and are afraid of giving consistent adequate corrections for misconduct. They mince along giving occasional, nagging, tormenting jerks on the choke chain, with the Basenji responding in rubber-neck fashion, until finally out of anger or embarrassment, the handler gives a mighty jerk, and yells, "Heel!" The dog responds in a rather defiant way and if he could talk, would probably say, 'Now wait a minute. just what in the world do you want?"

Most Basenji owners are aware that one of the breed's characteristics is that these dogs do not like to be cornered or threatened. Yet this is exactly what the dog feels when he has had his own way and has done what he pleased until his handler gets angry. (continued on page 27)

Breed clubs in well-organized metropolitan areas often

IT'S A VERY RARE BREED, MA'AM

What sets off a fad in dogs? How does it happen that a a breed called "The Aristocrat of the Canine World" - as so many are - suddenly turns up as the neighborhoood nuisance, the plague of the pound, and everybody's companion?

Our first thought is that movies and television foster such a mad 'pupulation' in a breed. We all know what Rin-Tin-Tin did for the German Shepherd; we've seen the Old English Sheepdog become a well-known breed because of his exposure on the screen.

Yet, somehow, this isn't the entire explanation. "Lassie" is a popular TV series watched by millions of people each week . . . and still the Rough Collie continues to be a popular, but not common, unexploited breed - in comparison with the German Shepherd or the Poodle. What television or movie series brought on the Poodle craze? Who knows?

Conscientious breeders will often protest that the presence of a breed in pet shops is responsible for multiplication of the breed, over-production, loss of quality, and eventual decay of both price and type as the puppy-factory contingent leaps into the situation.

The fact is, most pet shops and dealers will not carry quantities of puppies of any breed unless the breed is already popular.

In addition to this, pet shop sale prices are ordinarily higher than those offered by back-yard or cheap-operation breeders, simply because of the retailer's dependence on buying all or most of his pups.

Most kennels which wholesale pups to pet shops also make direct sales - at the same prices when they can, thus hurting pet shop sales instead of assisting pet shops in "cheapening the breed."

It is impossible, therefore, to blame pet retailers for propagation of fads, ruination of breeds and lowering of values. The demand must exist before the pet shop will handle the breed. And that's that!

Once a breed is established as a money-maker, of course, the pet shop enters the picture as quickly as possible. And where does the owner acquire the pups he sells? Nine times out of ten, he buys from a large-scale dog farm which did not even exist - or handled other breeds - a few months before the onset of the new fad.

Some of these dog-farm operations conduct business in a most reprehensible fashion. Others are strictly legitimate. clean, conscientious businesses with excellent reputations of long standing and passable breeding stock. Some good dog farms have existed for 20 or 30 years, occasionally changing or adding breeds but keeping consistently good standards.

Breeders in this category can seldom be blamed for the destruction of a dog - nor can the outlet to which they supply their product. They will stop producing the moment the market fails.

The "final blow" to a breed is then, not its early popularity just after "discovery" and publicity . . . it's what happens when, suddenly, one out of every ten or twelve pet owners is the proud possessor of X-Breed. The axe falls when the classified ads in the newspaper begin listing a dozen, two or three dozen telephone numbers at which "pure-bred X-Breed puppies, \$35 apiece" may be found. This is the path to destruction, not the publicity, or the wholesaler, or the pet shop! And HOW CAN WE STOP IT!

run classified ads of heir own, stressing the importance of buying well-raised, healthy pups from recognized kennels.

Such advertising may help the situation to some degree. Those who pay attention to the ads, the purchase of good (or "acceptable") stock through them, will stand less chance of being cheated, or becoming disgruntled to the point of wanting to strike back. However, the conscientious breed club member sometimes helps to cook his own goose to even a crispier crust than does the small wild-cat breeder with two bitches and a backyard. "How's that?" you shout. Well, take this hypothetical

You are a breeder of long-coated Sonoran Terriers, and have been for years. Although you belong to a breed club and exhibit your dogs regularly, you have always been hardpressed to find sales for your uncommon pups. Few people know what your breed looks like; nobody else in your part of town is offering pups for sale, and you find that you can't breed as often as you'd like because of the danger that you'll be left with two or three pet-type pups from every litter, growing rapidly past the age at which they're attractive.

So your breeding operation is limited to perhaps one or two litters per year . . . and you're always certain that you have orders before you breed a litter. Suddenly, on every TV channel, the news features Elizabeth Taylor and her longcoated Sonoran Terrier - in living color, presiding over a charity campaign which is publicized for several days. And in Florida, coincidentally, a long-coated Sonoran Terrier saves the life of a drowning baby.

Suddenly your telephone begins to ring. "I'll pay any reasonable price for a dog of that breed," says the caller. What is your instinct? Naturally, you rush out to the kennel with brush and comb to do a quick shaping-up job on one of those pet-type female pups you had left over from the last (continued on page 18) litter five months ago.

I hope you will publish this letter and maybe some others will give their Basenjis a chance in obedience. They may find that their stubborn, spoiled Basenjis can make the best bets for their Companion Dog degrees.



ARABELLA was a bit of a chewer - nothing serious, but felt that teeth and jaws were made to be used. If she started on anything I care about, I dab it with camphorated oil - 100%success to date. Also useful for itch or gnat bites that they want to lick - they can ruin the white hairs so quickly with continual licking, but they won't touch camphorated oil, and so it is not harmful to them. That depends really on whether the owners can stand the smell.

Basenji Club of New England YANKEE DOIN'S

A fitting tribute was tendered to Mr. and Mrs. Alexander Phemister at their home in Kingston, Massachusetts, on October 26, 1968, when they were honored by the presentation of an engraved walnut plaque from The Basenji Club of America, in recognition for their outstanding contributions to Basenjis and the Club, No one could be more deserving of the award than the Phemisters. They were the first breeders of Basenjis in the United States, and it is virtually impossible to list all the contributions the Phemisters have made to the Basenji breed. Among them was the acquisition of PHEM-ISTER'S CONGO, a bitch brought from Africa and bred to a Canadian Basenji which resulted in the first litter to be successfully raised in this country. From this litter, Mr. Phemister trained a male, PHEMISTER'S BARRIE, and made history when he became the first Basenji in the world to acquire *a C.D. and C.D.X. degree. From this male and his littermates came the foundation stock of all early American Basenjis.

Another major accomplishment of Mr. Phemister's was the founding of The Basenji Club of America in 1942; he was the club's first president and remained so for many years. Mr. Phemister, after much hard work and a great deal of persuasion succeeded in having the A. K. C. accept the Basenji Standard in 1943, and open the way for Basenji registrations. In 1945, the American Kennel Club placed the Basenji in the hound group, and soon after, PHEMISTER'S MELENGO became the first American Basenji Champion. Within a year, another "first" was made when CH, PHEMISTER'S MELENGO and her mother CH. ZINNIA OF THE CONGO, C.D., became the first brace

of Basenjis in the world to win Best Brace in Show.

In addition to serving as the first president of the B. C. O. A., Mr. Phemister has served for many years on the Board of Directors and has always taken an active interest in all club business. His wise council, firm decisions, and whole hearted effort has definitely been the difference between the success and failure of the club.

THOUGHTS ON PUBLICIZING OUR BREED

For as long as I have been a member of our area Basenji club, the Heart O'Northland Basenji Club, the most persistent topic of conversation has been on how to publicize our breed. Very often, we never seem to get beyond the things our club can do. While club activities are important, individual activities are also important. It is what the individual Basenii owner can do to publicize his breed that concerns me most.

If you own a Basenji and belong to The Basenji Club of America and one of the local clubs around the country, I will assume that you feel as I do - that the Basenji is the greatest dog on four feet. That is the first step. Since you really do think your dog is great, you should be ready and able to explain why you feel as you do at the drop of a hat. Now, how do you get your Basenji into the conversation without appearing to be a bit of a crackpot?

Do you own one of those pretty Basenji pins or tie clasps for dog show days? Wear it occasionally to work or on a shopping trip. Most dog show people have undoubtedly seen and have asked about the Basenji at one time or another. The cafeteria girl or the boss may not have. Let your pet sneak into the family snapshots which are likely to be taken to work or to the bridge club luncheon. Since Basenjis are so photogenic, they will capture the eye of most people in a snapshot. Be prepared to give a very brief history of your barkless wonder dog as soon as the viewer asks, "What kind of dog is that?" When the topic turns to dogs, be sure to mention, "my Basenji" instead of "my dog!"

Take your dog places with you where he will be seen by large groups of people. Some choice places are shopping centers, picnic grounds, beauty shops, garages, walks in the park, and especially, rides in the car. It never ceases to



surprise me how often a car pulls up alongside of me at a red light and someone asks, "What kind of dog is that?" It takes but a moment to say, "A Basenji - the barkless hound." On one occasion the man who asked was so fascinated, he followed me into a nearby shopping center and asked for more information. He ended up by taking my name and address so he could come and see our puppies at a later date.

There are a variety of decals and insignias, featuring the Basenji available to decorate cars, trucks, boats, show crates, campers, scrapbooks, notebooks, and whatever else you can think of to decorate with them. If you have a kennel name, have it painted on the side of your camper, truck, garage door, wagon, or the name plate on the gaslight by the front gate. Stationary, bearing your kennel name, can occasionally be used for personal correspondence too. There are lovely personal notes available with the head of a Basenii in either the red and white or tri-color.

Many schools in our area are asking for "community resource volunteers" to come to school and tell about their hobby or field interest. One lady in our area took her Basenji to school to talk about the "barkless dog" and the showing of dogs in general. It was a great success. I recently took my young male, DAFFY to work with me. I work at a child psychiatry station in a large city hospital. DAFFY had the run of the unit with the sixteen children all day. It was hard to tell who enjoyed it the most, he or the children. Nearly twenty-five of the staff were on the unit during the day, and I am sure they will remember him as warmly and as long as the children will.

Although obedience training classes are not meant to be publicity agencies, I can think of no better place to capture the attention of a good sized dog-loving population. Each week, between twenty and a hundred people see your dog behave under a wide variety of circumstances. Later the fun trial and in the obedience rings give wider audience to our breed. (continued on page 22)

STRYCHNINE POISONING

Strychnine is the oldest and most widely known poison for the taking of lives, especially those of animals.

Strychnine is the principal active chemical from a tree native to India. Derived from the seeds, commonly called "quaker buttons," strychnine was first introduced into Western Europe about the 16th Century, as a rat poison. In some sections of the world, it's still used for this purpose; but in recent years, other chemicals less harmful to cats and dogs have been developed and are in wide use in the United States.

Around the 18th Century, strychnine was introduced into human and veterinary medicine as a stimulant and a "bitter" to increase appetite. The only known action of strychnine in small doses is as a stimulator of secretions of the stomach. Some of the older veterinary preparations still contain small amounts of strychnine as a "bitter," but its use in human medicine has been almost abandoned.

FORMS OF THE DRUG

Strychnine is a white powder, moderately soluble in water and has a very bitter taste. Most of the rat poison preparations containing strychnine are in a dry cake form; however, powder is the most common type that is used maliciously.

SYMPTOMS OF STRYCHNINE POISONING

The symptoms observed are those of a convulsive nature. Strychnine is a convulsant poison and is a most painful method of destruction. The poison acts on all parts of the nervous system, but first and primarily on the spinal cord. The symptoms are very similar to an epileptic attack. The difference is an epilepsy attack lasts from one to three minutes, after which the animal rests for a short period and is again functional. Strychnine causes similar types of convulsions, but they occur in sequence, one after the other, until there is a paralysis of the respiratory system and the animal dies.

Symptoms develop rapidly after the animal eats the material, as this is one type of poison that is quickly absorbed from the stomach. Most poisons are picked up after they have cleared the stomach and are in the intestinal tract, thereby resulting in a time lapse between time of ingestion and onset of symptoms; but it isn't unusual to observe symptoms of strychnine poisoning several minutes after ingestion. Of course, the time interval may be affected if the stomach is full of food and by the type or form the poison was in - liquid, cake or powder, etc.

TREATMENT

Treatment is aimed at removing any poison that may be left in the stomach and preventing or relieving convulsions. This is done in different ways. If it's a known poisoning case with no symptoms at present, it may be possible to remove the poison with drugs that cause the dog to vomit. If symptoms are present, the treatment involves the removal of the convulsions which is done by giving the dog a general anesthetic, causing an immediate end to convulsions. It is not uncommon to keep a strychnine case asleep for two of even three days until the poison has worn off. While he's asleep, removal of the remaining poison can be done with a stomach tube. The prognosis is good if treatment is started immediately at the first suspicion of poisoning; but left untreated, the pet nearly always dies.



"ZEN" MY LESSONS

ZENDE'S first summer was a remarkable one in all our lives. For one thing SOOTY and I have never been so fit! We were soon walking two miles every morning by road and woods before I went to work; and another three or more in the evening to help use up the energy of our long-legged pup. We explored miles of the surrounding countryside on foot and by car, looking for safe places for ZEN to run free.

In the early days when I let her go, trailing line clipped to her waist band, I took it upon myself to maintain contact. She used to go off in big casts with me crashing along on the inner circle, tripping over fallen boughs and plunging through bracken and heather. I had a few odd looks from her as though she said, "How do you expect me to find anything when you're making all that noise?" But mostly, she ignored my progress as much as possible! She was really very patient with me, as it took some weeks for me to realise that all my bruises and twisted ankles were unnecessary. Her hunting style was the same as that which she had used for investigations around houses. She cast away in a large circle, but seemed able to time her speed - and mine, if I continued along the path - so that she always reappeared just ahead. Then, after a glance towards me, off she'd go again on the other track, and so covered the ground on both sides of my line. Sometimes when her route took her onto higher ground so that she could see or hear me, she did not return so soon, but continued on the flank, I would be conscious of a twig snapping or a crackle of undergrowth and check her progress accordingly, occasionally catching a fleeting glimpse of her as she topped a rise. If I heard nothing for a while, I would pause to listen for her. Then all sounds would cease except the tinkling calls of the goldfinches in the pine trees which I have often mistaken for the cat bell she still wore on her collar. Presently, I would become aware of two pointed ears around a windbreak or her white shirt front motionless against a tree. It said a lot for her alertness - that as soon as I stopped, so did she, looking no doubt for the game I had spotted and was about to stalk for

She taught me many things about the proper behaviour in woodland; such as her instinctive leap, high and backwards when anything moved in the path. Safely on terra firma again,

she would thoroughly investigate the cause of her fright, be it stick or shadow, but what better defense against the strike of a snake? Similarly, when wind or heavy rain brought the new bracken down across our narrow ways, and I would have pushed on through, ZEN insisted on careful scrutiny of each stem and frond before she would pass.

She was still keener on feather than on fur, and if she came upon a hare and a pheasant, would run the bird until he got up, tocking his warning, then with great dash follow his line of flight. One day she had performed this rather startling manoeuvre just as I was thinking of returning home, so after a suitable interval, I whistled and called to her. She eventually reappeared standing in view on the far edge of a clearing, and when she was sure that I had seen her, turned and raced back into the wood. It was clear that she had marked her bird into some tree and expected me to follow her and deal with the situation. After a short time she returned, and I assumed that the pheasant had taken advantage of her brief absence to shift. As we retraced our steps, I couldn't help marvelling at her natural way of working with me. No wonder their African masters set such value on these dogs as hunting companions. Also ZENDE'S silence caused the minimal disturbance of the ground. Once only have I heard her give tongue, and then only because she happened to cross almost under my feet, hard on the scut of a rabbit. She was giving the merest whisper of a whine as she strained to catch it, which would certainly not have been audible if they had been more than three yards away.

There was another lesson I had to learn, and that was not to change my direction when she was off on her circling. She had my course plotted as long as I continued in the track or ride where she had left me; but conditioned to the Schnauzer who hunted close like a trained Spaniel and changed direction with me, I did not consider my responsibility to the Basenji when she was out of hearing of my footsteps. The first time we diverged was a horrible shock - to me anyway. I really thought that I had lost her, and it was difficult to know where to start looking for a dog that could apparently cover half a mile in thirty seconds. 

Mrs. Margaret E. Robertson of Victoria, British Columbia, Canada, who officiated as Sweepstakes Judge at the Basenji Specialty at the Texas Kennel Club all-breed show in Dallas on September 29, owned the first Basenji to go Best in Show on the North American continent - CH. DAINTY DANCER OF GLENAIRLEY.

Her first Basenji, a tri-color, CAN, CH, GLENAIRLEY BLACK MERLIN, AM, and CAN, C.D., achieved the highest score (199 out of 200) of any breed in one obedience trial.

"I literally grew up with dogs," Mrs. Robertson told this writer. "My mother was a Boston Terrier breeder. At the age of 12, I purchased my first dog, also a Boston. For a time I bred and showed Bostons but never did much with them."

Fifteen years ago, Mrs. Robertson decided to purchase another breed. She selected the Basenii due to its reputation as a sturdy, healthy dog, easy to raise and breed.

This gentle-spoken Canadian has done much to propagate the once little-known breed, both in conformation and obedience.

"One of the greatest assets of the breed," Mrs. Robertson asserted, "is that the Basenji remains true to the original."

Asked what she considered most important in evaluating a dog, she readily answered, "A clean head, good bone, correct tail set, a far reaching stride and good expression."

The quality of the coat is of prime importance in Mrs. Robertson's opinion and one of the easiest things to lose. It should be fine, short and the skin pliable, she stated.

Not only has this Basenji authority made a great contribution to Basenjis, but Mrs. Robertson is active in the Canadian Kennel Club, serving as its Vancouver Island advisory representative and on the judges licensing committee. It is the aim of the Canadian Kennel Club, as it is of the American Kennel Club, she told me, to maintain the highest


We are now looking forward to the Omaha and Lincoln, Nebraska, shows. From all indications, classes will be large which is the way we like them.

I am writing in hopes that this may be printed in "The Mailbox" as I imagine the ads on the black and white Basenjis were very confusing to anyone who is not familiar with the backgrounds or who has been acquainted with Basenjis for only a short time. Therefore, I would like to clarify the situation so that the two lines may be readily distinguished from one another as they are entirely different in their genetic make-up. Their most common denominator is that they are both A.K.C. registered, purebred barkless Basenjis, both of which trace their ancestry directly to Africa.

In order to differentiate between the two bloodlines, I will refer to one as the "FULA" blacks, as most all of these dogs carry the "FULA" prefix in their registered names and are all direct descendants of the red and white bitch, named FULA OF THE CONGO, imported from Africa to England, by Miss Veronica Tudor-Williams.

The other I will refer to as the "COPTOKIN" blacks as they were first imported from Africa to the United States by Mrs. Gwendolyn Stanich, whose kennel name is "COPTOKIN."

The "FULA" blacks have been proven to be genetically recessive. This means that two red and white parents, both must carry the black coloring recessively in order to produce a black and white pup. If two of the "FULA" blacks are mated, they will produce an entire litter of black and white pups. They follow the same genetic laws as would govern the mating of a tri to a tri, or two reds carrying tri recessively.

The "COPTOKIN" blacks have been proven to be genetically dominant to both red and white and tri. This means they can produce black and white pups no matter what color dog they (continued on page 20) One Male R/W - 5 Females R/W



IT'S A VERY RARE BREED, MA'AM (continued)

When your prospective customer arrives, you're all set to operate. Your price has risen from the \$75 you would have asked last week for the sake of getting the pup a good home with a nice family. Now you will hope to get \$200 for the pup: After all, it's a very rare breed, and you've never made the money the dogs are worth. By the time the customer is in the living room, you've justified everything.

And he buys the pup, Hallelujah! What's more, a few days later, you sell the other one! And because of six or seven more calls that trickle in over the following month, you breed a young bitch you'd planned to hold off for another year. How could things progress more winningly?

Now let's look back to the man who bought the first pup. His wife had said that she just had to have one of those dogs and though he felt he couldn't afford it, he paid the price to make her happy. But when she heard what he paid, she had a fit! She didn't mean for him to spend that much on a puppy. After some discussion, they decide that it'll be all right. When she's old enough, they'll mate her and raise a litter to recoup the price they paid for her.

They have no evil intentions; they plan to ask equally as much for every puppy they sell, and they're already thinking what they'll do with the thousand dollars they should make on a five or six-pup litter. Naturally, they plan to take the best possible care of their dog and her puppies. They're nice, normal, honest people.

A few months later, their bitch is in heat (so is the one you sold to those other people) and they are back at your kennel asking for stud service. You refuse the breedings because the females are too young. But some friends of theirs bought a male from New York while they were on vacation, and they think both dogs are old enough, and what's more, they'll take a puppy in lieu of a stud fee. So the little pet bitch is bred.

Now everyone who felt able to afford a Sonoran Terrier priced at three figures bought one, during the sudden craze of the previous year. You've just settled down to the happy idea that your breed is now well-known, but still bringing good prices and maintaining quality. And with great shock, you see an ad in the classified section, offering long-coated Sonoran Terriers for \$50 each. WHAT HAPPENED?

This is what happened: the early surge of popularity ended. Those who could afford the dogs bought them. Nearly all of them planned to make up for the expense by raising some puppies. And when they tried to sell their pups for \$200, they couldn't do it. Now they have three-month-old pups ruining the back yard and those pups GOTTA GO!

The pups will go - all those who liked the looks of the breed before, but couldn't afford it, will now buy the dog of their dreams. The great numbers of Sonoran Terriers in circulation will then insure a reduced but steady demand for cheap pups, since "everybody has one and so I must have one."

The quality will decline; the breed will turn up in the dog pound; their popularity will taper off. And one day you'll find yourself in the same position you started in, breeding one or two litters a year, hoping to find a good home for your pettype pups at \$75.

Where did you go wrong? Could it have been the instant in which you decided to charge "all the traffic could bear" for that first pet pup? I think so. I suspect that first man might not have been so eager to breed his bitch puppy so soon, if he'd only paid a moderate price in the first place.

You, by keeping prices up to maintain quality, practically insured that prices would go down - by selling one pup too high and thereby setting off the reaction that would flood the market with low-quality long-coated Sonoran Terriers!

Think it over. Remember advertising like this: "Rin (continued on next page)



are mated to. In time, as the number of "COPTOKIN" blacks increase, it is predicted that through the mating of two of these blacks, a dog genetically pure for black and white pups will be obtained. That would mean this dog would produce all black and white pups in every litter, no matter what color he was mated to. A more complete genetic description is listed in the "Mailbox" of the May 1968, issue of THE BASENJI. To my knowledge, no complete genetic description has ever been published on the "FULA" blacks.

One other difference notable between the two lines is that the "FULA" blacks are born with no obvious tan hairs, but as they mature, tan hairs become visible in varying degrees over different parts of the body; usually the hind legs, under the tail and behind the ears.

The "COPTOKIN" blacks are born black and white with no obvious tan hairs and remain this way throughout their lifetime.

I hope this will help anyone liking the black and white Basenjis and wanting to acquire one, to understand the difference between the two lines so that their choice may be knowledgeable.

Usually when a Basenii is shown in obedience, he is the only one and often one of very few hounds. Many people will take a second look at the Basenji in the trial just because he is quite different from the majority of dogs being shown.

The Basenji is not widely recognized as a hunting dog, despite the fact that he is a hound. Both your hunting companions and the other hunters you meet in the field, will take notice of a Basenji that puts in a good showing at pointing or retrieving. Probably no pose that the Basenji takes, is as striking as his point!

Both school and public libraries are always eager for book donations. Giving a copy of Chad or Basenjis The Barkless Dogs, or "The Basenji," will surely be appreciated and will also place our breed to another segment of the population.

Many communities have radio or TV bulletin boards that air announcements of club activities free of charge. Some local childrens' programs also feature different types of animals from time to time. Company newsletters may be interested in reporting hobbies of employees, such as dog showing or breeding. Childrens' pet parades and hobby displays may also be a place to exhibit your Basenji to a large number of people.

The list is endless, anyone with a bit of imagination can add several items I may have missed with little effort. 

A Basenji does like security, and this is exactly what consistent, reasonable discipline gives him. Somewhere between the "tormenting jerk" and the "baseball bat" tactics to get his attention, is the phrase "common sense." If a handler doesn't have this he'd better switch breeds because this is an absolute necessity in training Basenjis. I do not mean to imply that everyone who has failed with a Basenji doesn't have common sense - the important question is whether they used

Another important aspect which must be remembered is the motto, "Restraining is not training."

You cannot keep a dog on a tight leash and then expect him to go with you when the leash is removed. Why? Because he hasn't had to think for himself! A man can close his eyes and if you take his hand he can follow you anywhere. Drop his hand and have him keep his eyes shut - see how close he can follow you. (Don't try this by a cliff!) This same thing applies to a dog. His leash is an absolute communication line. If it is always kept loose, except when giving a correction, he has to pay attention to stay with you.

What about praise? Mandatory. Neither man nor beast can be expected to respond well without it. It's half the "punishment and reward" theory, and just as important as a correction.

The word "sincerity" sums up the whole key to dog training - be they Baseniis or other breeds.

A dog, like a child, knows when you are sincere and when you are not. You cannot correct with vigor and then woolgather while issuing a pittance of praise. Likewise, if you woolgather while correcting, and then lavish the attention on him - he'll have you figured out in a moment!

A parting remark about obedience training, "If you expect a dog to give you his undivided attention - then you must be sure that he has yours!


