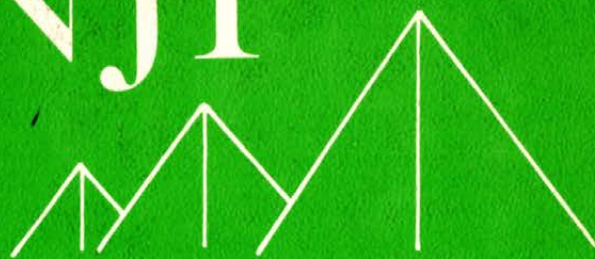

THE COVER STORY

Shown on the cover is CH. BETSY ROSS' KINGOLO OF BER-VIC, believed to be the first male Basenji to win Best in Show in the United States. KINGOLO won Best in Show under Judge Isidore Schoenberg, at the Queensboro Kennel Club show, Jamaica, Long Island, New York, on October 28, 1967, over an entry of 1,279 dogs.

KINGOLO is owned by Betsy and Ross Newmann of the BETSY ROSS KENNELS, 14801 River Road, Potomac, Maryland, and has been owner-handled by Mr. Newmann throughout his distinguished career.

KINGOLO'S sire is CH. FERUZI OF THE ZANDE, also owned by Betsy and Ross Newmann. FERUZI was the top-winning Basenji in the United States in 1964. KINGOLO'S dam is CH. BER-VIC'S MEMORY OF NYOKA, owned by Bernice Anderson of Boonsboro, Maryland, who won Best of Opposite Sex to FERUZI at Madison Square Garden in 1965.

KINGOLO'S record has been sensational. He won Best of Winners for a major under Judge Gordon Parham at Rock Creek Kennel Club show; Best of Winners for a second major at the Trenton Kennel Club show under Judge Fred Hunt; and Best of Breed for still another major at Plainfield, New Jersey

My bitch was accidentally bred on the night of the 22nd day after she first showed color. Furthermore, she was on a chain right outside the open door of the kitchen in which I was working. An injection was given which kept her in heat another three weeks, but which failed to prevent her having puppies.

If you have a Basenji bitch, don't believe what the books say. Check with your veterinarian for confirmation when you think she has gone out of heat.

What is a pure red and white, or pure black and white?

Is it not just the two colors with white markings as in the Basenji standard? If a red and white has black hairs on its body, (excluding tail or back of ears), it is called a brindle or shaded color and is not to be used in breeding. Yet, when a black and white has tan hairs on its body, it is advertised as a black and white. Isn't a red and white with black hairs the same as a black and white with tan hairs, and thus should not both of these off-colors be classed as detrimental to the breed.

The Basenji Standard calls for red, tri-color, or pure black and white. So then why is the black and white with tan hairs called a black and white, when in fact, it is a masked or mismarked tri.

ALOHA FROM HAWAII

Gene Schaefer's red and white bitch MACKEY, mated to her tri-color grandson, who also carries heavy Cambria bloodlines, produced what we believe to be the first black and white Basenji pup ever born in Hawaii. There were also two red and white and two tri-color pups. This unexpected development occurred on Halloween which seems an appropriate time as this black pup seems eerie.

Frank and I went over to Waikiki when the pups were about twelve days old to view the phenomenon. This is the blackest black pup I have ever seen with the minimum required white on his four feet, tail tip and chest. The inside of his ears are jet black; his nose is jet black. There is no trace of tan on him. In making out the pedigree for Gene, I found heavy tri-color on both sides for more than three generations.

What surprises all of us is that we thought the FULA lines were the only carriers of black and white. I imagine this will cause some speculation among the breeders of the blacks on the mainland since there is no FULA blood whatsoever in this new-born pup.

Several Sundays ago, we had the pleasure of watching two Basenjis in obedience competition - the first time in Hawaii. The Hawaiian Obedience Club held a "top dog" competition. Two dogs adjudged best qualified for each class were entered from each of the four area clubs in three categories of competition - utility, novice and open. Two of the Goshorn Basenjis, just eight days out of quarantine, were selected to compete. These Basenjis had always been worked indoors in Colorado, and the obedience match here was on grass, at Thomas Square. BILLY working in Utility, didn't like the heat and broke several times to head for shade, but CH. TASSIE, handled by Ilse, performed like a true pro and took First in Open Class. To make the win even sweeter, the judge was old-timer Arthur Zane who has frequently kidded me that Basenjis just couldn't be obedience trained.

The second series tests on our rabies problem, performed in the U. S. P. H. S. National Communicable Disease Center in Atlanta and the Walter Reed Institute of Research in Washington D. C., proved negative. This second series is based on injecting mice with serum from alleged rabid animals. None of the injected mice died. It is a genuine relief to know that we in Hawaii are still safe from rabies, but an awful lot of money was spent for rabies vaccinations at an average of \$5 per animal, and a lot of pets were destroyed by the humane society when people panicked. I tend to think some of the pets were strays and most of them weren't too well cared for anyway.

LONGEVITY IN PETS

Today's pets have a longer life expectancy, thanks to the discovery of many new drugs, biologicals and the development of research and knowledge in every day care and treatment of pets and millions of dollars being spent yearly to develop better pet foods.

The average pet owner nowadays can expect to enjoy or own the same pet for as long as ten to fourteen years; and in some rare instances for as long as eighteen to twenty years, barring accidental or unnatural death.

If the proper type of pet is chosen, there can be a very pleasant and companionable relationship between owner and pet. If the wrong type of pet is chosen, the relationship, at best, will be a strained one, ending up by the owner tolerating the pet through some type of stubbornness or loyalty. Or the owner may get disgusted and give up pets altogether with only memories as a reward, and another unfortunate pet is displaced.

Much time should be given in thought before obtaining a new pet. If the prospective owner has had other pets under the same conditions, the following suggestions may not apply.

THINGS TO CONSIDER

Size, coat, and especially, disposition, are factors closely related to satisfactory home life for a dog and his master. Heredity counts heavily in the mental and emotional qualities that dogs display as well as in their appearance. Of the 116 breeds now registered by the American Kennel Club, plus those registered by the United Kennel Club, each was developed for some specific service to man for which he is adapted by size, coat, color, senses, and disposition.

Clearly, there is a dog tailor-made for each owner who will give sufficient time and thought to making his selection and to developing the native qualities of his pet.

A DOG'S ANCESTRY

The advantage of purchasing a purebred dog for the non-breeder is that the ultimate appearance and temperament of such an animal can be forecast with some accuracy. However, a dog of uncertain ancestry has often proved to be an ideal selection.

Dogs without registration papers cost less, quality (continued on page 17)

Coming to date and to Basenji fanciers in England and
 the United States, the latter have consistently combed Central
 Africa for typical specimens of this attractive and interesting
 breed, and a number of individual dogs have been brought to
 the British Isles and to our own country during the last few
 years. Unfortunately, some of these animals from the more
 accessible parts of Africa proved to have been contaminated
 by foreign blood. Other and really good specimens died on the
 way out or after arrival; but enough worth-while dogs came
 through so that today there are quite a few excellent individuals
 owned both here and in England.

As might be expected, these dogs are the result of
 careful breeding. A case in point is that of a prominent British
 breeder who, for the purpose of still further improving the
 Basenji, and at great expense, personally selected and bought
 a bitch from a native of the Zande country in the Egyptian Sudan
 at the headwaters of the Nile. This native had never seen a
 white woman, and from all appearances, this dog is of the
 purest blood and an exceptionally fine specimen in so far as
 conformation and quality are concerned. She has been bred to
 an outstanding Basenji sire and four of the resulting litter -
 two of each sex - consigned to American breeders, should be
 in this country by the time this little "write-up" appears in
 print. These four dogs, bred to some of the 100-odd Basenjis
 registered with the American Kennel Club this year and last,
 should insure some really outstanding representatives of the
 breed for future shows. Apparently we shall see one "fossil,"
 at least, that shows very definite signs of life.

CAPITOL QUIPS

"HEREDITY IN OPHTHALMOLOGY"

Last year at this time, Seymour Roberts, DVM, submitted an article to *MODERN VETERINARY PRACTICE* which contained his description of the condition he found in some Basenjis and the following statement: "Both male and female Basenjis are affected, and incomplete data suggest that the responsible gene is transmitted as an autosomal dominant factor. It is also possible that a recessive gene that is widely distributed in the breed could be responsible. . ."

A dominant abnormality is the rarest kind, but is easily detectable. Any individual affected by a dominant abnormality must have received it from one of his parents. If the parents and their own ancestry are normal, they are certainly no carriers of the gene. One has therefore to assume that in one of the parents a mutation of a normal gene to a pathologic gene has occurred, and since this mutation is dominant, it necessarily expresses itself in the offspring. A recessive abnormality certainly occurs more frequently, but easily passes unnoticed since the offspring of an individual who carries it are phenotypically normal. A normal gene which has mutated to a pathologic recessive gene can be transmitted through many generations without manifesting itself. It remains hidden until by chance a mating with another carrier of the same gene occurs and an offspring showing the abnormality is born.

Heredity plays an important role in ophthalmology since at least 246 pathological genes are known which express themselves in ocular abnormalities, either exclusively or associated with other abnormalities. Of these genes, 91 are recessive, 30 are sex-linked and 125 are dominant. Over several hundred gene-determined ocular diseases are known in the human. These diseases range from simple near- or far-sightedness, cross- or wall-eyes, and cataracts, to retinitis pigmentosa (very similar to progressive retinal atrophy found in the dog and to be discussed in this article), retinoblastoma (a violently malignant tumor of the eye found in young children), and the ocular involvements in syndromes (sets of symptoms and findings manifesting themselves in specific patterns which characterize the disease).

Progressive retinal atrophy is a proven hereditary eye affliction found in many of the hunting breeds. Since it has been long studied and well documented, and since the Kennel Club of Great Britain and the breed club have taken steps to both study and eliminate the disease through selective breeding programs; it offers an excellent study of a hereditary disease of the eye. If, indeed, the condition found in our breed does

prove to be hereditary, then we as breeders and pet owners, would do well to follow the example set by the owners and breeders of those breeds afflicted with PRA.

PRA has been reported in the Gordon, Irish and English Setters, the Labrador Retriever, the Poodle, the Pointer, Elkhound, Beagle, and the Springer and Cocker Spaniels. But scattered cases of what appeared to be true hereditary, bilateral PRA has been encountered in other breeds and in dogs of mixed breeding. The diagnostic criteria for hereditary PRA is as follows: 1) one owner possession since early puppyhood; 2) no history of previous illness of any importance; 3) loss of vision noted to be gradual by the owner; 4) no accompanying neurological signs; 5) owner aware of increased reflectivity of the retina of his dog for some time. In contrast, the retinopathy associated with or following distemper is diagnosed on a basis of: 1) history; 2) sudden blindness; and 3) absence of prominent ophthalmoscopic findings.

The subjective symptoms of PRA are found in a regular pattern. The dog is shy, exhibits defective night or dimlight vision and bumps into objects and moves with caution when in the dim light. He is usually in the finest of health, but the owner may note increased pupil dilation and increased retinal reflectivity. The dogs become totally blind before the final stages of the disease - this may take from several months to several years. The diagnostic grades as established are:

Grade 1: Pupils semi-dilated and sluggish to response, increased retinal reflectivity.

Grade 2: Pupils dilated with little response, increased retinal reflectivity, smaller blood vessels nearly all gone, major vessels half the normal size, pale discs.

Grade 3: Pupils dilated with little or no response, increased retinal reflectivity, small vessels completely gone.

considered, and where at least one ancestor is known to be an
animal of superior intelligence or charm, they are often the
answer to one of the would-be owner's problems, namely, the
original cost. A happy, well-trained and well-cared for dog is
usually handsome, be he champion, cross-breed, or plain mutt.

After evaluating all the important facts, a decision can
be made as to the general type of pet desired. Above all, a pet
should not be chosen only because one thinks it is cute or
because the next door neighbor has one, or because that par-
ticular breed happens to be undergoing a popularity boom at
the time. Select the pet that will best fulfill all qualifications
desired.

ACCOMMODATIONS

A prospective owner should consider the accommo-
dations he has to offer a new pet, especially a dog. A small dog
will do very well being in a home with a minimum of outdoor
exercise, whereas a large dog must have more exercise to
stay healthy and happy. All dogs should be confined to indoors
at night since a night flying mosquito is the intermediate host
for heartworms of dogs.

KENNEL SELECTION

After all important decisions have been made, the next
step would be to locate this particular pet. There are any
number of very fine kennels, however, no consideration should
be given to a kennel with a poor reputation. Bargain hunting
for a dog is poor economy. Housing, labor, feeding, veterinary
care, stud fee, inoculations, registrations, etc., all cost money.

All breeders recognize their promising pups, and those
offered at minimal costs are likely to be animals that a con-
scientious kennel owner would never sell at all.

Most dogs, however, must depend upon adoption for
their homes and not all are carefully selected by the owners

who take them in. Consequently, veterinarians sometimes
know of good dogs that are offered for readoption through no
fault of their own and at low prices.

The better the breed of dog, the less difference the
buyer must pay between male and female. In loyalty and
affection, females and males are equal. Generally, males are
more brilliant and aggressive; females easier to train but
sensitive and easily spoiled. Males tend to rove and fight if
given much latitude, while females, though generally home-
stayers, require confinement at certain times.

major vessels one third the normal size, discs pale.

Grade 4: Pupils in full dilation with no response, increased retinal reflectivity, all vessels gone except, possibly at the venous circle, discs ashen white; absolute total blindness.

There is, to date, no known treatment to slow the progress of, or cure for the disease.

PRA was first recorded in six Gordon Setters in Sweden in 1911; all were closely related to a dog, RANGER, itself unaffected which had been imported from Britain. It first became prevalent in Britain in the 1920's following extensive line- and in-breeding to a famous dog which was a "carrier" of the genetic factor for the condition, although it also was unaffected. In many afflicted Setter families the dogs tend to be infertile and the incidence of mono and crypt-orchidism is unusually high. The bitches may be late coming into their first estrus and the estral periods are often irregular. The disease is not confined to either sex and the affliction usually misses one or more generations. The mode of inheritance is almost certainly a simple Mendelian autosomal recessive factor. Most cases of the disease occur through the mating of two "carriers." The Irish Setter Association, England, has taken active steps to eradicate the disease by requiring it's members not to use for breeding actively afflicted Setters nor those that are known to be "carriers." The Kennel Club has supported the breed association by making certain regulations designed to prevent the use of such Irish Setters for breeding.

The next, and last, article in this series will discuss the findings of the condition being studied in Basenjis and the relation of the affliction to hereditary factors.

THE BASENJI STANDARD

(Approved June 8, 1954)

CHARACTERISTICS -

The Basenji should not bark, but is not mute. The wrinkled forehead and the swift, tireless running gait (resembling a racehorse trotting full out) are typical of the breed.

GENERAL APPEARANCE -

The Basenji is a small, lightly built, short backed dog, giving the impression of being high on the leg compared to its length. The wrinkled head must be proudly carried, and the whole demeanor should be one of poise and alertness.

HEAD AND SKULL -

The skull is flat, well chiseled and of medium width, tapering towards the eyes. The foreface should taper from eye to muzzle and should be shorter than the skull. Muzzle, neither coarse, nor snipy but with rounded cushions. Wrinkles should appear upon the forehead, and be fine and profuse. Side wrinkles are desirable, but should never be exaggerated into dewlap. Nose - Black greatly desired. A pinkish tinge should not penalize an otherwise first class specimen, but it should be discouraged in breeding. Eyes - Dark hazel, almond shaped, obliquely set and far seeing. Ears - Small, pointed and erect, of fine texture, set well forward on top of head. Mouth - Teeth must be level with scissors bite.

NECK -



Of good length, well crested and slightly full at base of throat. It should be well set into flat, laid back shoulders. Forequarters - The chest should be deep and of medium width. The legs straight with clean fine bone, long forearm and well defined sinews. Pasterns should be of good length, straight and flexible.

BODY -

The body should be short and the back level. The ribs well sprung, with plenty of heart room, deep brisket, short coupled, and ending in a definite waist.

HINDQUARTERS -

Should be strong and muscular, with hocks well let down, turned neither in nor out, with long second thighs.

FEET -

Small, narrow and compact, with well arched toes.



TAIL -

Should be set on top and over to either side.

COAT -

Short and silky, skin very pliant. Color - Chestnut red (the deeper the better) or pure black, or black and tan, all with white feet, chest and tail tip. White legs, white blaze and white collar optional.

WEIGHT -

Bitches 22 pounds approximately. Dogs 24 pounds approximately. Size - Bitches 16 inches and dogs 17 inches from the ground to the top of the shoulder. Bitches 16 inches and dogs 17 inches from the front of the chest to the farthest point of the hindquarters.

FAULTS -

Coarse skull or muzzle. Domed or peaked skull. Dewlap. Round eyes. Low set ears. Overshot or undershot mouths. Wide chest. Wide behind. Heavy bone. Creams shaded or off colors, other than those defined above, should be heavily penalized.
