

Am. Ch. Black Charivari of Ouimac Sire: BOBEL'S HAWAII BANNER

Bobels Gad-About of Wil-Ja CH, KEIKI O KA MAKA PO (whelped 12/27/65, single whelp) Eng. Ch. Fleet of the Congo

Dam: TANGE SAZEN

Black Orchid of the Bambuti OTC

Translated, "SON OF A ONE EYE," KEIKI is the only product of the breeding of TANGE SAZEN (a legendary oneeyed Japanese Samuri warrior) and BOBELS HAWAII BANNER (PIKO). TANGE SAZEN (PIXIE) was also one-eyed as a result of eye damage in play with her mother, requiring the removal of an eye. PIXIE was killed by an automobile shortly after KEIKI'S birth and was the only survivor of a litter conceived in England and born in Hawaii.

KEIKI completed his conformation title by winning Best Basenji over two specials at the Hawaiian Kennel Club spring show in Honolulu on March 17, 1968, under Judge Albert E. Van Court. Later, Mrs. Van Court selected him as Best Hound in Show. KEIKI was very capably handled by Ann Goshorn, age 15. This win climaxed a campaign of 7 straight shows and 7 Winners Dog awards.

His first time shown was in a sanctioned match in July 1966, at just over six months of age. KEIKI gave his first indication of his winning ways by going Group One and being seriously considered for Best in Match. On September 5, 1966, he earned his first two points under Major Bryant Godsol, as Best Basenji, coming up from the Puppy Class. In October 1966, KEIKI was Best of Breed and Group Two in the Hawaiian Kennel Club Sanctioned Puppy Match. Two points were added in March 1967 when Miss Marjorie E. Siebern selected KEIKI as Winners Dog and Best of Opposite Sex. This is the only time he was not selected for Best Basenji in a show.

His first major was under Judge Vincent G. Perry at Maui in May 1967, Mr. Perry also gave him Best Hound award. The second major came under Judge R. A. Cross who awarded (continued on page 2)

I really appreciated you people sending me the April and May issues of THE BASENJI at my old address. I happened to be home when they arrived.

My Basenji had fallen and sprained his leg - all the ligaments and muscles were loose from the pastern. These two issues gave drawings and gave us a better idea of the structure of the leg. The veterinarian I had taken the dog to had only given him pain killer which I found out after receiving THE BASENJI and changing veterinarians. The new veterinarian took X-rays to confirm what was actually wrong and also consulted an expert on treating small animals from Texas A and M. We have had a cast on the leg for three weeks and we can see improvement in the tightening up of these ligaments.

THE BASENJI is almost a Bible for us with our Basenji and I recommend it as a "must" for all new found Basenji friends across the country.

In the construction business, we don't always get sent where we expect. The company sent someone else to the job in Osawatomie, Kansas. I sent the postmaster in Kansas a notice to forward all of our mail to us which he hasn't done even though we are paying him to do this. Right now my husband and I are temporarily at a job near Las Vegas, New Mexico, we might be there another week, and we have another week or two to spend in Cuba, New Mexico. "THE SENJI-SIZER"

Have you ever wished your Basenji was as firm and trim as some seen in the show ring, but the thought of daily regulated exercise for you and your dog leaves you with that "tired all over"



feeling? Bill Magee has solved this problem by inventing a modern exerciser which allows the "people" part of the team to sit back in his easy chair while his Basenji gaily exercises himself into beautiful condition.

Bill and Jan Magee, members of the Hi-Country Basenji Club, have given us a demonstration of their remarkable device and we were amazed and a bit envious of those lucky Magee dogs taking turns and enjoying the walking machine as if it were a game.

Bill designed his home made dog walker and says it can be made in any handy-man's workshop for around \$100. The major components of the "Senji-Sizer" consist of a 1/3 horsepower 1725 RPM 110 volt motor, spring loaded pulley on motor, 8.5 inch pulley on rollers (washing machine wringer type rollers) and belt of 2 ply, 8 inch wide and 8 1/2 feet long.


The exerciser works "tread mill" fashion with the dog walking at a set pace which can be varied from slow to fast by adjusting the belt speed from 270 to 540 feet per minute.

The Magee's three Basenjis truly enjoy their walking sessions and will walk without any lead or restraint, however, they should not be left unattended while exercising. Two to three minute sessions daily is ample for tightening up and developing a dog. Too much exercise could be detrimental and any dog just beginning to work out on a "Senji-Sizer" should not be permitted to walk for more than a minute at first, gradually building up until the two to three minute maximum


THIS IS THE BASENJI

INTELLIGENT BASENJIS

There is one thing about Basenjis that I find especially interesting and that is their great sense of family. The mothers, though they will feed their own and their daughters' families of puppies, and at the same time are very strict about keeping outsiders away. I find my "boss" bitch will readily accept litters of Poodle pups that run around the garden, but she takes a long time to get used to and make friends with a Basenji puppy I bring in from outside.

I find with my Poodles that if one of them hurts itself and starts to "cry," some of the older dogs will rush in and attack it, and this despite the fact that my Poodles all have especially good natures. If a Basenji hurts itself, all the others rush up and showutmost concern and are clearly very worried indeed. I will never forget the worry of great grandma when two youngsters decided to breed when I was not there. She was very worried as the female was screaming her head off as Basenjis do in these circumstances and great grandma was trying to attack the dog who was hurting her poor little female offspring. Luckily I heard the row and came running.

Once when I had them all loose in the woods, we came to a very wet area where there was a swollen stream. I jumped over and so I thought had all the Baseniis 'till we heard the warning howls of someone left behind and found a young bitch who had not dared to clear the water. The whole flock rushed back to her and BOI jumped to her and jumped back across the stream several times until she picked up enough courage to cross herself. Then everyone gathered round to lick and comfort her.

Another thing about Basenjis is their amazing sense of direction. My husband took a young female with him on a walk. He was with a friend and they motored to a place several miles away, parked the car and started walking. She was with them for an hour until they came past several people and she had apparently got bewildered and missed him. After calling for a long time, he retraced his steps and found her under the car. She had never been that way before and she was only a baby of about seven months.

A family I know have a Basenji female and her daughter from me. INT. CH. PERLITA OF ROSSANTY is the mother. and I think the most intelligent Basenji I have ever heard of. Her owners take these two with them wherever they go and tell PERLITA where they are heading before they start so she can

really enjoy the trip. They have friends in Drammen, a town about 30 miles off. PERLITA adores these people and gets very excited when she hears where they are going, and as they get to the outskirts of Drammen she starts yodelling and gets very excited. One time her owners were to go to the mountains and the route lay through Drammen. As they were not calling on their friends there, they said nothing to PERLITA. As they approached Drammen, she sat up and got very excited, and when they passed the turning to their friends and did not turn, but drove straight on, she was frantic. She pulled at their clothes and made a terrible noise and would not be comforted until they had driven a long distance past.

A final story concerns us and shows how near nature we live. A couple of years back I had taken the Basenji flock up in the woods and we were about ten minutes away from home when I decided to explore a small path I had not been on before, and after awhile, thought it looked rather like an elk path. At that moment, a huge male elk got up in front of us and made off at full speed with all the dogs after him. I called like mad as it was the breeding season and elk can get nasty. The name of GLENAIRLEY MISSALTHRUSH should have had an (m) behind it to show that she is WIDGEON'S

If my "honor roll" is to have any validity at all, I must stick to the official AKC publication.

"SNARLS, NOT YODELS"

We hear a lot of talk about the "old type" Basenji, but when I look at the pictures of a lot of them that are winning throughout the United States, I wonder just what is meant by "old type." I have a feeling that a lot of breeders are becoming so kennel-blind that they can't see the creeping similarity between the type they are breeding and the smaller Boxers. Or the creeping similarity between the type they are breeding and a Bull Terrier. I don't mean the head - I mean the body. How can some of these winners be construed as "finely pointed" or "aristocratic," and "GAZELLE LIKE?"

Did you all read Veronica Tudor-Williams' book? The same applies today as it did twenty years ago. Where are the 22 pound bitches and the 24 pound dogs? WHERE ARE THE BASENJIS THAT APPEAR HIGHER ON THE LEG THAN THEY DO FROM PROW TO STERN? What's with the judges that put up these short-legged, wide-fronted Basenjis to top spots? What's with the breeders that sell such dogs as breeding quality, let alone show quality? "OLD TYPE?" Let me tell you - there were some pretty big dogs then, according to the standard. But percentage wise, there were less than there is now, and they could hold their own against a lot of them being shown right now, and come out on top! We felt that our beloved CH. TENNJI'S BRUCE, whelped December 28, 1953, matured a bit coarse. He was 17 1/4 to 17 1/2 inches tall, and weighed 26 pounds. He had marvelous expression, a good red color, and moved beautifully, with a far-reaching, swinging stride. Old type? Hummm, CH, TENNJI'S CANDY, whelped December 1954, was exactly 16 inches tall, and weighed 22 pounds. Glorious deep red coat. If that's "old type," that's a pity.

Lately, I've had a terrible mad-on at the judges. Perhaps I shouldn't judge them so harshly. If breeders would open their eyes and come off this kennel-blind bit, they'd start putting that elegant, gazelle-like, leggy, slim, red and white, or black, tan and white Basenji in the show rings for the judges to see. Don't sit there and exclaim that you're not kennel-blind! And don't give me the excuse that "the judges thought he was good enough to put up." Don't let those judges be your excuse for not breeding for a gazelle-like animal! If judges rarely see such a Basenji, how will they know it's the proper type? No chance! They're going to continue putting up the short-legged, saggy backed, fawn colored, wide fellows that are more "typical."

Come on, start breeding and showing gazelles instead of the faded out, wide guernseys.

VETERINARY JOURNAL

POISONOUS SNAKES

All poisonous snakes found in the United States, with the exception of the coral snake, are classified as "pit vipers." These are the cottonmouth or water moccasin, the copperhead and approximately 26 kinds of rattlesnakes. The rattlesnake is considered to be the most dangerous due to its size and amount of venom produced.

All snakes having a venom capable of producing any marked effect on an animal possess some teeth known as "fangs." Basically, fangs are shaped like the other teeth, being curved and slender, but somewhat larger. All teeth are regularly replaced at intervals of perhaps two weeks to a month, and the teeth and fangs that are accidentally lost are quickly renewed. Hence, a snake from which the fangs have been removed (as done sometimes in carnivals and circuses) soon become dangerous again. Some fangs are hollow like hypodermic needles, whereas others possess a groove down one side.

SPECIALIZED GLANDS

In actuality, the venom glands of a snake are specialized salivary glands which are analogous to the human parotid salivary gland. They are elongated structures which are situated in a fibrous sheath and surrounded by a thin layer of muscle. They are located on each side of the head, just posterior to the eyes. When a venomous snake bites a victim, the full or distended venom sacs are compressed simultaneously with the closing of the jaws. In snakes with hollow fangs, the venom is ejected through the fangs into the victim's tissue in a manner similar to that of expressing fluid out of a hypodermic syringe through a needle. In snakes with grooved fangs, the venom is expressed from the venom ducts into the groove on the fang and then it flows through the grooves during the biting process into the victim's tissues. The venom not only immobilizes, but it also aids in the subsequent digestion of

considered to be 1 mg per pound of body weight. Therefore, a rattlesnake has the potential of killing 4 or 5 average size dogs with one bite. On the other hand, the lethal dose of moccasin venom is 3 mg per pound of body weight, thereby giving a moccasin the potential of killing only one average size dog.

The mode of spread of the venom is generally by the lymphatic circulation. Venom is usually deposited in the muscles or subcutaneous tissues. It travels with the lymph and slowly spreads as the lymph flows. Eventually, if the venom is not removed by suction from the subcutaneous spaces, it enters the veins and general circulation in the region of the upper thorax and is then carried by the blood stream to all parts of the body. As the venom passes through the liver, detoxification can occur if the animal is not completely overwhelmed by the venom.

Occasionally venom may be injected directly into a large blood vessel. When this happens, the venom spreads rapidly throughout the victim's body and death often occurs within a few minutes.

The coral snake, however, is entirely neurotoxic in effect. Diagnosis is usually made by the visible evidence of fang marks surrounded by extensive swelling and extreme pain. Fang marks, however, are not always visible. Therefore their presence or absence should not be the sole criteria for making a diagnosis. The presence of local tissue swelling and/or pain at the site of a snake bite is a reliable sign. If no significant local swelling, pain, or other alarming symptoms develop within a short period of time (30 to 45 minutes), the bite can be considered to have been inflicted by a non-poisonous snake.

The seriousness of any snake bite case is dependent upon the kind of snake, the amount of venom injected, the body weight of the victim, the location of the bite, and the toxicity of the venom. The toxicity of the venom from two snakes of the same kind and/or comparable size may vary considerably.


